They have no share capital.

Policies on reserves

The trustees have resolved to establish reserves to provide for future activities, and the trustees have wide power of investment. Within those powers, a policy has been determined that the existing assets be retained to produce income which is wholly utilized to support existing activities. The intention in the immediate future is to restore the balance of the capital held to preserve the income necessary to maintain the activities of the charity. Reserves held are considered only sufficient to cover a reasonable period of expenditure, should further income fail to be materialized and are held in an interest-bearing bank account.
