The Trustees have pleasure in submitting their report and accounts for year ended 31st March 2025. The financial statements have been prepared in accordance with accounting policies set out on page 5 and comply with the Statement of Recommended Practice (SORP) and the applicable law.

ESTABLISHMENT OF THE ASSOCIATION

Somali Banadir Association in UK (SBAUK) was founded on 22nd November 2011 and established as Islamic Welfare Association Daara'ri'aaya for catering for the need of young people who are starving during and after the political crises of Somalia.

CONSTITUTION, OBJECTIVES AND ORGANISATION STRUCTURE

The trustees made all the decisions regarding allocation of funds and activities. The Board of trustees are comprised of the Chairman, Secretary of the Association, and the Treasurer.

The charity is independently constituted under a Constitution adopted on 2nd October 2012 and is a UK registered Charity number 1149719 on the Central Register of the Charity Commission for England and Wales. The objectives of the charity as set out in the Constitution are:

- (a) to promote any charitable purposes for benefit of the Somali Banadir Community especially (but not exclusively) for young people in the United Kingdom and the world at large.
- (b) to relieve poverty and persons in condition of pains, hardship or are aged and /or sick.
- (c) the advancement of education and the promotion of health and well-being of the community.
- (d) to improve the conditions and quality of life of the members of the community, improve their physical welfare so that they may grow to fulfil their potentials in the community.

The Somali Banadir Association in UK (SBAUK) was involved in educational improvement activities designed to increase members' awareness of the opportunities available in education. These outreach activities are organised locally in London and other main cities in the United Kingdom.

ACHIEVEMENTS AND PERFORMANCE

The principal activities of the Charity during the period under review are Education, Emergency Reliefs and employment creation. The BARAARUJINTA BAHWEYNTA BANAADIR UK organised some meetings and events where issues affecting the community members are discussed with solutions.

Somali Banadir Association in UK are currently engaged in emergency relief efforts and Small Scale development projects undertaken in Somalia for the support and welfare of the helpless and war victims.

Relief efforts and welfare undertaken in Somalia includes support for the poor families, basic educational support for the children and supplies of educational resources for the needy.

The long term goal of the Somali Banadir Community is to enable the poor and the needy people to become economically self-reliant, politically exposed and educationally enhanced.

PUBLIC BENEFIT REPORTING

The trustees of the Somali Banadir Association paid due regard to the Charity Commission's guidance on public benefit and members of the public are not restricted from benefitting through the following charitable activities.

(a) Public Counselling

The Somali elders and professionals in Banadir Association are well informed and committed to enabling the community in London and rest of UK to benefit from public counselling of the Somali virtues and cultural heritage. This is achieved through periodic counselling services available to any member of the public including old people, single parents and the hopeless.

(b) Youth development

Youth development activities are undertaken by using Somalia cultural heritage and Societal values to raise public awareness in improving their morality, education and wellbeing in the society.

The Association supports the young people to organise trips to historical and educational centres and efforts are geared to bring offending and socially-displaced youth back to normal life and made them returned into their educational pursuits.

Sporting and recreational activities are also organised for the young people for their personal physical fitness and career development.

RISK POLICY

The Trustees have assessed the major risks to which the Association is exposed particularly those relating to the operations and finance and are satisfied with the risk management systems in place to mitigate the risk exposure to the Association.

REVIEW OF THE FINANCIAL POSITION

The net incoming resources for the year amounted to a surplus fund of £47 (Year 2024 was a deficit fund of £7,369) and all of which are allocated to the unrestricted reserves of the charity.
