The Trustees present the annual report and financial statements of the Charity for the year ended 31 March 2025. The financial statements comply with current statutory requirements and the requirements of the Charity's governing document. The financial results are set out in the enclosed accounts.

Objectives and Activities

To provide access to education for children from underprivileged families and street children, prioritising girls.

Achievements and Performance

In February 2023 the trustees of Ujala School have been successful in purchasing a plot of land near the current school. The vision is to have a purpose-built school. With the new school building we will be able to increase enrolment of students from the current 60 to a total of 150 pupils, while at the same time providing education up to Grade 10. This will also give the graduating students a possibility to sit in the board exams and then enter the next phase of their education elsewhere. The school produced their first graduates in 2024.

Review of the financial position

The financial results of the charity for the year ended 31 March 2025, are fully reflected in the attached financial statements together with the notes thereon. Total Income was £28,785. Total resources expended were £9,000 resulting in net income of £19,785. On 31 March 2025, the charity has total funds of £37,439.

Reserves

The charity has total unrestricted reserves of £37,439

Structure, Governance and Management

The Charity has been set up as an unincorporated association and is governed by a constitution.

Notes to the Financial Statements
For the year ended 31 March 2025

1. Basis of preparation

1.1 Basis of accounting

These accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts. The accounts have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014, and with the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and with the Charities Act 2011.

1.2 Going concern

At the time of approving the Financial Statements, the Trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus, the Trustees continue to adopt the going concern basis of accounting in preparing the Financial Statements.

2. Accounting policies

2.1 Income recognition

All the charity's revenue resources are recognised in the Statement of Financial Activities ("SOFA") when the charity has met the obligation and entitlement to those resources granted and the monetary value can be measured with sufficient reliability.

2.2 Tax reclaims on donations and gifts

Gift Aid receivable is included in income when there is a valid declaration from the donor. Any Gift Aid amount recovered on a donation is considered to be part of that gift and is treated as an addition to the same fund as the initial donation unless the donor or the terms of the appeal have specified otherwise.

2.3 Donated services and facilities

Donated services and facilities are included in the SOFA when received at the value of the gift to the charity provided the value of the gift can be measured reliably. Donated services and facilities that are consumed immediately are recognised as income with an equivalent amount recognised as an expense under the appropriate heading in the SOFA.
