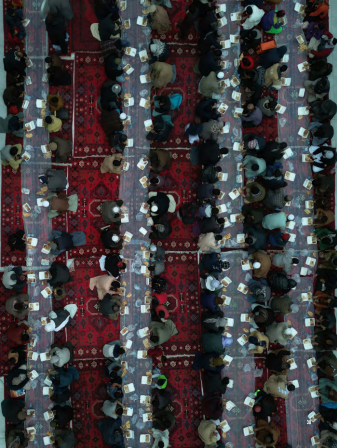

## HEALTH AID PROJECT

The Dental Project is creating a significant and lasting impact on the health and well-being of vulnerable families who previously had little to no access to dental care. By offering free or affordable dental services, in 2024, the project supported **300+ individuals**, providing them with free or affordable dental services that offered relief from pain, infection, and discomfort—leading to improved overall health and daily functioning.

Beyond treatment, the project focuses on prevention. Through awareness sessions and hands-on guidance, families learn the importance of oral hygiene, proper brushing techniques, and healthy habits that reduce future dental issues. Children especially benefit from early dental care, resulting in better nutrition, improved speech, and increased self-confidence. Adults, meanwhile, experience fewer health complications linked to poor oral hygiene, allowing them to work, study, and care for their families without the burden of chronic dental pain.

Over time, the Dental Project will contribute to building a healthier, more informed, and more resilient community. By reducing long-term healthcare costs and promoting preventive care, the initiative enhances quality of life and provides dignity to families who previously lacked access to essential dental services.



## CHILD/ORPHAN EDUCATIONAL AID IN PAKISTAN

Pakistan, with its rich history and vibrant culture, faces enormous challenges. Poverty is a leading cause of hunger, malnutrition, and disease in Pakistan. Almost a quarter of Pakistan's population lives below the poverty line, without access to food, shelter, clothing, or healthcare. Pakistan's food insecurity makes it more vulnerable to the long-term effects of climate change. Threatening to disrupt agricultural activities and unleash extreme weather events such as the recent deadly floods, which devastated Pakistan's infrastructure and cost billions of rupees. Pakistan was devastated by the worst floods in its history, which left 33 million people homeless and caused over 20 billion GBP in damage.

Thanks to your generosity, Qamar foundation was able to provide critical aid to the most vulnerable communities in Pakistan's most remote areas, such as hot meals, food packs, for orphans and also repairing orphanage.

**Opinion**

## **1 Accounting policies**

### **Basis of accounting**

The financial statements of the charitable organisation, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Assets and liabilities are initially recognised at cost or transaction values unless otherwise stated in the relevant accounting policy note

The financial statements are prepared in sterling which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £1.

### **Going Concern**

The trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future at the time of approving the financial statements. Thus the trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

### **Turnover**

Turnover represents all income to the charity, the majority of which is donations.

### **Income**

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Where donations received do not specify a designated fund they are treated as unrestricted income.

### **Expenditure**

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

### **Tangible fixed assets**

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life:

**Creditors**

Creditors are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors are normally recognised at their settlement amount after allowing for any trade discounts.

**Taxation**

The charity is exempt from corporation tax on its charitable activities.

Value added tax is not recoverable by the charity and as such is included in the relevant costs in the statement of financial activities.

**Critical accounting estimates and judgement**

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The charity makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results.

**Fund accounting**

Unrestricted general funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Fund	Description
Community Centre	Helping build small community mosques in underserved areas, each accommodating around 80 people. These centres serve as places of worship, education, and community gatherings, offering spiritual guidance, learning opportunities, and social support to those who need it most.
Childcare/Orphan	Ensuring that orphaned and vulnerable children receive education, care, and emotional support, protecting them from harm, neglect, and exploitation. This initiative provides a safe and nurturing environment, giving them a chance for a brighter and more secure future.
Emergency Aid Responses	Responding immediately during crises and disasters, delivering life-saving food, water, medical care, and emergency shelter to those in desperate need.
Qurbani	Enabling families in poverty to share in the blessings of Eid by providing them with fresh meat from the Hajj sacrifice.
Sadaqah	Offering urgent financial assistance to struggling individuals and families, ensuring they can access basic necessities such as food, medicine, and housing.
Shelter Relief/Housing	Rebuilding homes for earthquake victims and families displaced by disasters, ensuring they have a safe and dignified place to live.
Food Pack	Providing essential food supplies to families facing extreme poverty, ensuring they do not go hungry.
Ramadan Food Pack	Supporting families during Ramadan by delivering food packs that sustain them throughout the holy month.

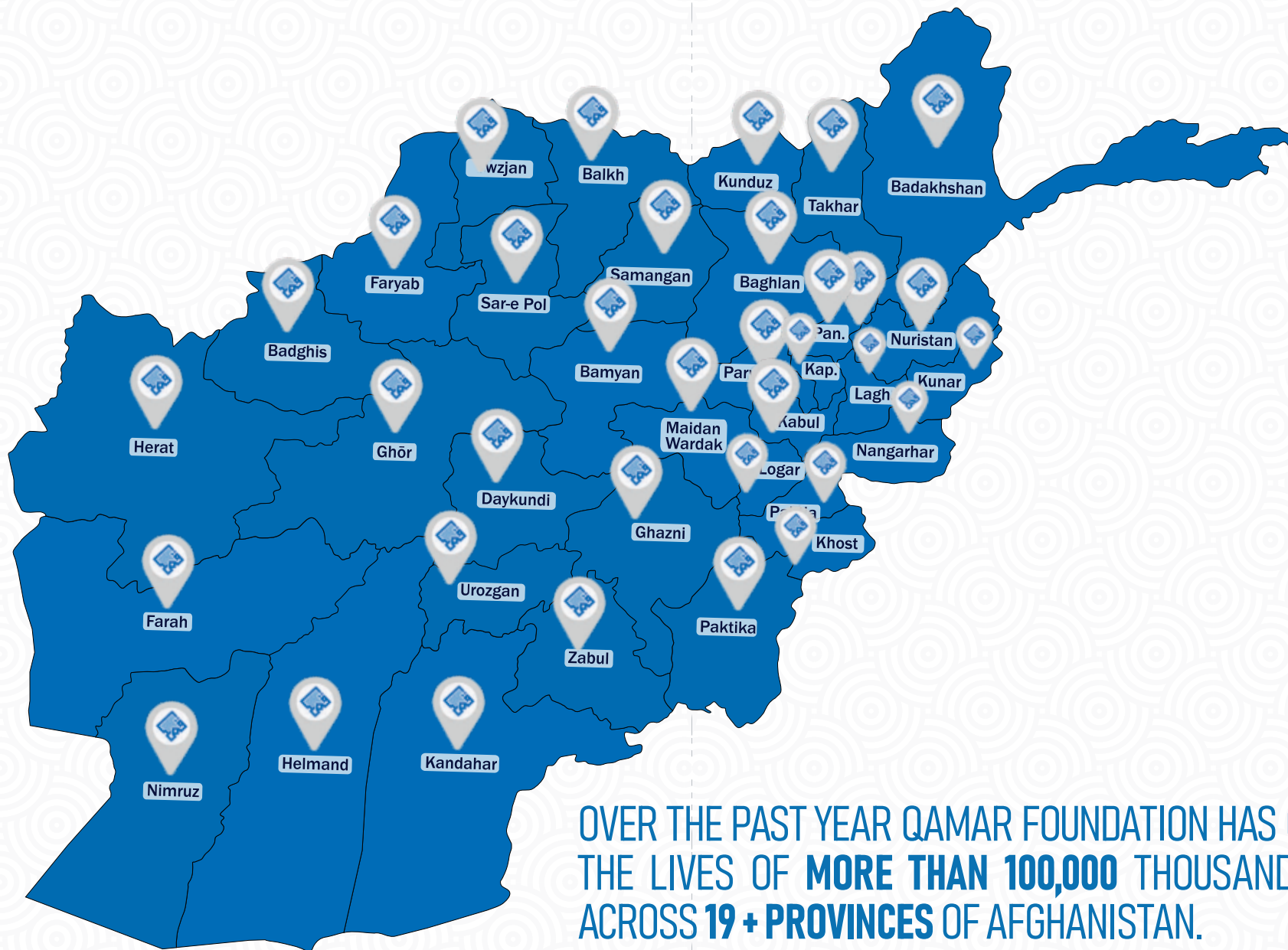

## EMERGENCY RESPONSES

Years of internal conflict and extreme natural disasters, particularly drought, have shaped Afghanistan's turbulent history. Despite these war-torn conditions, the people of this nation continue to suffer from extreme poverty. Due to economic crises, Afghanistan is in desperate need of humanitarian assistance, as the effects of years of war, ongoing instability, and natural disasters have placed the country in a precarious position.

In our ongoing efforts to provide immediate assistance to those in need, we have undertaken several initiatives:

**2500 + families** received emergency pack This support aims to alleviate their financial hardships and provide them with the means to meet their basic needs.



**Assistance for Refugees:** We have provided fresh hot meals, bread, to refugees crossing from the Torkham border in Afghanistan. Additionally, we have distributed ready bread loaves to the neediest families in Kabul, ensuring they have access to nourishing food during these difficult times.

# WINTER RELIEF PROGRAM

As the winter months creep in, storms and blizzards batter many parts of Afghanistan. Exacerbating the situation, people in most parts of the country are often ill-prepared for the harsh weather. Their homes are built for the scorching summer, and the few items of clothing they own are simply not warm enough for winter. Those living in open spaces or tented camps will desperately need warm clothes and shelter to fend off the bitter cold.

Based on our research, food is particularly scarce in rural areas of the country, with reports of increasing malnutrition and deaths among the most vulnerable. Women and children are especially at risk, with women typically prioritizing their families' needs above their own.

Families are exhausting the last of any meager savings to buy a meal, and people are begging on the streets for food. Increasing numbers of families are being pushed deep into debt just to buy food.

In the Winter Relief operations, the Qamar team focused on delivering the necessary quantities of winter aid to the main concentrations of underprivileged people suffering from the winter season. Our team delivered vital assistance, including warm clothes, stoves, blankets, wood, essential warm clothing and food items for **more than 5000+ family** members to help needy families stay warm, healthy, and protected throughout the winter.



# QAMAR FOUNDATION REBUILDS HOMES FOR HERAT EARTHQUAKE VICTIMS

In the wake of the devastating earthquake that struck Herat, Afghanistan, many families were left homeless, their lives shattered in an instant. Entire communities were reduced to rubble, with families struggling to survive amidst the destruction. The tragedy left thousands of people without shelter, forced to endure harsh weather conditions and the uncertainty of how they would rebuild their lives.

Recognizing the urgent need for safe housing, Qamar Foundation stepped forward to provide life-saving support through its Home Rebuilding Initiative. With compassion and swift action, Qamar Foundation has begun the process of constructing **27 new homes** for the victims of the Herat earthquake, offering a beacon of hope to families who lost everything.



# BUILDING HOMES, RESTORING HOPE FOR ORPHANS, DISABLED, AND NEEDY FAMILIES

Qamar Foundation is proud to announce its life-changing initiative to **build 65 homes for orphans, disabled individuals, and needy families** across Afghanistan. In a country where poverty and hardship have left many vulnerable, especially those without family support or physical ability to sustain themselves, the need for secure housing is more critical than ever.

For many orphans and disabled individuals, the lack of a stable home compounds their daily struggles, making survival even more difficult. Families facing extreme poverty, with little to no income, often endure unsafe living conditions, further deepening their vulnerability. Without the comfort of a home, they are exposed to harsh weather, insecurity, and the psychological toll of uncertainty.

Qamar Foundation's housing initiative seeks to restore dignity and hope by providing safe, warm, and secure homes for these deserving individuals. Each home is more than just a shelter—it is a foundation for a better future, where children can grow up with stability, and families can start rebuilding their lives with confidence.

# QURBANI (ZABIHA) PROGRAM

Each year, Qamar Foundation implements its Qurbani program, distributing meat packs during Eid ul-Adha. In Islam, the Muslim community is obligated to donate money so that livestock can be slaughtered, cut, and packaged. On behalf of donors, these packets are distributed to impoverished families in some of the poorest areas, ensuring that families who normally have little or no food can enjoy a nutritious meal. This year, we have **distributed 20,000 + meat Packs** for the Qurbani relief program in Kabul and other provinces of Afghanistan

## A LIFELINE FOR POOR FAMILIES IN AFGHANISTAN

For countless Afghan families, the struggle for daily survival overshadows the joy and spiritual significance of Ramadan. With widespread poverty, food insecurity, and the ongoing impact of years of conflict, many are left wondering how they will feed their families, let alone celebrate this blessed month.

Afghanistan continues to face some of the highest levels of poverty in the world. After decades of conflict, natural disasters such as floods and earthquakes, and economic instability, millions of families find themselves trapped in a cycle of poverty. **Over 40%** of the population lives below the poverty line, and food insecurity is rampant, particularly in rural areas where access to resources is limited. Many families do not have enough food to break their fast at Iftar or to sustain themselves during Suhoor.

In response to this dire situation, Qamar Foundation has launched the Ramadan Food Pack Initiative to provide much-needed relief to poor families across Afghanistan. Each food pack is carefully designed to offer essential items that will sustain a family throughout the month of Ramadan. These packs include rice, flour, cooking oil, lentils, dates, and other staples, allowing families to observe Ramadan with dignity and without the constant worry of where their next meal will come from.

For just a small contribution, you can ensure that a family in Afghanistan has enough food to break their fast and share in the blessings of Ramadan. Each pack is not just a donation; it is an expression of solidarity, compassion, and hope for those who are enduring unimaginable hardship.



## SEASONAL AID RAMADAN IFTAR MEALS

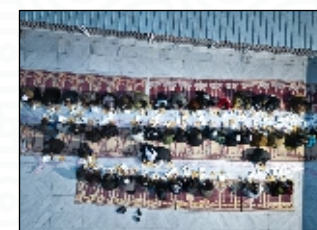
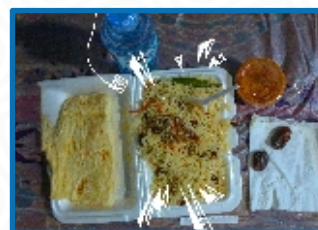
For millions, acquiring sufficient food is a daily struggle, with parents facing the painful reality of being unable to provide their children with a meal to start and break their fast. With resource depletion, food availability, and financial resources are even harder to come by for our already-vulnerable communities. Based on our experience working on the ground in different parts of Afghanistan for many years, this past year was particularly challenging for poor families.

With more than half of the population living below the poverty line and people still in dire need, Qamar Foundation provided aid in combating Afghan hunger by distributing warm, cooked meals to families in need, ensuring they could have a hot, nutritious Iftar meal.

Through our Warm Iftar Meals program, we helped alleviate food insecurity in remote areas throughout Afghanistan, providing **more than 30,000 + Iftar-cooked meals**. With the generous support of our donors, we reached vulnerable groups and communities that have suffered from natural disasters or poverty, adversely affecting their food and nutrition security.

Qamar Foundation has distributed the iftar meals in the following provinces during Ramadan:

# WE PROVIDED CRUCIAL HUMANITARIAN AID TO (500) BENEFICIARIES IN PAKISTAN.

Pakistan, with its rich history and vibrant culture, faces enormous challenges. Poverty is a leading cause of hunger, malnutrition, and disease in Pakistan. Almost a quarter of Pakistan's population lives below the poverty line, without access to food, shelter, clothing, or healthcare. Pakistan's food insecurity makes it more vulnerable to the long-term effects of climate change. Threatening to disrupt agricultural activities and unleash extreme weather events such as the recent deadly floods, which devastated Pakistan's infrastructure and cost billions of rupees. Pakistan was devastated by the worst floods in its history, which left 33 million people homeless and caused over 20 billion GBP in damage.

Thanks to your generosity, Qamar foundation was able to provide critical aid to the most vulnerable communities in Pakistan's most remote areas, such as hot meals, food packs, for orphans and also repairing orphanage.

**Qualified Opinion**

We have audited the financial statements of Qamar Foundation for the year ended 31 December 2023 which comprise the Statement of Financial Activities, the Balance Sheet, Cash Flow Statement and notes to the financial statements, including significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards including FRS 102. The Financial Reporting Standard applicable in the UK and the Republic of Ireland (UK Kingdom Generally Accepted Accounting Practice).

In our opinion, except for the effects of the matter described in the Basis for qualified opinion section, the financial statements:

- give a true and fair view of the state of the charity's affairs as at 31 December 2023 and of its incoming resources and application of resources for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- have been prepared in accordance with the requirements of the Charities Act 2011.

**Basis for qualified opinion**

It was not clear whether certain donations shown as income and some expenditure on charitable activities were restricted or unrestricted in their nature.

This would have an effect on the balances of the restricted and unrestricted funds at 31 December 2023 although the total funds are accurate.

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the Charity in accordance with the ethical requirements that are relevant to our audit of financial statements in the UK, including the FRC's Ethical Standard and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis of our qualified opinion.

**Key audit matters**

Except for the matter described in the Basis for qualified opinion section, we have determined that there are no key audit matters to be communicated in our report

Our opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon.

Our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the course of the audit, or otherwise appears to be materially misstated. If we identify such material this gives rise to a material misstatement in the financial statements themselves. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

Although the Trustees Report provides a comprehensive review of the work carried out by the charity in the year, there are a number of omissions in reporting so the report does not comply with the SORP on disclosure of all key facts.

**Matters on which we are required to report by exception**

In the light of the knowledge and understanding of the charity and its environment obtained in the course of the audit, we have not identified material misstatements in the trustees' report

We have nothing to report in respect of the following matters in relation to which the Charities (Accounts and Reports) Regulations 2008 require us to report to you if, in our opinion:

- adequate and proper accounting records have not been kept, or returns adequate for our audit have not been received from branches not visited by us : or
- the financial statements are not in agreement with the accounting records and returns; or
- we have not received all the information and explanations we require for our audit.

The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below:

We identified areas of laws and regulations that could reasonably be expected to have a material effect on the financial statements from our sector experience through discussion with the Officers and other management (as required by auditing standards).

We had regard to laws and regulations in areas that directly affect the financial statements including financial reporting and taxation legislation. We considered that extent of compliance with those laws and regulations as part of our procedures on the related financial statement items.

With the exception of any known or possible non-compliance, and as required by auditing standards, our work in respect of these was limited to enquiry of the Officers.

We communicated identified laws and regulations throughout our team and remained alert to any indications of non-compliance throughout the audit.



## **1 Accounting policies**

### **Basis of accounting**

The financial statements of the charitable organisation, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011.

The financial statements have been prepared under the historical cost convention.

Assets and liabilities are initially recognised at cost or transaction values unless otherwise stated in the relevant accounting policy note

The financial statements are prepared in sterling which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £1.

### **Going Concern**

The trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future at the time of approving the financial statements. Thus the trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

### **Turnover**

Turnover represents all income to the charity, the majority of which is donations.

### **Income**

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

### **Expenditure**

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

### **Tangible fixed assets**

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life:

### **Creditors**

Creditors are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors are normally recognised at their settlement amount after allowing for any trade discounts.

### **Taxation**

The charity is exempt from corporation tax on its charitable activities.

Value added tax is not recoverable by the charity and as such is included in the relevant costs in the statement of financial activities.

### **Critical accounting estimates and judgement**

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The charity makes estimates and assumptions concerning the future.

The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results.

### **Fund accounting**

Unrestricted general funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can be only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.
