Objects: THE PROTECTION, PRESERVATION AND IMPROVEMENT OF THE ENVIRONMENT FOR THE BENEFIT OF THE PUBLIC AND TO ADVANCE THE EDUCATION OF THE PUBLIC IN MATTERS CONCERNING THE ENVIRONMENT, ITS CONSERVATION AND PROTECTION BY: (1) THE RECLAMATION, REMEDIATION, RESTORATION OR ANY OTHER OPERATION INTENDED TO FACILITATE THE ECONOMIC, SOCIAL OR ENVIRONMENTAL USE OF LAND; (2) ANY OPERATION INTENDED TO PREVENT OR REDUCE ANY POTENTIAL FOR POLLUTION OR TO REMEDY OR MITIGATE THE EFFECTS OF ANY POLLUTION OF LAND WHICH MAY BE, IS BEING OR HAS BEEN POLLUTED BY THE CARRYING ON OF AN ACTIVITY ON THE LAND WHICH HAS NOW CEASED; (3) THE PROVISION, MAINTENANCE OR IMPROVEMENT OF A PUBLIC PARK OR OTHER PUBLIC AMENITY PROVIDED IT IS FOR THE PROTECTION OF THE ENVIRONMENT; (4) WHERE IT IS FOR THE PROTECTION OF THE ENVIRONMENT, THE CONSERVATION OR PROMOTION OF BIOLOGICAL DIVERSITY THROUGH: (A) THE PROVISION, CONSERVATION, RESTORATION OR ENHANCEMENT OF A NATURAL HABITAT; (B) THE MAINTENANCE OR RECOVERY OF A SPECIES IN ITS NATURAL HABIT; (5) THE MAINTENANCE, REPAIR OR RESTORATION OF A BUILDING OR OTHER STRUCTURE OPEN TO THE PUBLIC AND WHICH IS A PLACE OF RELIGIOUS WORSHIP OR OF HISTORIC OR ARCHITECTURAL INTEREST PROVIDED IT IS FOR THE PROTECTION OF THE ENVIRONMENT.
