Objects: 1) THE RELIEF OF SICKNESS AND THE PRESERVATION OF HEALTH AMONG PEOPLE ANYWHERE IN THE WORLD WHO ARE IN POOR HEALTH OR WHO ARE AT A DISPROPORTIONATE RISK OF SUFFERING DUE TO ILLNESS OR DISEASE BY THE PROVISION OF GRANTS, ITEMS OR SERVICES TO INDIVIDUALS IN NEED OR CHARITIES OR OTHER ORGANISATIONS WORKING TO ACHIEVE THIS AIM;2) THE PREVENTION OR RELIEF OF POVERTY ANYWHERE IN THE WORLD BY PROVIDING GRANTS, ITEMS OR SERVICES TO INDIVIDUALS IN NEED OR CHARITIES OR OTHER ORGANISATIONS WORKING TO ACHIEVE THIS AIM;3) TO ADVANCE THE CHRISTIAN FAITH FOR THE BENEFIT OF THE PUBLIC IN ACCORDANCE WITH THE STATEMENT OF BELIEF AT SCHEDULE ONE BY PROVIDING GRANTS, ITEMS OR SERVICES TO CHARITIES OR OTHER ORGANISATIONS WORKING ANYWHERE IN THE WORLD TO ACHIEVE THIS AIM;4) TO ASSIST IN SUCH WAYS AS THE CHARITY TRUSTEES SEE FIT ANY CHARITY OR OTHER ORGANISATION OPERATING ANYWHERE IN THE WORLD WHOSE AIMS ARE TO ADVANCE THE EDUCATION OF THOSE WHO LACK EDUCATIONAL OPPORTUNITY OR PROVISION DUE TO FINANCIAL HARDSHIP.
