TO ADVANCE THE EDUCATION OF THE PUBLIC REGARDING THE IMPORTANCE OF THE NATURAL ENVIRONMENT AND THE CONTRIBUTION THAT LOCAL NATURE CONSERVATION PROJECTS (IN PARTICULAR THE MOUNTAIN GORILLA RESERVES) MAKE TO THE WELL-BEING OF LOCAL COMMUNITIES.

Activities: Omushana, Sunshine for Children aims to enhance lives of children in the villages around the mountain gorilla reserves in SW Uganda by improving their educational opportunities, welfare, confidence and quality of life. To date, Omushana has constructed a community Library & IT Training Centre, assisted more than 10 schools, children's groups, a vocational institute and football academy club.
