IN FURTHERANCE OF THESE OBJECTS BUT NOT OTHERWISE, THE TRUSTEES SHALL HAVE THE POWER: TO ESTABLISH OR SECURE THE ESTABLISHMENT OF A COMMUNITY CENTRE AND TO MAINTAIN OR MANAGE OR CO-OPERATE WITH ANY STATUTORY AUTHORITY IN THE MAINTENANCE AND MANAGEMENT OF SUCH A CENTRE FOR ACTIVITIES PROMOTED BY THE CHARITY IN FURTHERANCE OF THE OBJECTS ABOVE.

Activities: Providing a refurbished community centre for accessible rental to create a safe, welcoming venue for leisure and learning; strengthening our community. All rentals have met our charitable objects. To date the rentals have included: Pre School, Faith Group, Voluntary organisation celebrating volunteering, Board meetings and Community events.
