The Trustees present their report and the financial statements of Kinetic Foundation for the year ended 31 August 2020, which have been prepared in accordance with the Companies Act 2006, the Charities Act 2011, the Charities Statement of Recommended Practice (Charities SORP (FRS 102)) and Financial Reporting Standard 102 (FRS 102).

## OUR AIMS AND OBJECTIVES

### Purposes and Aims

Our purpose is set out in the objects and contained in our articles of association.

The Kinetic Foundation supports disadvantaged and/or disengaged young people from the most deprived areas in London by delivering a wide range of educational opportunities for them to learn new skills and improve their employment potential. Most of our participants come from BAME communities, are male and aged between 14-19. Focusing on community togetherness and using football as the hook for participation, we offer free sport and education projects regardless of gender, ability, financial situation or ethnicity, which deliver structured and engaging, learning and competition. We offer opportunities, raise aspirations and develop those often overlooked and written off.

Our vision is to decrease rates of unemployment and improve the educational aspirations and achievements of the young people who use our services. Our mission is to support and help young people through providing activities which develop their skills, capacity and capabilities to enable them to participate in and integrate into society as independent, mature and responsible individuals.

We further these aims by specifically undertaking the following activities:

- (1) advancing the education of young people by providing the opportunity for them to partake in education, health and vocational related training courses;
- (2) providing young people with access to facilities, training and opportunities to participate in sport, leisure and volunteer activities; and
- (3) advancing and promoting community development through volunteering.

### Ensuring our work delivers our aims

We have now completed the eighth year of operation as a registered charity. In the last 12 months, as in the previous years, we have built upon the projects we continue to run and launch, all with further success. Continually reviewing how our projects connect to and further our aims and objectives, we monitor each project as they progress and assess the achievements and the benefits that they have brought to our young people, so learning important lessons.

### The focus of our work

We take each young participant and use their passion for football to focus and encourage them to participate in education, volunteer work and ultimately to provide them with viable prospects and a grounding for future work opportunities. But it is equally important that these young people then in turn use their position to coach, encourage and guide many other young people in their communities to similarly find confidence, opportunity and friendship through sport.

### How our activities deliver public benefit

In 2019/20 the Kinetic Foundation delivered:

- 3 Post-16 full time education projects with 121 young people enrolled.
- 6 weekly community football sessions reaching over 150 participants per week.
- 52 hours of activity every week across five local venues.
- Free funded Summer sport programmes for the most vulnerable and deprived children in Reigate and Banstead, giving our young people the chance to volunteer and start employment.
- More than 75 GCSE students received support, football sessions, coaching workshops and volunteering opportunities.

Initial engagement with young people is through free weekly football sessions often run at evening hours of high crime and antisocial behaviour. Football provides a platform for mutual respect and communication, which is a powerful tool for initial engagement and breaking down boundaries. The main aims of the structured community sessions are to give young people access to free physical activity and for our highly skilled coaches to provide support and advice, whilst signposting to future education and employment opportunities available to the individual.

Our main project is the Kinetic Academy, an inclusive Post-16 Football Academy. The project encourages every participant at Kinetic to stay in education and complete a University recognised course, all whilst pursuing their football dreams. This education environment, partnered with a structured football programme, provides each participant with an invaluable structure to help them develop and opens avenues into further education or employment. Our success stories show that only 3% of our graduates leave to become NEETs. We have alumni fulfilling their dreams of playing professional football, scholars at American universities, others attending Russell Group UK universities as well as a large number entering paid employment. All these outcomes are made possible through providing a clear vision and journey for each young person, changing their mindsets and unlocking their potential, all through a passion for football.

Our case studies are not revolutionary, but the achievements are made even greater considering the barriers that our young people face due to their backgrounds and upbringing. In numerous cases of successful university admissions, students are the first of their family to attend. We provide opportunities to young people, whilst providing a support network to their families, who may otherwise find themselves involved in crime, gang culture or disengaged with society.

Kinetic uses a unique community sport model that provides diversionary activities, education and opportunities to the most vulnerable, ignored and overlooked communities in London.

### FINANCIAL REVIEW

Funding for the Charity comes mainly from partner school service delivery fees, grants, corporate partnerships and events.

During our eighth year in operation we raised funds of £351,604, an increase on the previous year. The largest contribution was £210,306 of Education Grants made to support our full time Academy programme. The other major contribution was £91,388 of community grants. Of the funds raised £337,997 was spent. With an increased number of hours delivered, young people in our programmes and further financial support by donors for our projects, our largest expenditure was £228,755 in relation to staff costs. We have a balance of £80,763 available at the end of the financial year which we intend to use to provide financial stability in support of our ongoing and new initiatives moving forward

### FUTURE YEARS

We have received national coverage and local awards for the Kinetic Academy project, our young people and the outcomes generated. Because of this, the number of Post-16 school spaces have doubled in the last 2 years and we are inundated with requests to join our programmes and want to provide more opportunities for more young people.

As a result, we have increased the number of young people enrolled in our full-time Academy with the introduction of additional course offerings at Harris Academy South Norwood, Harris Academy Tottenham and Harris Professional Skills Sixth Form. We have more than 200 young people enrolled on our Post-16 programmes for school year 2020/21.

Launching in Tottenham marks our first step towards expansion into a new geographic location and we plan to implement our full community model there within two years.

We will maintain our engagement with 14-16-year-old participants through our free funded community football where we can continue to have the biggest impact on young lives. This SportEducate project continues to run with generous funds donated by the Dylan Howells Foundation and the Real Madrid Foundation.

Over the next five years we aim to:

1. Increase amount of corporate unrestricted funding and donations to improve sustainability, through improved marketing;
2. create our own hub for sport and education in Croydon; and
3. expand our full-time education programmes more widely across London.

The responsibility to help, track and progress each young person is more important than ever. Higher participation means Kinetic can benefit more young people, but this also incurs an increased administrative and pastoral support demand. We do not want to lose sight of the fundamentals, namely the outcomes and exit routes, that built the foundations of this successful community football and education charity.

### Impact of the Coronavirus pandemic

In 2020, the Coronavirus pandemic has impacted the Foundation through the closure of schools, the cessation of sporting activities, the prohibition of gatherings and the cancellation of significant fund-raising events. Through the crisis the board of trustees has continued to meet to assess the implications of the pandemic for the financial health of the Foundation and the wellbeing of the beneficiaries. The bulk of the Foundation's income is from educational bodies and is not expected to be affected. The Foundation has taken up the Government Furlough Scheme for its coaching staff due to the shortfall in fundraising income. For future years we intend to use the delayed 2020 Euros and our 10th Anniversary to reach our fundraising and income targets.

The challenge of the pandemic has seen demand for our services increase with parents and young people continuing to self-refer. We are allocating funds to training and increasing our support staff to help manage the mental wellbeing and progression of our participants.

### STRUCTURE, GOVERNANCE AND MANAGEMENT

#### Governing Document

The organisation is a charitable company limited by guarantee, incorporated on 12 October 2012 and registered as a charity on 21 March 2013. The company was established under a memorandum of association and articles of association which set out the objects and powers of the charitable company and govern its operations. In the event of the company being wound up the members are each required to contribute an amount not exceeding £10.

#### Board of Trustees

The directors of the company are also charity trustees for the purposes of charity law. Under the requirements of the articles of association, at each annual general meeting one-third of the board of trustees (such number to be made up of the longest serving members) must be put forward for re-election.

All members of the Board of Trustees give their time voluntarily and receive no benefits from the charity.

At the annual general meeting held on 18 June 2020, Hannah Charlton, James Calvert, Andy Rennison and Soye Briggs offered themselves for re-election and were duly re-elected.

As the charity's focus is on young people and the provision of the bespoke sports-related programme, the Board of Trustees seeks to ensure that the requirements of this group and the programme are accurately reflected through the diversity of the trustee board.

The trustees have a good working knowledge of the Foundation's aims and objectives and the initiatives in place to meet them. The board members bring vastly different experiences, qualifications and knowledge from traditional business; legal skills; experience in sports and working with underprivileged young people.

#### Organisational Structure

As of 31 August 2020, Kinetic Foundation had a board of trustees of 9 members from a variety of professional backgrounds relevant to the work of the charity, who meet at least quarterly and are responsible for the strategic direction and governance of the charity.

The day-to-day management of the Foundation including provision of the programmes and other initiatives is delegated to the Chief Operating Officer and the Academy Manager. They have responsibility for the overall operational management of the programmes including supervision of the young people and ensuring that the instructional and support team involved continue to develop their skills and working practices in line with good practice.

### RESPONSIBILITIES OF THE BOARD OF TRUSTEES

The trustees (who are also directors of Kinetic Foundation for the purposes of company law), as set out on page 1, are responsible for preparing the Trustees' Report (incorporating the directors' report) and the financial statements in accordance with applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102: The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

Company law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company and of the income and expenditure, of the charitable company for that period. In preparing these financial statements, the trustees are required to:

- (a) select suitable accounting policies and then apply them consistently;
- (b) observe the methods and principles in the Charities SORP;
- (c) make judgments and accounting estimates that are reasonable and prudent;
- (d) state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements, and
- (e) prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business.

The trustees are responsible for maintaining proper accounting records which disclose with reasonable accuracy at any time the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

This report is prepared in accordance with the provisions applicable to companies subject to the small companies regime within Part 15 of the Companies Act 2006.

## CONCLUSIONS

The Trustees continue to support and challenge all that Kinetic Foundation is doing and to administer the growing programme. The current pandemic continues to place unprecedented pressure on Kinetic Foundation and those we exist to support. Through prudent management, the financial position remains strong due to the funding base from government educational bodies; the use of the furlough scheme and the hard work in obtaining grant funding in place of our usual fund-raising opportunities. I am grateful to my fellow trustees for their support and commitment to guide the organisation; especially at the time of the first lockdown and to Harry and James and all the Kinetic team for managing through the year whilst remaining unrelenting in their focus on the students. In the same way that the long-term effects of the 2008 financial crisis in part brought about Kinetic Foundation, the long term economic and social implications of the Pandemic on young people will only serve to increase the need for Kinetic Foundation.

In delivering what we do, we are always in deep gratitude to the many people and organisations that generously donate their money, their time and their ideas. On behalf of everyone at Kinetic Foundation, we extend our thanks to them once again. We simply could not exist and help all the young people within our realm without that support and in turn those young people would be denied the life chances we seek to give them.

It is always hugely gratifying to see the lives of the young people we exist to support develop positively; but the relationship between them, Kinetic Foundation and all our supporters is a symbiotic one where everyone derives some benefit. We would never presume it to be one way because it is the essence of our ethos that by giving and sharing, everyone gains including society as a whole. One only has to hear the stories of some of our Alumni to understand that.

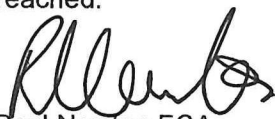
### Independent examiner's statement

### 1. ACCOUNTING POLICIES

The principal accounting policies adopted, judgements and key sources of estimation uncertainty in the preparation of the financial statements are as follows:

#### **Basis of preparation**

The financial statements have been prepared under the Companies Act 2006 and in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) – (Charities SORP (FRS102) as amended by Update Bulletin 1) and Financial Reporting Standard 102 (FRS 102). The financial statements are drawn up on the historical cost basis of accounting, and are prepared in sterling, which is the financial currency of the charity, rounded to the nearest £.

Kinetic Foundation is a private company limited by guarantee incorporated in England and Wales. The registered office is Croydon Sports Arena, Albert Road, London, SE25 4QL. The charity meets the definition of a public benefit entity under FRS 102.

The trustees consider that there are no material uncertainties about the charity's ability to continue as a going concern.

#### **Tangible fixed assets**

Tangible fixed assets costing more than £100 are capitalised and included at cost including any incidental expenses of acquisition.

#### **Depreciation**

Depreciation is provided on all tangible fixed assets at rates calculated to write off the cost less estimated residual value of each asset over its expected useful life of four years on a straight line basis.

#### **Debtors**

Grants receivable and other debtors are included at the settlement amount due. Prepayments are valued at the amount prepaid.

#### **Cash at bank and in hand**

Cash at bank and in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of opening of the deposit

#### **Creditors and provisions**

Creditors and provisions are recognised where the charity has a present obligation arising from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are recognised at their settlement amount.

#### **Financial instruments**

The charity only has financial assets and liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

#### **Restricted funds**

These are restricted income funds given to the charity for specific purposes. They are expendable by the trustees in furtherance of particular projects within the charity objects.

#### **Unrestricted funds**

These are funds expendable at the discretion of the trustees in furtherance of the objects of the charity.

### 1. ACCOUNTING POLICIES (continued)

#### Income recognition

Donations and other incoming resources (including legacies) are included in the Statement of Financial Activities (SOFA) when the charity has entitlement to the income, it is probable the income will be received and the amount of income receivable can be reliably measured. Grant income is accounted for on an accruals basis and matched to the appropriate period. No amounts are included in the financial statements for services donated by volunteers.

#### Expenditure recognition

All expenditure is accrued as soon as a liability is considered probable, discounted to present value for longer term liabilities and has been classified under headings that aggregate all costs related to the category.

### 10. RELATED PARTY TRANSACTIONS

Kinetic Foundation paid staff costs under joint contracts of employment of £78,256 (2019: £87,917) to Kinetic Coaching in Sport Ltd during the year, a company jointly owned by the key management personnel Mr J Fotheringham and Mr H Hudson. In addition, other consultancy costs of £38,500 plus VAT (2019: £nil) were paid to Kinetic Coaching in Sport Ltd. At the year end the charity owed £19,482 (2019: £nil) to Kinetic Coaching in Sport Ltd, which was settled on 1 September 2020.
