The young Rabbi and his wife continue their excellent work within the local community, the Jewish Society at Bournemouth University, providing weekly kosher Sabbath take away meals for the students and visits to the elderly. The teenagers group where the participants enhance their knowledge of Judaism continues to interact in person and via zoom with other similar groups worldwide.

Hospital and care home visiting and community welfare services continue to feature among our core activities and our excellent relationship with the Dorset Constabulary ensures our premises and community are safe and secure which has become even more necessary during these troubled times.

Financial Review

The charity has maintained a healthy level of achievement in all its performance targets. This has enabled sustained and new funding to be invested in future services. The Trustees are conscious of the need to further expand the Charity's fundraising in order to secure the activities of the charity.

Policy on reserves

Unrestricted reserves - It is the policy of the Trustees to seek to maintain funds which are the reserves of the Charity at a level sufficient to cover management, administration and support costs, subject to constraints arising from diminishing financial and other resources available.

Restricted reserves are funds subject to specific grants and are spent at the discretion of the Trustees in furtherance of some particular aspect of the objects of the Charity. Should a surplus arise on a restricted fund the charity will look at how to apply this in accordance with the donor's wishes. The charity's Trustees and managers are active in seeking grants for its activities. The material amount of restricted reserves relates to funding received for the freehold property shown in note 12 of the financial statements.

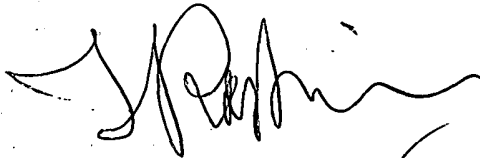

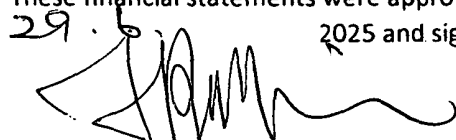

Basis of accounting

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008), and the requirements of the Statement of Recommended Practice "Accounting and Reporting by Charities" issued in March 2005 (SORP 2005).

Incoming resources

Fund accounting

Resources expended

Expenditure is included on an accruals basis, inclusive of value added tax.

Costs of generating funds are those costs incurred in attracting voluntary income, in particular the costs of maintaining the Charity's profile within the sector.

Governance costs include those costs incurred in the governance of the Charity's assets and are primarily associated with constitutional and statutory requirements.

Liabilities are recognised when incurred. Provisions are only recognised when there is a present obligation as a result of past events.

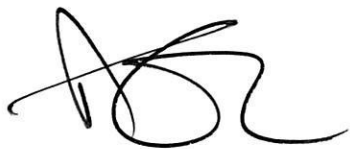

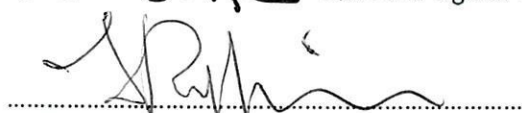

YEAR ENDED 31 MARCH 2021

1 ACCOUNTING POLICIES

Basis of accounting

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008), and the requirements of the Statement of Recommended Practice "Accounting and Reporting by Charities" issued in March 2005 (SORP 2005).

The Charity has taken advantage of the exemptions in the Financial Reporting Standard for Smaller Entities (effective January 2008) from the requirements to produce a cash flow statement on the grounds that it is a small charity.

Incoming resources

Income has been recognised gross on the basis of entitlement, certainty and measurement. Donations, legacies and other forms of voluntary income are recognised as incoming resources when receivable, except insofar as they are incapable of financial measurement.

Fund accounting

Unrestricted funds are general funds that are available for use at the trustees' discretion in furtherance of the objectives of the Charity.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the accounts.

Resources expended

Expenditure is included on an accruals basis, inclusive of value added tax.

Costs of generating funds are those costs incurred in attracting voluntary income, in particular the costs of maintaining the Charity's profile within the sector.

Governance costs include those costs incurred in the governance of the Charity's assets and are primarily associated with constitutional and statutory requirements.

Liabilities are recognised when incurred. Provisions are only recognised when there is a present obligation as a result of past events.

Tangible fixed assets

All fixed asset initially recorded at cost

Depreciation is calculated so as to write off the cost of an asset, less its estimated residual value, over the useful economic life of that asset as follows

- Fixtures and fittings - 15% per annum straight line
- Motor vehicles - 25% per annum straight line

Going concern

No material uncertainties that may cast significant doubt about the ability of the company to continue as a going concern have been identified by the trustees.
