Trustees Report:

Objectives and Activities

Objectives as set out in the constitution:

The relief of financial hardship amongst those seeking asylum in the United Kingdom or who are refugees, and who reside in the West Midlands.

To preserve and protect the physical and mental health of those awaiting and those granted refugee status and their dependents.

Activities:

- Community hosting network for destitute refugees and migrants
- Befriending and advocacy support for separated young refugees
- Sessional activities and support for newly arrived asylum seeking families
- Outreach support to newly arrived asylum seekers living in hotel accommodation

Trustee's Responsibilities in Relation to the Financial Statements.

The charity trustees are responsible for preparing an annual report and financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice). The law applicable to charities in England and Wales requires the charity trustees to prepare financial statements for each year which give a true and fair view of the state of affairs and of the incoming resources and application of resources of the charity for that period. The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities Act 1993, the charity (Accounts and Reports) Regulations 2008 and the provisions of the trust deed. They are also responsible for safeguarding the assets of the charity and hence taking reasonable steps for the prevention and detection of fraud and other irregularities.

Summary of main achievements

This year was another very busy year and saw staff supporting more sanctuary seekers than the previous 12 months - over the course of the year we supported 649 individuals. Despite there being many changes to the asylum and huge problems with delays, backlogs, policy and legal changes, our staff have remained flexible and responsive in their support. As an organisation we have achieved some fantastic outcomes for our beneficiaries and have increased our advocacy work significantly to fill the gaps left by closures of other services or changing needs. Our team have made referrals to over thirty different agencies across Birmingham and the West Midlands, most notably we have made referrals to: The Bike Project, Refugee Action, Refugee and Migrant Centre, St Chad's Sanctuary, Birmingham Children's Trust (for age dispute cases), Brushstrokes, Breaking Barriers and Restore.

The year was very challenging for staff and volunteers and we are prioritising our staff's wellbeing and have been exploring ways to ensure staff feel supported. Our staff team lead the West Midlands response to the Rwanda detentions during April and May and this was a very intense period for all those involved. Followed quickly by the riots in the summer and some intense support to 100 men who were moved out of a hotel in Rotherham, meant that staff felt quite depleted by Autumn. Staff now meet more regularly for wellbeing sessions and regularly check in with each other and our Development Worker feeds any concerns into the Trustee Board. We will continue to monitor these situations.

Our hosting project remained quiet as per the previous year but we were happy that we were able to support two destitute asylum seekers, providing 30 nights of accommodation despite receiving approximately 20 referrals and enquiries - sadly many did not meet our criteria but where possible, we provided invaluable information to a range of other agencies which enabled them to take action to avoid destitution for their service users.

Our family befriending and advocacy project has been extremely busy, supporting over 161 separated young refugees - 61 of whom were age disputed (the Home Office Border Agency gives them a date of birth making them an adult, despite the young person claiming to be under 18). Much more of our time has been spent on supporting these age disputed young people. Our youth hub has continued to grow and we offered 29 youth hub sessions, recording 393 attendances from - 102 young people. Demand for the youth hub is growing and becoming more of a focus of our work. In response, we have increased the number of volunteers at the hub to support our staff and plan to try to increase staff support going forwards. We are very grateful to the community at St. John's Sparkhill for their support since we moved to using their Church Hall in January 2025. The youth hub offers a safe and welcoming space for the young people who attend but we also offer a holistic approach to helping to improve the confidence and resilience of the attendees. We continued to offer a lot of one-to-one advocacy support for those who needed it and made many referrals to a wide range of relevant support services. We also continued to offer our befriending support and matched ten young people with family befrienders as well as supporting several historical ongoing matches which go back a number of years. A couple of our volunteers also befriended a group of four young refugees who were struggling in hotels, offering weekly support sessions in the hotels and meeting them as a group for outings. Some of these young people would have struggled in one to one befriending situations and we are keen to develop this group befriending model going forward as an alternative to our traditional befriending model.

Our family support project continued to offer a great deal of advocacy work to the families, single women and couples who live in a city centre asylum hotel. The project supported, 166 individuals, 100 adults and 66 children - who made up 44 families and 45 single people/couples. Our project coordinator ran 37 community hubs in the hotel - recording 787 attendances. On average 25 family members attended each hub, a mix of adults and children. The hubs involved a lot of emotional support, sorting out practical issues, advocacy with various agencies, a lot of health advocacy, liaison with GPs etc, help with applying for schools and also guiding family members through the Right to Remain Toolkit to help them prepare for their asylum interviews. We supported 65 children to attend school and 22 young people to go to college/higher education and also secured 12 nursery places for under 5s. We also ran 10 wellbeing trips and activities which included visits to Martineau Gardens for

their spring and summer celebrations, several trips to Botanical Gardens, Think Tank Science Museum, Birmingham Cathedral and Roundhouse Art Sessions.

Our hotel outreach in other asylum support hotels was also extremely busy, and our outreach coordinator supported 311 individuals, the majority single men. Our outreach worker ran hubs in three hotels across Birmingham and currently runs weekly hubs in two hotels and offer remote WhatsApp support to a third hotel. Across the three hotels, our coordinator ran 76 community hubs recording 849 attendances, on average 11 people attended each hub. At the start of the year much of the advocacy work focussed on the Rwanda detentions and providing emotional support to many residents including for those who had fled to another city to avoid possible detention. Over the summer, many hotels appeared to be emptying, so there was a shift to referrals to nationwide organisations as people were dispersed. During Refugee Week in June our coordinator organised a photographic exhibition for Refugee Week in collaboration with The Exchange at University of Birmingham. Sadly, the summer brought riots, a lot of fear and distress and resulted in 100+ asylum seekers being suddenly relocated to a Birmingham hotel from the Holiday Inn Rotherham which had been attacked and set on fire. Our focus changed rapidly to supporting a large number of people who had suffered a very violent attack. Our coordinator contacted Victim Support, who provided legal advice and were able to offer therapy sessions, Humans For Rights who offered legal advice, Restore for befriending, Birmingham City Council's Migration Team to fund St Chad's Sanctuary for extra clothing. This also included a huge amount of advocacy work to liaise with the Home Office around new addresses, missed asylum interviews, sorting out medication, access to GPs, locating belongings etc. Then in the autumn, the focus shifted again as the Home Office started to process asylum claims and disperse residents very quickly. Since then we have witnessed a high turnover in the hotels which means that we now focus more on support for interviews (travel arrangements and prep) and lots of support for submitting appeals, lots of referrals for successful applicants for moving on support accessing e-visas. We are also having to support more refused asylum seekers and are having to support them to appeals. Over the year we also ran six wellbeing activities which included visits to Martieau gardens, Illuminate Festival at Botanical Gardens and theatre trips.

The Development Worker continues to support staff to develop their projects and explore new funding opportunities. Our worker has drawn in funds from a wide range of funders over the course of the financial year as well as raising awareness of our work, which has resulted in a strong amount raised from community donations. We are in a good financial position going into the next financial year and hope to continue to develop our projects and maintain our reserves.

Structure, Governance and Management

The charity is operated under the rules of its constitution adopted on 5th Feb 2013.

Financial Review

Birmingham Community Hosting (BIRCH) Network has a generous pool of local and regional charitable trusts and funders, as well as support from the National Lottery and good support from individual, and community funders. BIRCH raised **£87555** from charitable trusts and

foundations, and **£6718** from community donations; we raised **£680** in sales from our shop sales. **£66,455** was allocated as restricted funding for specific projects, **£21,200** was received as 'core/unrestricted running costs' funding which was designated to specific projects. **£7298** was unrestricted community donations, most of which went into our reserves. We also received **£4467** in income for specific items for individuals or for bus tickets for asylum seeking children to attend school. This is separated from other income as this is not spent on staff or project costs.

At the end of the financial year, we had secured total funds of **£94,953** during this financial year. We also carried forward **£83,861** from the previous financial year. At the end of the financial year we had **83,295** in secured cash funds. Out of these funds **£31,158** (unrestricted funds) was designated to reserves (accounting for four months of operating costs), **£30,855** (restricted funds) was carried forward and designated to the projects that the funding was restricted to and **£21,200** (unrestricted/core funding) was designated to specific future project funding.

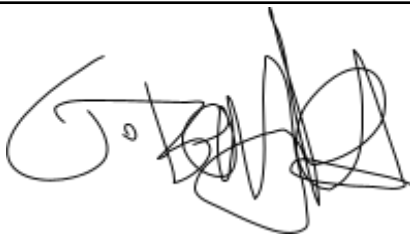

Summary of main achievements

This year was a very busy year and saw staff supporting more sanctuary seekers than the previous 12 months. Despite there being many changes to the asylum and huge problems with delays, backlogs, policy and legal changes, our staff have remained flexible and responsive in their support. As an organisation we have achieved some fantastic outcomes for our beneficiaries and have increased our advocacy work significantly to fill the gaps left by closures of other services or changing need.

Our hosting project was quieter than normal, but we were able to support four destitute asylum seekers, providing 126 nights of accommodation. We also provided invaluable information to a range of other agencies which enabled them to take action to avoid destitution for their service users.

Our family befriending and advocacy project has been extremely busy, supporting over 65 separated young refugees, and our coordinator has been engaged in a lot more one to one

advocacy and support. We have seen a big increase in age assessment cases and have worked with more under 18-year-olds than the previous few years. We have increased our wellbeing day trips and support and have continued to link in the most vulnerable separated young refugees with volunteer befrienders.

Our family support project evolved a lot over the course of the year, from stay and play sessions, to after school clubs and a big increase in advocacy work. This has mostly involved helping asylum seeking children find school places and supporting them with school uniforms, orienting them to the new school and sorting out bus tickets. We have also run more wellbeing trips and sessions. This project has supported over 60 families over the course of the year.

Our newer refugee outreach project which started in May 2022 has been very successful, with our practitioner supporting over 200 sanctuary seekers across four hotels in Birmingham. The support has included English Conversation classes, one-to-one advocacy support, group outings and activities. Our practitioner has made links with a wide range of agencies for effective cross-referral pathways and joint working, they have also run some very successful Welcome events as new hotels have opened.

The Development Worker continues to support staff to develop their projects and explore new funding opportunities. Our worker has drawn in funds from a wide range of funders over the course of the financial year as well as raising awareness of our work, which has resulted in a strong amount raised from community donations. We are in a good financial position going into the next financial year and hope to continue to develop our projects and maintain our reserves.

Structure, Governance and Management

The charity is operated under the rules of its constitution adopted on 5th Feb 2013.

We also received **£9,456** in income for specific items for individuals or for bus tickets for asylum seeking children to attend school. This is separated from other income as this is not spent on staff or project costs.

At the end of the financial year, we had total funds of **£83,861**. Out of these funds **£27,860** (unrestricted funds) was designated to reserves (accounting for four months of operating costs), **£28,327** (restricted funds) was carried forward and designated to the projects that the funding was restricted to and **£27,674** (unrestricted/core funding) was designated to specific future project funding.

ABOUT US

Here at BIRCH we offer support and friendship to people seeking sanctuary who are on the periphery of society. We focus on three main groups: those with no recourse to public funds who are experiencing destitution, young people who arrived in the country as unaccompanied asylum seeking children, and newly arrived asylum seekers families living in temporary accommodation (usually hotel accommodation).

VISION

Birmingham is a welcoming city where residents stand in solidarity with people seeking sanctuary, increasing resilience and wellbeing.

MISSION

BIRCH Network improves the lives of vulnerable refugees and migrants by relieving destitution and improving wellbeing through increased resilience.

AIMS

BIRCH Network aims to:

- provide community hospitality to asylum seekers and refugees in Birmingham and surrounding areas
- reach out and create spaces to offer support to asylum seekers, refugees and other vulnerable migrants
- reduce social isolation by offering compassion, welcome, practical support and help with integration into the local community

We mobilise volunteers and the local community to help us offer this support and to give a voice to those we are supporting. We offer advocacy and emotional support on a one-to-one basis and via group support. We are a small but responsive charity which allows us to be effective at responding to need and tailoring our work to help fill the gaps left by other services.

THE YEAR IN CONTEXT

It was another busy year for Birch Network and we continued to grow as an organisation and reach more sanctuary seekers than ever before. The expansion of hotels as accommodation for sanctuary seekers has meant that we are now offering more outreach work to a wider number of hotels and sanctuary seekers resident there. The growing asylum backlog has also meant that the type of support we offer has changed and adapted as the people we support are living for longer periods in hotels and we are witnessing the mental health impact that being left in limbo is having on them.

In June 2022 we recruited a new project coordinator, Alison Tinker, who has hugely developed our capacity to offer support to sanctuary seekers living in hotels. This new outreach project has been instrumental in helping us to connect with a wider range of support agencies and we have run some very successful welcome events to newly arrived sanctuary seekers with a growing range of support agencies. We have been able to offer English conversation classes, information hubs, and to link more and more people in with essential services and meaningful opportunities e.g. volunteer positions, sports/art clubs and college courses.

The year was dominated by the Nationality and Borders Act which came into force in April 2022 and by a general backdrop of anti-migrant and refugee rhetoric. This Act introduced various changes that will have a detrimental impact on refugees, emanating from the introduction of a discriminatory two-tier system of refugee protection (not currently in force) and also the concept of 'offshore processing', the use of 'reception centres', the criminalisation of people seeking asylum, and the age assessment of young people. In practice this has resulted in the Rwanda plan, which would see people seeking asylum sent to Rwanda. Although flights were boarded for Rwanda in 2022, as of January 2023, no one has been removed to Rwanda due to ongoing legal action. The threat of being deported to Rwanda has been very difficult for those awaiting the outcome of various legal cases and as with many other agencies, we wait to see whether this policy is deemed legal and what impact this might have.

Despite this, as you will see in the rest of the report, we have had many successes and have managed to support hundreds of sanctuary seekers. We have specifically been trying to offer more and more wellbeing and group activities to enable us to reach greater numbers of people who need support.



Night Bus Riders

We ran a successful night bus and ride and are very grateful to our trustees, volunteers and supporters who helped us raise over £2000.

We were also glad to welcome some new trustees at the start of the financial year, Emma Hawthorne and Kamilla Khalid, who bring a range of experience and expertise to our trustee team. Then following a successful AGM in January we welcomed a further three more trustees (Fatima Batool, Izzy Knowles and Nicole Lewis), who joined the team in April 2023. These new trustees bring vital experiences as service users, immigration advisers and local campaigner and volunteer host and are helping us to develop our Governance and make our Trustee Board more diverse and representative.

Objectives and Activities

Objectives as set out in the constitution:

The relief of financial hardship amongst those seeking asylum in the United Kingdom or who are refugees, and who reside in the West Midlands.

To preserve and protect the physical and mental health of those awaiting and those granted refugee status and their dependents.

Activities:

- Community hosting network for destitute refugees and migrants
- Befriending and advocacy support for separated young refugees
- Sessional activities and support for newly arrived asylum-seeking families
- Outreach support to newly arrived asylum seekers living in hotel accommodation

Trustees' Responsibilities in Relation to the Financial Statements

The charity trustees are responsible for preparing an annual report and financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice). The law applicable to charities in England and Wales requires the charity trustees to prepare financial statements for each year which give a true and fair view of the state of affairs and of the incoming resources and application of resources of the charity for that period. The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities Act 1993, the charity (Accounts and Reports) Regulations 2008 and the provisions of the trust deed. They are also responsible for safeguarding the assets of the charity and hence taking reasonable steps for the prevention and detection of fraud and other irregularities.

Summary of main achievements

This year was a very busy year and saw staff supporting more sanctuary seekers than the previous 12 months. Despite there being many changes to the asylum and huge problems with delays, backlogs, policy and legal changes, our staff have remained flexible and responsive in their support. As an organisation we have achieved some fantastic outcomes for our beneficiaries and have increased our advocacy work significantly to fill the gaps left by closures of other services or changing need.

Our hosting project was quieter than normal, with fewer asylum seekers getting refused status, but we extensively supported one young, hosted guest and continued to support another hosted single mother with various issues. We also provided invaluable information to a range of other agencies which enabled them to take action to avoid destitution for their service users.

Our family befriending and advocacy project has been extremely busy, supporting over 50 separated young refugees, and our coordinator has been engaged in a lot more one to one advocacy and support. We have seen a big increase in age assessment cases and have worked with more under 18-year-olds than the previous few years. We have increased our wellbeing day trips and support and have continued to link in the most vulnerable separated young refugees with volunteer befrienders.

Our family support project evolved a lot over the course of the year, from stay and play sessions, to after school clubs and a big increase in advocacy work. This has mostly involved asylum seeking children find school places and supporting them with school uniforms, orienting them to the new school and sorting out bus tickets. We have also run more wellbeing trips and sessions. This project has supported over 50 families over the course of the year.

Our newer refugee outreach project which started in May 2022 has been very successful, with our practitioner supporting over 179 sanctuary seekers across three hotels in Birmingham. The support has included English Conversation classes, one-to-one advocacy support, group outings and activities. Our practitioner has made links with a wide range of agencies for effective cross-referral pathways and joint working, they have also run some very successful Welcome events as new hotels have opened.

The Development Worker continues to support staff to develop their projects and explore new funding opportunities. Our worker has drawn in funds from a wide range of funders over the course of the financial year as well as raising awareness of our work, which has resulted in a strong amount raised from community donations. We are in a good financial position going into the next financial year and hope to continue to develop our projects and maintain our reserves.

Structure, Governance and Management

Nature of Governing document

The charity is operated under the rules of its constitution adopted on 5th Feb 2013.

Financial Review

Birmingham Community Hosting (BIRCH) Network has a generous pool of local and regional charitable trusts and funders, as well as support from the National Lottery and good support from individual, and community funders. BIRCH raised £54,042 from charitable trusts and foundations and £11,222 from community donations, we raised £1,099 in sales from our first Christmas shop. £56,735 was allocated as restricted funding for specific projects, and £9,628 was unrestricted community donations, most of which went into our reserves. We also received £2,318 in income for specific items for individuals or for bus tickets for asylum seeking children to attend school. This is separated from other income as this is not spent on staff or project costs.

At the end of the financial year, we had total funds of £45,788. Out of these funds £23,884 (unrestricted funds) was designated to reserves (accounting for four months of operating costs), £21,904 (restricted funds) was carried forward to be spent on the projects that the funding was restricted to.

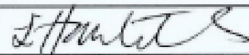

THE YEAR IN CONTEXT

As restrictions relating to the COVID 19 pandemic lifted we were able to restart a lot of our activities throughout the year. In fact we grew as an organisation and have been able to develop our services and respond to the needs that we witness. Staff remained on part furlough for some of the year but most were back on their full hours by the Autumn.

In April 2021 we celebrated Birch Network turning 10 years old and promoted some of our achievements over the last decade via social media, reflecting on our successes and developments! It feels like support and advice agencies for migrants and refugees are needed now more than ever, sadly.



During the summer we said goodbye to David Hirst, who had been involved with Birch for over five years and was involved with all of our projects at some point. David was a fantastic employee who helped to continue and develop our work and we wish him well for the future. Steph Neville, one of our existing employees, took over as our hosting network coordinator and undertook the task of getting the hosting network set up again.

In October we recruited Helen Hibberd as our new part-time development worker, a new role for Birch, which aims to focus on fundraising, staff supervision, project development and improving systems for monitoring and reporting. This has helped put us in a strong position to ensure we are able to fundraise and continue to run and develop our service.

All of our projects have adapted to the post-pandemic environment, which has seen a huge number of asylum seekers being housed in hotel accommodation for longer and longer periods. Hotels are wholly inadequate for accommodating asylum seekers, many of whom are experiencing trauma and mental anguish, and we started to do more advocacy and outreach work to the residents living in these hotels. This culminated in a decision to employ a new worker to help develop a new outreach project to enable us to offer more activities to help reduce isolation and offer welcome to newly arrived asylum seekers in Birmingham, and in May 2022 we appointed Alison Tinker to run our new project. We also participated in a report coordinated by Asylum Matters - 'In a place like prison: voices from institutional asylum accommodation' - which interviewed a variety of residents in hotel accommodation and clearly demonstrated how this type of accommodation is very negative for everyone living there, and that refugees need to be settled in local communities. We also joined the Together With Refugees coalition, which is calling for a better approach to supporting refugees that is fair, kind and more effective, and we have participated in many of the campaign activities and signed their petitions.



All of this work is set against a backdrop of growing hostility and persecution towards refugees and migrants. The 'anti-refugee' Bill aims to criminalise refugees who are trying to seek safety, and to develop large scale detention centres which are known to be detrimental to asylum seekers' physical and mental health and are often in locations with very limited access to legal advice, as well as the development of the scheme to deport asylum seekers to Rwanda which runs contrary to the UK commitments to offer safety to those seeking asylum. The year also saw many refugees coming from Afghanistan and Ukraine which helped to raise public awareness of refugees and a strong community response to help those arriving, but this is set against a backdrop of increasing hostility towards migrants from the Government. This year has created so much fear and anxiety and we will continue to do as much as we can to support migrants and refugees in Birmingham and the West Midlands.

THE HOSTING NETWORK

The pandemic continued to have an impact on the operational ability of our hosting network from April 2021 to end of March 2022. Our previous hosting coordinator, David Hirst, left in August 2020 and was replaced by Steph Neville, who is also one of our coordinators for our Family Fun Sessions.



Once in post our new hosting coordinator's main task was to get the hosting network restarted again. This meant reconnecting with previous hosting volunteers, many of whom were no longer in a position to host, and recruiting new hosts. Recruiting hosts can be challenging as we are asking for a big commitment and we have to spend time training them, checking their suitability, visiting their property and conducting DBS checks etc. During this period our coordinator was able to recruit four new host families and two previous families agreed to continue hosting.

We were then able to approach referral agencies to let them know that we were able to receive referrals to the hosting network again. We were already hosting one individual whose long-term hosting placement came to an end at the end of February 2022 when she was able to access asylum support. Our hosting coordinator and the volunteer host helped facilitate the move-on, communicating with the referral agency, the home office and the accommodation provider, and offering the guest considerable support through this transition period.

Initially referrals to the project were very slow, this was mostly due to backlogs in the asylum system, which meant that asylum seekers were not getting decisions made on their claims so there were fewer asylum seekers being refused and made destitute. This is somewhat positive, but also means that asylum seekers are in limbo longer, which can feel very distressing and often people are housed in hotels which are not suitable for extended periods of time.

As word spread about the project we started to receive referrals again. Referrals to the hosting network include asylum seekers who are evicted when their initial claim is refused and are subsequently evicted from Home Office funded accommodation, and domestic violence survivors who are waiting for spaces in women's refuges or to submit an immigration application to make them eligible for asylum support. We also work with trafficking victims, who are being referred into the national referral mechanism which provides advice, support, and accommodation for those who have been trafficked. Often these people need somewhere to stay whilst they are being referred and assessed and are not eligible for publicly funded accommodation. Everyone who we host and accept a referral for has a 'move on' plan – usually they will be making a fresh claim for asylum or another type of immigration application which will make them eligible to move into asylum support accommodation or a women's refuge/accommodation for trafficking victims.

From Sept 2021 to March 2022 we hosted three individuals, one was our existing long term guest and there were a further two individuals. One was an asylum seeker who some of our hosts hosted for a weekend while awaiting his asylum support accommodation and another guest was referred by Women's Aid, we hosted this woman for three weeks before she became eligible for benefits and was then moved back into supported accommodation.

The Homes for Ukrainians hosting scheme was also announced in March 2022 and our coordinator attended a lot of meetings and discussions about the implications and concerns about the scheme. We decided that we would support any of our current hosts who wished to join these schemes, in addition to our ongoing scheme. We have supported two of our host families to host Ukrainian families (a total of six individuals) and they are in the process of helping them apply for benefits/schools, sort out essential provisions etc.

Since March we have been very busy with referrals and have gone on to host several more cases. Our hosting scheme remains extremely valuable to destitute migrants. Our guests are taken out of destitution and provided with a warm, safe roof over their head, in the welcoming environment of a volunteer's home. As such our beneficiaries benefit from increased wellbeing, resilience and social networks during a challenging period in their lives. We continue to help those who struggle with the mental anguish that being a 'refused' asylum seeker or becoming destitute entails. Birch Network strives to help those who have received poor legal advice during their initial claim and will continue to champion on behalf of those who seek a place of safety while they try to rebuild their lives. We work closely with our referral partners to ensure that they are supported to make new immigration claims and we offer support and casework to each individual to enable them to do this. Our hosts also offer emotional and practical support to their guests and help to improve the well being, mental health and resilience of the person we are supporting

FAMILY BEFRIENDING

The Family Befriending Project matches unaccompanied young refugees (16-25 years) who are feeling unsupported, isolated and excluded with trained volunteer families who are willing to offer ongoing support and friendship.

This year the scope of the project really expanded and our befriending coordinator started offering a lot more one on one advocacy work to young refugees who were being referred to the project, as well as young refugees we were encountering through our outreach work in hotels or directly from other residents living in the hotels who were concerned about other young refugees they were living with.

Our project had been running in various ways during the pandemic via texts, WhatsApp and Zoom, as well as garden meetings and walks in the park etc. As restrictions eased it was a big relief to be able to offer the young people we support a full service and for our volunteers to be able to welcome them into their homes again. We also felt able to offer more group outings and this has been a really valuable addition to our service. It enables us to offer respite and well being days to a wider range of young people than we could previously.



17 young refugees supported by befrienders

Between April 2021 and March 2022, 17 young people were supported by befrienders (ten new cases and seven matches from previous 18 months). Additionally a further 25 young people were supported face to face with support and advice connecting them to community support. This meant that our project coordinator actively supported 43 young refugees new to the project during this period.

Our befriending coordinator also organised nine wellbeing days catering for a total of 44 young people (some people went to more than one event). These included trips to Shropshire, Wales, Warwickshire farm, and Manor House Wroxhall. We have also supported other organisations with trips to trampoline parks, football events and welcome events for newly arrived young people seeking refuge.

Our coordinator spent extended periods with nine young people in crisis, they have benefitted from one to one sessions (usually long walks in country parks) where they have been able to open up about the trauma they have experienced in the past and their fears about the future. In most cases, we were able to go on to identify services that have helped them move forward and some have gone on to be matched with befrienders or linked with other community groups and included in wellbeing days.

By expanding our advocacy service, our coordinator has supported:

- three young people to successfully get their true age back, and is in the process of supporting another young man
- four homeless young people to get accommodation and three to be moved to more suitable accommodation
- six young people with their education and employment (help with applying to college, understanding full range of options, writing CVs, supplying additional learning materials, assisting in search for jobs and assisting with job and work experience applications)
- three young people to get specialist help in respect of their mental health
- six young people to progress immigration claims where solicitors had left or failed to stay within reasonable timescales
- two separated brothers to be reunited and to spend Christmas together
- eight young people to integrate with other community groups
- four young people to actively engage in volunteering
- informed and enabled three young people to get their benefit entitlements
- five young people to develop their talents (art, music and sport)

“Hello, I’m Ramar”

Last year during the last few months of lockdown Birch received a message from an unknown person just saying ‘Hello. I’m Ramar’ It is not unusual to receive similar messages and when we respond, we often find someone desperately trying to reach out for support. This was certainly the case for Ramar!

Several messages later and with the help of Google translate we learnt that in his mid teens Ramar had fled war and embarked on a long, very dangerous journey where he had been exploited and left with many physical and mental scars. The final part of his journey involved battling in freezing conditions across the English Channel and then being confronted by Immigration Officials who dismissed a very important part of Ramar’s identity, his age.

Having been deprived of a normal childhood, it soon dawned on Ramar that after arriving on British soil, further years were swiftly snatched from him when he was given a random year of birth several years older than his seventeen years. As a result, he was housed in adult initial accommodation with no support. Traumatized and desperately sad, he spent day after day alone in his room, he eventually got hold of details of a number of charities and sent out messages with the few English words that he knew ... ‘Hello, I’m Ramar’.

After a few failed attempts to meet up, Ramar eventually found the courage to come out of his initial accommodation and meet up with me. Over the months, trust has built up and together we have identified support to meet his outstanding needs. This includes medical help, enrolment on college courses, clothes, a good solicitor who is now fighting to get his true age reinstated and most importantly care and emotional support.

As Ramar has grown in confidence we have been able to introduce him to other young people like himself and he has enjoyed playing games, sharing food and chatting with them. He also has now been matched with family befrienders and gets on well with all members of the family, enjoying days out with them, games, walks and lots of opportunities to learn English and feel welcome and valued.

The process of challenging unlawful age assessments is unfortunately often long and drawn out but we all believe that it is well worth fighting for and in the meantime Birch and our dedicated volunteers are trying to give Ramar some of the support that he has been denied. Recently he looks so much happier.

FAMILY FUN SESSIONS

At the start of April 2021 our family fun sessions were still very restricted by the pandemic. During April, Steph, one of the coordinators, was still running Zoom sessions with some of the families we had contact with, which included making chocolate crispy cakes - there were some smiling faces at this session! We also continued to deliver activity packs to families who were living in hotels, as and when we were able to get information about who was staying there.

We were really concerned about how isolated the families were, stuck in hotels with no outside space, so as soon as restrictions on meeting outdoors lifted we decided to run the sessions outside and our first Picnic and Play sessions started in May 2021. The first session was a success and two mums and four children from the hotel came to the park which was within walking distance of their hotel and immediately invited another mum. The families were so thrilled to be in the outside space and we were able to show them local parks which they could access for free and they soon started walking to the parks daily to give everyone some fresh air and enjoy the green spaces and playgrounds.

We continued to run the Picnic and Play sessions until August and also managed to run some day trips with the families. In July we took several families to Martineau gardens, a local community garden, and they had a great time playing in the sand pit, exploring the woods and generally running around in a beautiful green space. In August, we took some families and young refugees (9 adults and 16 children) on a farm visit and treated them to a delicious Kurdish cooked meal.

The families were so grateful to be able to explore local outside spaces after being trapped all together in one room for so many months!

In September we restarted the Family Fun Sessions back in Christ Church hall in Selly Park and were happy to be able to offer a wide range of activities and play opportunities for the children, as well as a relaxing and welcoming space for the parents.

Between April 2021 and March 2022, we were visited by 322 visitors to either our Picnic and Play or Family Fun sessions, this included 27 families (35 adults and 62 children).

Historically we have only worked with families to our sessions for a very short period of time as they were only housed in hotels for six weeks. Now, with backlogs in the asylum support system and a lack of move on accommodation, many families are stuck in the hotels for much longer periods, often for over six months. In response to this, our team has increased the amount of advocacy support they provide to the families. A lot of this work involves helping the children to apply for school places. We are very fortunate to have a growing number of schools of sanctuary in Birmingham and we have developed good relationships with several local schools (some are schools of sanctuary), which has resulted in us finding school and nursery places for 25 children.

We also helped all of these children source school clothes and referred a further 19 individuals to St Chads Sanctuary for clothes and essential hygiene products. Many children were assisted with initial travel costs until these came through from the council and our staff helped the children to get to school for their first days, when it was not a very local school (mostly secondary schools). We have also been working with the schools and Asylum Matters to try to raise concerns about the condition of the hotel accommodation - many families have reported bed bugs and there are numerous complaints about the inadequacy of the food provided.

35 individuals were also offered additional advocacy support which ranged from helping register with dentists, getting HC1 forms, information sharing, signposting and liaison with other professionals.

In July 2021 following discussions with our staff about the needs of residents in some of the hotels in Birmingham, Refugee Support Europe have once a month started attending the hotel which accommodates most of the families to provide clothes, provisions and fresh fruit to the residents. This has had a really positive impact on the residents.

OUTREACH ACTIVITIES

From July 2021 the use of hotels in the West Midlands to accommodate asylum seekers expanded significantly, and delays in processing asylum support claims meant that many asylum seekers are forced to live in the hotels for longer and longer periods. Birmingham currently houses over 1000 asylum seekers in hotels.

Our staff were increasingly concerned for the single adults in the hotels, who have very little financial support (approx £8 a week to live on) and were suffering because of how isolated and bored they felt. We were also coming across young people in hotels who had not been correctly age assessed and were therefore not getting the support they needed. Additionally we also came across some individuals who were not getting any support. Our staff and some volunteers started reaching out more to the residents in these hotels to try to offer some support and link with various agencies local to them. In May 2022 we were able to start a new project aimed specifically at single adult asylum seekers living in hotels, following a very generous community donation. This project has developed extremely well and we are now offering volunteer run English conversation classes in two hotels, a sewing machine share scheme, one-to-one support for a number of extremely vulnerable individuals, as well as escorting over 30 individuals to various community events. We hope to be able to expand and build on this work.

Prior to starting the new project we were able to offer some outreach activities via our existing staff, volunteers and trustees. This included days trips to local farms, visits to trampoline parks, attending football matches of local teams. We were also able to run a 4 week coaching session for 25 men living in a hotel in Castle Bromwich. More recently we have been supporting a group of men to train and run in their local park runs, and are fortunate to have partnered with Coopah Running, which is a digital running coach scheme.

Objectives and Activities

Objectives as set out in the constitution:

The relief of financial hardship amongst those seeking asylum in the United Kingdom or who are refugees, and who reside in the West Midlands.

To preserve and protect the physical and mental health of those awaiting and those granted refugee status and their dependents.

Activities:

- Community hosting network for destitute refugees and migrants

- Outreach support to newly arrived asylum seekers living in hotel accommodation

Trustee's Responsibilities in Relation to the Financial Statements.

The charity trustees are responsible for preparing an annual report and financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice). The law applicable to charities in England and Wales requires the charity trustees to prepare financial statements for each year which give a true and fair view of the state of affairs and of the incoming resources and application of resources of the charity for that period. The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy ~~any~~ any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities Act 1993, the charity (Accounts and Reports) Regulations 2008 and the provisions of the trust deed. They are also responsible for safeguarding the assets of the charity and hence taking reasonable steps for the prevention and detection of fraud and other irregularities.

Summary of main achievements

This year was a busy year, following the pandemic, with many projects finally being able to restart properly. Our hosting project slowly opened and whilst referrals were slow initially, the project soon started hosting destitute migrants and our coordinator was able to recruit some fantastic new volunteers. We also started some new relationships with referral agencies and have been happy to work with Women's Aid South Birmingham to help some of their domestic violence survivors.

Our family befriending project was also very busy and our coordinator has been engaged in more one to one advocacy and support, as well as linking isolation young refugees with welcoming volunteers in Birmingham and the West Midlands. We have also been able to offer more day trips and well-being activities.

The family fun sessions really picked up in the Autumn, following a summer of picnic and play sessions. We started seeing families coming on a longer-term basis and as such, have

been more involved in helping asylum seeking children find school places. We have also offered increased advocacy support and were able to start English Conversation Classes.

Following the increase of the use of hotel accommodation and the number of asylum seekers being accommodated in them in Birmingham and across the West Midlands. We were keen to develop more outreach work to offer more support to these residents. Our staff were conscious that we were not able to offer as much support to adults single men. Fortunately, following a large unrestricted donation, we will advertise and recruit for a new outreach worker in the following financial year.

The recruitment of our new Development Worker in October 2022 was in response to the need for more fundraising work and a clearer fundraising strategy, as well as improved staff support and liaison between staff and trustees. Our new worker has already secured some strong funding, as reflected in our [accounts](#) and enabled us to build up our reserves. We hope to be able to continue this position into the next financial year.

Structure Governance and Management

Nature of Governing document

The charity is operated under the rules of its constitution adopted on 5th Feb 2013.

Financial Review

Birmingham Community Hosting (BIRCH) Network has a generous pool of local and regional charitable trusts and funders, as well as support from the National Lottery and good support from individual, and community funders. BIRCH raised £34,450.00 from charitable trusts and foundations and £15,687.74 from community donations, we raised £873.59 in sales from our first Christmas shop. We also received £4,528.53 towards staff salaries under the Government's furlough scheme. £37,978.53 was restricted funding for specific projects, and £17,561.33 was unrestricted community donations, most of which went into our reserves or was designated for the new outreach project for the following financial year. We also received £1,215.00 payment for an young refugee who didn't have a bank account and this sum was paid back to him.

At the end of the financial year, we had a surplus of £46368. Out of these funds £14848 was designated to reserves (accounting for three months of operating costs), £9,700 was designated to cover the costs of starting the new outreach project and £22184 was carried forward and designated to the projects that the funding was restricted to.

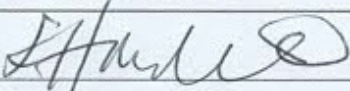
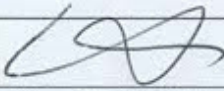

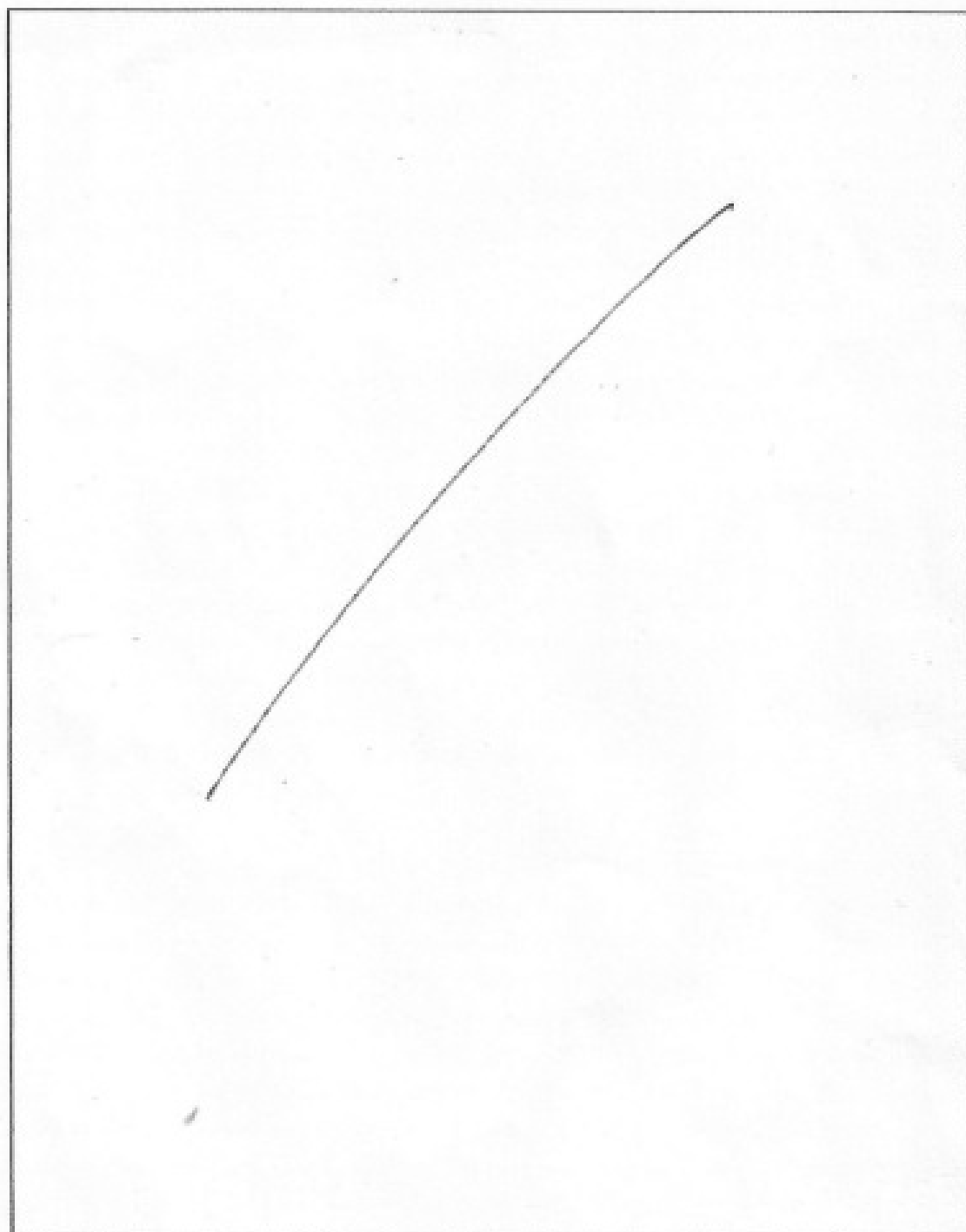
