TO PROVIDE, MAINTAIN AND MANAGE AFFORDABLE HOUSING FOR THE RELIEF OF THOSE IN NEED, BY REASON OF YOUTH, AGE, ILL-HEALTH, DISABILITY, FINANCIAL HARDSHIP OR OTHER DISADVANTAGE; AND D. THE PROMOTION OF THE EFFICIENCY AND EFFECTIVENESS OF CHARITIES FOR THE PUBLIC BENEFIT, IN PARTICULAR BUT NOT EXCLUSIVELY BY ADVISING AND ASSISTING OTHER CHARITIES ON ISSUES RELATING TO PROPERTY, PURCHASE, LEASE, MAINTENANCE AND MANAGEMENT.

Activities: The relief of poverty by: a. Providing direct and indirect support and assistance, predominantly by the creation, purchase and/or lease and/or maintenance of the buildings, infrastructure and/or other assets b. Through the provision of support, assistance and information directly and indirectly to people deemed to be in need.
