Charity's objects

The objects of the charity are to advance, promote or carry out such charitable purposes as the trustees in their absolute discretion from time to time think fit. The charity will have a particular emphasis on the advancement of education and health.

Structure, Governance and Management

The Charity is governed by its trust deed dated 14 March 2013 as amended by deed dated 16 December 2013.

The trustees that held office during the year are listed above.

New trustees are appointed by the board of trustees and are given an induction pack which includes the trust deed and guidelines on how to perform their duties as a trustee. Additional training is given as and when necessary.

Activities and Achievements

The charity was first registered on 21 May 2013.

During the period, the charity received no donations but made a number of donations to various charitable projects totalling £23,000.

The trustees have had regard to guidance published by the Charity Commission on public benefit.

Financial review

The Charity made a surplus of £838 in the year ended 5 April 2022, meaning year end reserves are £190,280. The principal funding source is receipts from non-monetary investments and dividends.

Policies

Reserves

It is the policy of the trustees to maintain reserves in the Charity at a level to enable it to be administered efficiently, to meet its short term expenditure requirements and to have adequate resources to fund its charitable objectives. Current year end reserves are £190,280.

The Charity's cash reserves are held in an account with NatWest Bank Plc, and in accounts managed as part of the Charity's investment portfolio by Veritas Investment Management,

The Charity's investments are held in a portfolio managed by Veritas Investment Management.

STATEMENT OF TRUSTEES' RESPONSIBILITIES

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF THE AB DAVID CHARITY

I report to the trustees on my examination of the financial statements of The AB David Charity ('the charity') for the year ended 5 April 2022 which comprise the Statement of Financial Activities and the Balance Sheet.

This report is made solely to the charity's trustees, as a body, in accordance with section 145 of the Charities Act 2011. My work has been undertaken so that I might state to the charity's trustees those matters I am required to state to them in this report and for no other purpose. To the fullest extent permitted by law, I do not accept or assume responsibility to anyone other than the charity and the charity's trustees as a body, for my work, for this report, or for the opinions I have formed.

Responsibilities and basis of report

As the trustees of charitable company you are responsible for the preparation of the financial statements in accordance with the requirements of the Companies Act 2011 ('the Act').

Having satisfied myself that the financial statements of the charitable company are not required to be audited under Part 16 of the Act and are eligible for independent examination, I report in respect of my examination of the charitable company's financial statements carried out under section 145 of the Charities Act 2011 ('the 2011 Act') and in carrying out my examination I have followed all the applicable Directions given by the Charity Commission under section 145(5)(b) of the 2011 Act.

An independent examination does not involve gathering all the evidence that would be required in an audit and consequently does not cover all the matters that an auditor considers in giving their opinion on the financial statements. The planning and conduct of an audit goes beyond the limited assurance that an independent examination can provide. Consequently I express no opinion as to whether the financial statements present a 'true and fair' view and my report is limited to those specific matters set out in the independent examiner's statement.
