Organisational structure and management

The Al Salam Trust, previously known as the Al Salam Foundation, operated as a Charitable Incorporated Organisation (CIO), registered on 22nd May 2013 with the Charity Commission. The organisation is governed by the Trustees, who determine strategic direction and policy. The day to day operation is also carried out by the Trustees.

Appointment of trustees

The Trustees are appointed under the rules of the constitution. There must be a minimum of six and a maximum of nine Trustees. The current Trustees were appointed at the inauguration meeting.

Risk Management

The trustees have a duty to identify and review the risks to which the Charity is exposed to and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

Objectives and activities

The Charity's objects, as set out in its governing document, are;

- To establish an Islamic educational centre
- To cater for the religious, cultural, educational and social needs of Rotherham's Arabic speaking communities primarily but not exclusively
- To promote better community relations for the good of society
- To work towards the relief of poverty

Main activities and Public benefit

In planning the activities during the year the Trustees have considered the Charity Commissions Guidance on public benefit. The Trustees have ensured that the organisation has worked to forward it's aims and objectives.

1. Mosque and Community Facilities

Commitment to Smooth and Reliable Operations

The Trustees continue to work diligently to ensure the day to day running of Masjid Al Salam remains efficient, organised, and responsive to community needs. Systems are regularly reviewed to maintain consistent access to the mosque for all worshippers, including during peak times, special events, and out of hours prayers.

Health, Safety, and Compliance

Ongoing attention is given to maintaining a safe environment across all areas of the mosque, including prayer halls, ablution facilities, entrances, and community spaces. Regular inspections, risk assessments, and maintenance checks are carried out to ensure compliance with legal standards and best practice. Emergency procedures, signage, and equipment are kept up to date to protect all users of the building.

Supporting a Peaceful Worship Experience

The Trustees prioritise creating an atmosphere where the congregation can pray with tranquillity and peace of mind. Cleanliness, organisation, and respectful conduct are actively promoted to uphold the sanctity of the prayer space.

Enhancing Community Access and Inclusion

The mosque remains open and accessible to all members of the community, with particular attention to families, elders, and individuals with additional needs. Improvements to facilities are planned and implemented with the aim of increasing comfort,

2. Imam and Spiritual Guidance

Friday Sermons (Khutbah)

- The Imam continues to deliver weekly Friday sermons that address the spiritual, social, and moral needs of the congregation. Sermons (Khutbas) are carefully prepared to provide relevant guidance rooted in Qur'an and Sunnah, while also responding to contemporary challenges faced by the community. The khutbahs aim to uplift, educate, and inspire worshippers, strengthening their connection to Allah and encouraging positive action within the community.

Study Circles and Group Learning

- Regular study circles are held to deepen the community's understanding of Islamic teachings, covering topics such as Qur'anic tafsir, hadith, fiqh, and spiritual development. These sessions create a welcoming environment for learning, reflection, and open discussion, allowing attendees to ask questions and seek clarity on religious matters.

Support and Individual Guidance

- The Imam remains available to provide personal advice, spiritual counselling, and support for individuals and families facing challenges. This may include guidance on marriage, bereavement, personal struggles, and religious queries, offered with confidentiality and compassion. The mosque continues to prioritise a supportive environment where community members feel comfortable seeking help and spiritual direction.

3. Ramadan: The Holy Month

A Blessed and Intensely Active Period

Ramadan remains the busiest and most spiritually uplifting time of the year at Masjid Al Salam. The Trustees, volunteers, and Imam work together to ensure the mosque operates smoothly throughout the month, accommodating the significant increase in attendance and activities. Additional arrangements are put in place to manage footfall, maintain cleanliness, and support worshippers during extended hours.

Taraweeh Prayers

Taraweeh prayers continue to be a central feature of Ramadan at the mosque, drawing large congregations every night. The prayers are led with clarity, devotion, and a focus on completing the recitation of the Qur'an in a manner that is accessible and spiritually enriching for all attendees.

Enhanced Facilities and Extended Access

- Opening hours are extended to accommodate night prayers, qiyam, and increased use of the mosque for Qur'an recitation and reflection.
- Additional cleaning schedules, safety checks, and facility management measures are implemented to maintain comfort and safety during peak times.

4. Eid Prayers (Eid al Fitr and Eid al Adha)

Large Community Gatherings

Eid al Fitr and Eid al Adha continue to be the most significant communal celebrations at Masjid Al Salam, drawing large numbers of worshippers from across the local area. The Trustees, Imam, and volunteers work together to ensure that all arrangements are in place for a smooth, safe, and spiritually uplifting experience. Additional measures are implemented to ensure safety, including designated areas for families, elders, and individuals with additional needs. Eid prayers are followed by moments of community connection, greetings, and celebration, reflecting the unity and joy of the occasion.

5. Madrassah for Young Children

Foundational Islamic Education

The Madrassah at Masjid Al Salam continues to provide a strong foundation in Islamic learning for young children, nurturing both their knowledge and character. Lessons are designed to support gradual, age appropriate development, ensuring every child progresses with confidence and understanding.

Reading and Writing Arabic

Children are taught to recognise, read, and write the Arabic alphabet, progressing to words and sentences as their skills develop. Lessons focus on correct pronunciation, handwriting, and familiarity with essential vocabulary, forming the basis for Qur'anic reading.

Qur'an Recitation and Tajweed

A core element of the Madrassah is helping students recite the Qur'an accurately and fluently. Teachers introduce the rules of tajweed in a simple and accessible way, enabling children to develop correct recitation habits from an early age.

Memorisation (Hifz)

Children are encouraged to memorise selected surahs and duas, beginning with shorter chapters and gradually building their memorisation skills. Emphasis is placed on understanding, consistency, and revision to ensure strong retention and confidence.

Learning Daily Prayers and Islamic Manners

Students also learn how to perform salah correctly, including the actions, recitations, and etiquettes of prayer. Lessons also cover essential Islamic manners, values, and character development, helping children embody good behaviour at home, school, and in the community. The Madrassah maintains a welcoming, structured, and safe environment where children feel encouraged and supported.

Positive Impact of Moral Behaviour on the Wider Community

- The Madrassah places strong emphasis on Islamic manners, respect, honesty, and responsibility, helping children develop good character alongside their academic learning. These values extend beyond the classroom and prayer hall, influencing how young people interact at home, in school, and within the wider community. By nurturing qualities such as kindness, patience, humility, and consideration for others, the mosque contributes to shaping a generation that is confident, respectful, and socially responsible. The positive behaviour modelled by students often encourages their peers and families to adopt similar values, creating a ripple effect that strengthens community cohesion. This focus on moral development helps build a safer, more compassionate local environment, reflecting the true spirit of Islam and enhancing the reputation of the Muslim community as a whole.

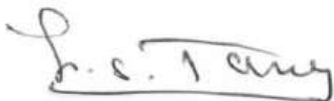

Main activities and Public benefit

In planning the activities during the year the Trustees have considered the Charity Commissions Guidance on public benefit. The Trustees have ensured that the organisation has worked to forward it's aims and objectives.

Mosque and Community Facility

Masjid Al-Salam provides a welcoming, spiritual environment where Muslims can worship five times a day and provides an important community facility that assists with building the self-confidence of Rotherham's Muslims around their faith. Both men and women pray with peace of mind and a sense of belonging.

Spiritual Guidance

The Imam has always been available to answer questions around religious and ethical issues and he is always accessible and prepared to answer questions in relation to the Muslim faith. The Imam and young scholars also organise timely study circles in the Masjid around various topics of interest including the teachings of the Quran and the Sunnah. Over the past year, the Masjid, through its Imam and young scholars has offered online guidance and teachings available via YouTube.

Ramadan

The Trust ensured that the Masjid was ready and equipped to deal with the extra attendances during the Holy month of Ramadhan, in doing so ensuring the safety and well-being of everyone during both standard prayers and Tarawih prayers. As always, food and drink were made available via the community and Islamic education circles followed by Tahajud prayers were offered throughout the latter part of the night.

Eid Prayers

Eid Al-Fitr and Eid Al-Adha are two main celebrated holidays in the Islamic year. The first celebrates the end of the Holy month of Ramadhan and the latter celebrates the performance of pilgrimage (Hajj). Both occasions are well attended by Muslims of all age groups. Due to the large number of worshippers, prayers are performed in open space. Food and drinks are prepared in advance by members of the community and administered through volunteers in celebration after each Eid prayer.

Friday Prayers and Sermons

Friday (Jumu'ah) prayer is attended by hundreds of worshippers from all parts of Rotherham and is the main platform for delivering the important weekly sermon that we feel is of great importance as it mainly focuses on social issues affecting our communities.

Madrassah

Establishing a Madrassah has been integral to the Mosque's mission. The Masjid continues to deliver Islamic educational classes for children at various times throughout the week. These classes are important to not only teach the Quran, but to explain the ethics and manners of Islam, i.e., one's duty towards their parents, relatives, community and society as a whole.

Volunteering

Volunteering is a valuable resource to the Trust. We value the contributions and important roles of both the male and female volunteers and their ongoing support. The Trust benefits greatly from volunteers who have different skills to offer, such as helping with fund-raising, organising activities, carrying out maintenance to the building and not to forget the members and trustees helping to drive the Trust and its work forward.

Funeral Prayers and Services

The Masjid is also a place where funeral prayers are performed and support is available to bereaved families whenever requested. The Masjid also provides a wash and preparation room for the deceased at no cost to the families.

- To cater for the religious, cultural, educational and social needs of Rotherham's Arabic speaking communities primarily but not exclusively
- To promote better community relations for the good of society
- To work towards the relief of poverty

Main activities and Public benefit

In planning the activities during the year the Trustees have considered the Charity Commissions Guidance on public benefit. The Trustees have ensured that the organisation has worked to forward it's aims and objectives.

Message of thanks

It has been a challenging year for everyone and for many reasons, particularly the cessation or changing of prayer services to ensure that our community was safe, as well as new services we had to introduce to temporarily replace old practices. We would like to take this opportunity to relay our gratitude to our congregation, community and volunteers for their continuous understanding, patience and support during the 2020-21 financial year.

Covid 19 Effort

To support the Covid effort, we participated in local media publications to encourage the uptake of the Covid 19 vaccinations by the Muslim community and worked closely together to ensure that Covid 19 guidelines were adhered to once lockdown was eased. This included: Adequate signposting, provision of hand sanitisers, ensuring social distancing was maintained, provision of masks and prayer sheets, keeping the premises well ventilated, closure of ablution areas and toilets and reiterating the importance of adhering to the Masjid's Covid rules and regulations at each Friday Prayer and through timely text messages. We also worked closely with officials to get clear messaging out to the community and moved our Islamic education services online to ensure that users continued to have access to Islamic education.

Ramadan

After missing out on the blessing of last year's congregational prayers for the holy month of Ramadhan, it was such a relief to hear in March, that we would be allowed to open the Masjid for congregational prayer including the Tarawih prayers and Eid Celebrations. However, the Trust ensured that stringent practices were in place to ensure the overall safety of worshippers.

The downstairs conversion to an addition prayer room was completed in May 2001 and was a much-needed space particularly through the holy month of Ramadhan and Friday Prayers. The wash room was also completed at the same time with only few final touches remaining. The above projects would not have been possible without the generosity and hard work of the congregation and community.

Impact of Covid 19

Due to efforts and restrictions that have been put in place to ensure the safety of the general public, it has been extremely difficult for us to plan ahead with new services and events other than the ones mentioned above. It has also been a difficult year financially, as the Covid pandemic has hit many people hard, and our congregation and community are no exception. We hope that the coming year will be more productive and prosperous for everyone.

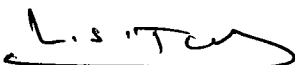

1 Accounting policies

1.1 Basis of preparation

These financial statements have been prepared under the historical cost basis and in accordance with the Charities Act 2011 and related Regulations.

As the charity's level of income is below £250,000 the management Trustees have opted for the accounts to be prepared in a receipts and payment basis. This is in accordance with the Charity Commission guidelines for small charities and is seen as more appropriate for this project.

1.2 Fund Accounting

Incoming resources that may be applied for the charities general purposes are treated as unrestricted incoming resources and are credited to the unrestricted fund.

2 Tangible fixed assets

The freehold building is stated at the insured valuation of the building including its fixtures and fittings. No depreciation has been applied as the trustees consider that this is a fair reflection of the value of the building.
