**Structure, Governance and Management:**

Christ Followers International Church is governed by a trust deed dated 01/01/2012. It was registered as a charity on 18/07/2013 and the charity number is 1152956.

Recruitment and appointment of new trustees would be in line with the trust deed and with the consent of the trustees. The criteria set for the suitable candidate would be someone who is sensitive to the needs and demands of the organisation.

**Risk Review:**

The trustees have assessed the risks to which the charity is exposed, in particular those related to the operations and finances of the trust, and are satisfied those systems are in place to manage this.

The objects of the charity are:

1. The advancement of the Christian faith worldwide.
2. The relief of poverty.
