TO ESTABLISH, OR SECURE THE ESTABLISHMENT OF THE PROVISION, MAINTENANCE OR IMPROVEMENT OF WONDERLAND PARK;4. TO PROMOTE SUCH OTHER CHARITABLE PURPOSES AS MAY FROM TIME TO TIME BE DETERMINED.
