Structure, governance and management

In July 1909, a son was born into the Akindayomi family of Ondo State of Nigeria. Even though this child grew up surrounded by idol worshippers, he knew there existed a greater power and yearned to know, "The God who created the earth and everyone on it". This pursuit for God led him to the Church Missionary Society where he was baptized in 1927. Still spiritually unfulfilled, he joined the Cherubim and Seraphim church in 1931. Whilst there, he began to hear a voice within him saying, "You will be my servant." Since this was not his intention, he decided to ignore the voice. This went on for seven years during which all the business ventures that he tried resulted into failure. In debt and without peace of mind, he found himself totally dependent on the grace of God. Here marked the beginning of a definite relationship with God. Totally broken, he yielded saying, "Lord, I will go wherever you want me to go." He asked for signs to confirm that this was indeed God's call. The confirmation came through the Bible passages of Jeremiah 1:4-10, Isaiah 41:10-13 and Romans 8:29-31. The Lord assured him that He would provide for all his needs, as he would not receive any salary from that point on. This proved to be a comforting reminder during the trials in the months ahead. He became married in 1941. He continued to worship with the Cherubim and Seraphim. In 1947, he started to become concerned that the church was departing from the true Word of God in some of its practices. By 1952, he felt totally persuaded to leave the Church. He started at Willoughby Street, Ebute-Metta, Lagos a house fellowship called, the Glory of God Fellowship. Initially there were nine members but before long the fellowship rapidly grew as the news of the miracles that occurred in their midst spread.

Pa Akindayomi also had a vision of words that appeared to be written on a blackboard. The words were "The Redeemed Christian Church of God." Amazingly, Pa Akindayomi who could not read or write was supernaturally able to write these words down. In this visitation, God also said to him that this church would go to the ends of the earth and that when the Lord Jesus Christ appeared in glory, He would meet the Church. The Lord then established a covenant with Pa Akindayomi, synonymous to the Abrahamic covenant in the Bible. He said that He the Lord would meet all the needs of the Church in an awesome way if only members would serve Him faithfully and be obedient to His Word. It is upon this covenant that the Redeemed Christian Church of God was built.

Objectives and aims

THE REDEEMED CHRISTIAN CHURCH OF GOD, TESTIMONY CHAPEL @ WEST BROMWICH, BIRMINGHAM is one of the over 950 Parishes of this Mission in the United Kingdom, it is an arm of THE REDEEMED CHRISTIAN CHURCH OF GOD (RCCG) CENTRAL OFFICE, United Kingdom.

THE REDEEMED CHRISTIAN CHURCH OF GOD, TESTIMONY CHAPEL @ WEST BROMWICH which was established on 10th June 2007 from the then Area Headquarters under Pastor Joshua Alake who is now a Provincial Pastor had its first place of worship on High Street, West Bromwich with 10 members. Pastor Adejimi Akintola Lawal is the founding Pastor of the Parish and is still the Pastor to date. This Parish is a Registered Charity with Trustees, and the Parish Pastor is the Secretary to the Church Trustees. The Trustees members are the main decision-making persons for the day to day running of this Parish.

This Parish has had its ups and downs but to God be the glory for His faithfulness as we are still marching forward despite the challenges.

OUR PRIORITIES:

1. We desire to worship God in Spirit and in truth in our private and public worship. The Lord ONLY shall be the object of our worship. We seek to hear from God and also desire the presence of His glory in our gatherings - I Kings 8:11; I Chronicles 16:29; Psalm 96:6; John 4:23-24; Revelation 22:9. 2. We desire to live holy and sanctified life such that at any time we are able to hear from God directly and receive His blessings - Psalm 16:1-2; Leviticus 11:45; I Corinthians 1:30; II Corinthians 7:1; I Thessalonians 4:3; Hebrews 12:4. 3. We desire to be led all the times by the Spirit of God such that we are able to do only His will - Romans 8:14-18; 12:1-2; Ephesians 5:17; 6:6.

4. We want to teach and learn the Word of God in the power and anointing of the Holy Spirit for edification, refreshing, encouragement and comfort - Isaiah 2:3; Matthew 28:19-20; Romans 15:4; I Timothy 4:13; II Timothy 2:2. 5. We want to build a Church of God with our spiritual gifts as the Lord gives opportunity for the advancement of the kingdom of God and the spiritual growth of members - Romans 13:3-8; I Corinthians 3:6-9; 12:7; Ephesians 4:11-12. 6. We also want to build a Church where blessings and burdens are shared for the glory of God through interpersonal ministry and service that will enhance spiritual and social enrichment of individual members - Colossians 3:16; John 4:36; 13:13-15, 17; Galatians 6:9-10; Ephesians 4:29; Hebrews 13:16.

We have had our permanent place of worship (on Lease) at 151 Hilltop, Wednesbury Road, B70 0SB, West Bromwich - a place we opened by faith, and we have expended resources both human and financial. However, a notice of vacating the place was served to us by our Landlord - The Church of England and we eventually left on 30th September 2023 for a new place of Worship cited at ASDEN HOUSE, 1-5 Victoria Street, B70 8ET, West Bromwich, Birmingham. We have expended so much in this new place of worship such as: 1. Construction of both male and female toilets. 2. Partitioning to created layout and spaces for our numerous activities of worship. 3. Continuous repairs and amendments to suite our purposes

FUTURE PLANS:

In conformity of the vision of our General Overseer - Pastor Enoch Adejare Adeboye, we want to have a touch on our community and take every family therein and beyond for Christ in obeisance to God's command that we should go to all parts of the world, preaching the gospel - John 16:16. In the light of this, this Parish has planted TWO new Parishes since inception. These Parishes are: (i) RCCG His Dwelling Place planted 13th May 2013 pastored by Pastor Emmanuel Folarin. (ii) RCCG The Kingdom Chapel planted 18th December 2016 pastored by Pastor Taiwo Buraimoh. (iii) WE PLAN TO PLANT ONE OR TWO PARISHES IN DUE COURSE AS THE LORD HELPS US.

MAJOR PROJECTS:

As mentioned above, we have moved to a new place of worship on a 5-Year Lease i. As usual, we have embarked on serious renovation of the new property to meet the needs of a Church, and this has cost us close to £60,000 and its still ongoing. ii. We have constructed brand new Toilets for both male and female and also made loads of internal partitioning to meet for our use. iii. Our Church has been granted Certificate to operate as a Place of Worship by Sandwell Borough Council on 5th March 2024. v. Our Parish has just joined Sandwell Faith Network to be involved in the betterment of our Church in particular and the Community in general. vi. We are now involved in periodic Food Bank, Health Talk and support for the less privileged in our environment. vii. We are proposing to replace our older Trustee members for new ones.

Notes to the Financial Statements

Year ended 31 March 2025

1. General information

The charity is a public benefit entity and a private company limited by guarantee, registered in England and Wales and a registered charity in England and Wales. The address of the registered office is 18 SHAPINSAY DRIVE, RUBERY-REDNAL, BIRMINGHAM, WEST MIDLANDS, B45 0HN, UNITED KINGDOM.

2. Statement of compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

3. Accounting policies

Basis of preparation

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

Going concern

There are no material uncertainties about the charity's ability to continue.

Fund accounting

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Designated funds are unrestricted funds earmarked by the trustees for particular future project or commitment.

Restricted funds are subjected to restrictions on their expenditure declared by the donor or through the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

Incoming resources

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- legacy income is recognised when receipt is probable and entitlement is established.
- income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities, events, non-charitable trading activities, and the sale of donated goods.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.
- other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

Tangible assets

Tangible assets are initially recorded at cost, and subsequently stated at cost less any accumulated depreciation and impairment losses. Any tangible assets carried at revalued amounts are recorded at the fair value at the date of revaluation less any subsequent accumulated depreciation and subsequent accumulated impairment losses.

Tangible assets *(continued)*

An increase in the carrying amount of an asset as a result of a revaluation, is recognised in other recognised gains and losses, unless it reverses a charge for impairment that has previously been recognised as expenditure within the statement of financial activities. A decrease in the carrying amount of an asset as a result of revaluation, is recognised in other recognised gains and losses, except to which it offsets any previous revaluation gain, in which case the loss is shown within other recognised gains and losses on the statement of financial activities.

Impairment of fixed assets

A review for indicators of impairment is carried out at each reporting date, with the recoverable amount being estimated where such indicators exist. Where the carrying value exceeds the recoverable amount, the asset is impaired accordingly. Prior impairments are also reviewed for possible reversal at each reporting date.

For the purposes of impairment testing, when it is not possible to estimate the recoverable amount of an individual asset, an estimate is made of the recoverable amount of the cash-generating unit to which the asset belongs. The cash-generating unit is the smallest identifiable group of assets that includes the asset and generates cash inflows that largely independent of the cash inflows from other assets or groups of assets.

For impairment testing of goodwill, the goodwill acquired in a business combination is, from the acquisition date, allocated to each of the cash-generating units that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the charity are assigned to those units.

Financial instruments

A financial asset or a financial liability is recognised only when the charity becomes a party to the contractual provisions of the instrument.

Basic financial instruments are initially recognised at the amount receivable or payable including any related transaction costs.

Current assets and current liabilities are subsequently measured at the cash or other consideration expected to be paid or received and not discounted.

Debt instruments are subsequently measured at amortised cost.

Where investments in shares are publicly traded or their fair value can otherwise be measured reliably, the investment is subsequently measured at fair value with changes in fair value recognised in income and expenditure. All other such investments are subsequently measured at cost less impairment.

Other financial instruments, including derivatives, are initially recognised at fair value, unless payment for an asset is deferred beyond normal business terms or financed at a rate of interest that is not a market rate, in which case the asset is measured at the present value of the future payments discounted at a market rate of interest for a similar debt instrument.

Other financial instruments are subsequently measured at fair value, with any changes recognised in the statement of financial activities, with the exception of hedging instruments in a designated hedging relationship.

Financial assets that are measured at cost or amortised cost are reviewed for objective evidence of impairment at the end of each reporting date. If there is objective evidence of impairment, an impairment loss is recognised under the appropriate heading in the statement of financial activities in which the initial gain was recognised.

For all equity instruments regardless of significance, and other financial assets that are individually significant, these are assessed individually for impairment. Other financial assets are either assessed individually or grouped on the basis of similar credit risk characteristics.

Any reversals of impairment are recognised immediately, to the extent that the reversal does not result in a carrying amount of the financial asset that exceeds what the carrying amount would have been had the impairment not previously been recognised.
