**Objects:** TO ACT AS A RESOURCE FOR UNDER-PRIVILEGED YOUNG PEOPLE LIVING IN INDIA BY PROVIDING ADVICE AND ASSISTANCE AND ORGANISING PROGRAMMES OF PHYSICAL, EDUCATIONAL AND OTHER ACTIVITIES AS A MEANS OF:(A) ADVANCING IN LIFE AND HELPING YOUNG PEOPLE BY DEVELOPING THEIR SKILLS, CAPACITIES AND CAPABILITIES TO ENABLE THEM TO PARTICIPATE IN SOCIETY AS INDEPENDENT, MATURE AND RESPONSIBLE INDIVIDUALS;(B) ADVANCING EDUCATION;(C) PROVIDING RECREATIONAL AND LEISURE TIME ACTIVITY IN THE INTERESTS OF SOCIAL WELFARE FOR PEOPLE LIVING IN THE AREA OF BENEFIT WHO HAVE NEED BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABILITY, POVERTY OR SOCIAL AND ECONOMIC CIRCUMSTANCES WITH A VIEW TO IMPROVING THE CONDITIONS OF LIFE OF SUCH PERSONS TO RELIEVE POVERTY AMONG CHILDREN AND YOUNG PEOPLE IN INDIA IN SUCH WAYS AS THE DIRECTORS THINK FIT.

**Activities:** The Trustees raised funds through a monthly donation program and application to charities like J Paul Getty Jr Charitable Trust. They evaluated and approved applications for funds made by Indian charities such as Dream A Dream India. ?95,000 was granted to Dream A Dream India to support their Life Skills & Career Connect programs for young people from vulnerable backgrounds in Bangalore, India.
