

CWFO gave some financial support to struggling teachers to rebuild their classes which have been seriously affected by Covid restrictions and the general publics reluctance to engage in full body contact activities.

CWFO would like to thank its long term donors who continued to support the charity during these difficult times.

Class numbers are now slowly rising again as public confidence builds and CWFO hopes to rebuild its participants in the coming years.

It seems unlikely that CWFO will be able to visit China next year but we hope to resume our full activities with China and have maintained our Chinese contacts.
