THE ADVANCEMENT OF EDUCATION OF YOUNG PEOPLE BY PROVIDING AND IN THE PROVISION OF FACILITIES FOR EDUCATION IN PARTICULAR BUT NOT EXCLUSIVELY AT THE PHAYA TAUNG MONASTERY AND ORPHANAGE.
