Chairs Report 2024/25

We have carried on as we left off last year, with a slight increase in footfall, and therefore increasing our profile within the local community. It is heartening to see the amount of people who stop and read our external event posters to check out what is going on.

The Gallery Team of Jenny and Liz have fully promoted the Gallery space, contacting local artists, with such a huge positive response, we are now fully booked until 2027! Some are artists wanting to return, as they love the space. Jenny has decorated the room and made new curtains to give it a lovely fresh feel.

Although the museum has been mainly closed whilst we review the new display case exhibits and milestones in Baldock's history to showcase, we have had an increasing footfall looking at the temporary displays. We currently have a *'Baldock during WW2'* exhibition, which is proving very popular, but our new layout and exhibits are coming on. We are aiming to open with more permanent displays within the next financial year. We have help and are collaborating with other North Herts Museums, too.

We have had a very successful drama production, a variety of music events and children's shows, as well as our NT Live, Cinema Live Musicals and Exhibition on Screen regular screenings in our Theatre Space. We still run our monthly cinema club, too. We are looking forward to more of the same this coming year.

The theatre space is also used by regular hirers, where we still try to hire under our agreed Arts & Heritage banner.

We have ongoing maintenance and refurbishment being carried out to keep the building fit for purpose. One of the theatre Green Room's is currently being reviewed. The dressing room space is to receive a facelift courtesy of Jenny and her husband Keith to provide artist preparation space and some storage.

The day to day running of the whole building, gallery opening times, event planning and management, booking enquiries, processes, policies, risk assessments and account management are all carried out by our wonderful team of volunteers. Without whom we would not be able to run the centre, so, as always, a huge thank you to all volunteers involved.

Chair's Report for year ended 31st May 2023

Chairs report 2023/2024

It has been a successful and enjoyable year at BAHC, with a variety of events, spanning arts and heritage, that have been well received by the local community.

Our gallery has gone from strength to strength. We have local artists lined up until the end of 2025, some of whom are artists who want to return for another session. The building has really benefitted from this popular gallery and we have had some lovely comments in our visitor's book. The room is transformed each time a new exhibition is hung and we therefore attract regular visitors.

The Theatre space is also used more and more for regular classes, from dance, to martial arts to yoga, with everyone enjoying the ambiance the space provides.

Since starting our NT Live screenings (in Jan 2023) these have picked up and have been joined by Cinema Live's musical series and Exhibition on Screen productions that focus on an artist, popular artistic themes or gallery. Our footfall has increased with these screenings as has our mailing list.

Our little Community Cinema Group is also popular once a month. We are now retaining our existing adult members, with new members joining. Unfortunately, the afternoon family matinee hasn't been so popular, so we'll consider if we keep this going next year. The new comfortable chairs purchased for the theatre have proven very popular, so a well worth investment last year.

Our History in the Afternoon talks are now so successful that it is becoming difficult to find enough subject matter and speakers for them, but we are sure this is something that we can overcome.

The museum, showcasing Kayser Bondor, was also very popular throughout this season. Many people visited and we also received very good feedback. However, being conscious of the space requiring a lot of work to make it a really popular local visitor attraction, we set about trying to obtain funding for new doors, levelling the floor and obtaining new exhibition display cases. This would also make the building brighter and more attractive externally.

Unfortunately our numerous funding attempts were not successful, therefore it was felt that perhaps we should complete what work we could to make the museum area a little more fit for purpose within our means. On making this decision the floor was levelled with new flooring throughout. The High Street side, where we hoped to place new doors was internally plaster boarded to make a complete wall (a disused external door covered) with two windows, as this would allow us to utilise this space for exhibitions. The room was decorated and new exhibition cases purchased.

Chair's Report for year ended 31st May 2022

I'm delighted to report that, although not quite as busy as pre Covid, we are nevertheless well on our way. Welcoming back our regular groups with no further disruption, the art group, along with ballet and yoga classes as regular weekly sessions.

We managed to get the new flooring in place in the theatre before we opened fully, and also invested in new blinds and theatre curtains, so a fresh new look for the space, which has received wide approval from all visitors to the centre.

We do admit that the Covid grants we received have helped keep us going during this difficult period and we would thank our treasurer, Ted, for all he does in applying for any additional funds.

Our museum project is still going ahead, but we are now looking at breaking this into two separate projects. One will cover the new doors which includes the restoration of the original arches and will be our new main entrance. The other will be a makeover of the museum space, with new boxed display cabinets.

With Ted's help we applied for new AV equipment for our film@bahc monthly screenings as in the coming year we intend to expand this and run a new members only community movie club, showing at least another two movies a month. Thanks go to Sally for her efforts with the film club. We would also thank Jean and her husband Jon for their sponsoring some of the equipment and assisting in setting everything up.

Jenny has taken over as Gallery Manager from Liz. We would like to thank Liz for her brilliant job in promoting the Gallery from concept and also for the assistance that she has given to Jenny. We have had some very successful art exhibits with these being well received by the local community. Jenny has taken on the position really well and had good artist support, too. We are booked up with local artists wanting to use the gallery for at least the next 12 months.

Jenny's husband, Keith, has also helped us out by completing some building maintenance. We had damp patches from a blocked rainwater down-pipe and had to have the affected walls treated in January and Keith very kindly assisted with the removal of radiators and painting afterwards. Keith has also built us a new cupboard at the back of the hall space for us to store the film nights AV equipment. Having the work carried out voluntarily has saved us on maintenance costs, so this is much appreciated.

The drama group managed to put on a Panto 'Jack and the Beanstalk', which was a sellout over a weekend in November. Liz, Maureen, Laura, Sally and Jenny worked very hard on the event, supported by various other drama group and BAHC volunteers, plus Ted on the sound and lights. A great all-round effort.

We were also able to support the Baldock Festival again as some of their events took place in our Theatre space. It was great to play a small part in another successful community event.

Our own monthly History in the Afternoon event has gone from strength to strength and is very well received. So much so that we have had to move to the theatre space

1. Accounting Policies

Basis of Accounting

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008) and the Statement of Recommended Practice on Accounting and Reporting by Charities issued in March 2005.

Turnover

The turnover shown in the profit and loss account represents amounts invoiced during the year, funding received from donations and subscriptions and income from various fund raising events during the year. It also includes Covid Grants of £ 22,834

In respect of long term contracts and contracts for ongoing services, turnover represents the value of work actually carried out in the year, including estimates of amounts not invoiced. Turnover in respect of long term contracts and contracts for ongoing services is recognised by reference to the stage of completion reached at the year end date.

Assets and Depreciation

Assets are depreciated on a straight line basis over 3 years.

Grants Received

All grants awarded for specific purposes are accounted for in the Balance Sheet. Other (general) grants and donations are treated as Income.

Financial Instruments

Financial instruments are classified and accounted for, according to the substance of the contractual arrangement, as either financial assets, financial liabilities or equity instruments. An equity instrument is any contract that evidences a residual interest in the assets of the Company after deducting all of its liabilities.

No charges for Directors' remuneration have been set in arriving at the operating profit.
