Report of the trustees for the year ended 5 April 2025

The Trustees present their report along with the financial statements of the Charity for the year ended 5 April 2025. The financial statements have been prepared in accordance with the accounting policies set out on pages 10 and 11 and comply with the Trust Deed and applicable law.

Structure, governance and management

Governing document

The Charity is an unincorporated trust constituted by a Deed of Trust dated 30 September 1978, most recently amended by Deed of Variation dated 10 January 2014. The Trust was registered with the Charity Commission for England and Wales on 17 January 2014 under Charity Registration Number: 1155382

Recruitment and appointment of new trustees

The names of the Trustees who served during the year and since the year end are set out on page 1. None of the Trustees, nor any person connected with them, received any remuneration or expenses from the Charity in the year ended 5 April 2025 (2024: £nil).

The Trust operates 3 Gospel halls and Trustees are chosen from among the regular congregation of the halls. New Trustees are nominated by the existing Trustees or by the congregation and must be appointed by unanimous resolution of the congregation. They are selected according to their skills and experience and are expected to use both in furthering the objects of the Charity. Checks are made to ensure the Trustees' eligibility to act and incoming Trustees are made aware of their responsibilities by the existing Trustees, who ensure that new Trustees read the Trust Deed and relevant Charity Commission guidance.

Wider network

The Trustees maintain informal links with similar charities with a view to pooling experience considered useful in pursuing the objects of the Charity.

Risk management

The Trustees have identified and reviewed the major risks to which the Charity is exposed and confirm that they have established systems or procedures to manage and mitigate those risks.

Objectives and activities

Objectives and aims

The charitable purposes of the Charity are the advancement of the Christian religion for the public benefit, including by the carrying on of the service of God in accordance with the Old and New Testaments of the Holy Bible as followed by those Christians forming part of the world-wide fellowship known as the Plymouth Brethren Christian Church (the "Brethren") and any other charitable purposes connected with Brethren. The core doctrine of the Brethren and proper practices in furtherance of certain aspects of doctrine are summarised in two schedules to the Trust Deed.

Public benefit

The Trustees confirm that they have complied with their duty under section 4 of the Charities Act 2011 to have due regard to the Charity Commission's general guidance to charities on public benefit.

Main activities and achievements

Preston Down Trust

Report of the trustees for the year ended 5 April 2025

The Trust provides and maintains 3 Gospel halls where religious meetings are held by the local Brethren community. Details of the origins, teachings and way of life of the Brethren can be found on the website - www.plymouthbrethrenchristianchurch.org and in the schedules to the Trust Deed.

The Trust's main achievements this year have been to maintain its income at a sufficient level to meet its obligations and encouraging members of the Congregation to support the Rapid Relief Team charity (Registered Charity No:1161586) in providing food boxes for families suffering extreme financial hardship

Plans for Future Periods

Despite the increased cost of energy, the trustees feel that these increased costs are not significantly impacting on the ability of the charity to continue as a going concern

Meetings

Meetings held at the Gospel halls include the Lord's Supper (Communion), Gospel preachings, Bible readings and Bible addresses. There is a structured weekly schedule of meetings and, depending on the particular meeting, between 30 and 300 people normally attend these occasions.

The meetings are attended by the regular congregation and most are open to other properly disposed visitors. The notice board outside the Hall welcomes visitors and displays the times of Gospel preachings, along with a telephone number for those seeking further information or help. Gospel tracts, which are distributed by street preachers, also display this information.

Bibles and an extensive range of other Christian reading material are on display at the halls and visitors are free to help themselves.

Spreading the Gospel message and the life of a Christian

The Gospel halls are a base from which the regular congregation and others who attend the meetings are encouraged to spread the Christian Gospel, in word and deed.

Members of the congregation participate in a programme of street preaching and Gospel tracts are provided free of charge by the Charity to such preachers to be handed out to interested members of the public.

In addition to street preaching, members of the congregation also keep in touch with prison chaplains to provide gospel tracts and bibles as required. The trust operates a programme of providing regular packs of food and gospel literature to homeless and needy persons through local charities or hostels for the homeless.

In carrying out this work, the congregation considers itself to be living out its faith in practice, as particularly exemplified in the following extract from the schedule to the Trust Deed on living a Christian life:

- We seek and are encouraged to live exemplary lives in all our relationships with others in the wider community (including former Brethren), in accordance with the teachings of Holy Scripture (1 Tim 2:2).
- We regularly go out from our homes to preach on the streets, to distribute Christian literature and engage with the wider community (including former Brethren) in order to present eternal salvation, available to all men by faith in Jesus Christ. (2 Tim 4:2).
- We seek as members of the public to lead Christian lives as husbands and wives, parents, children, employers, employees and neighbours. (Col 3:22-25, Col 4:1).
- The preservation and protection of the family unit is fundamental and children are prized as a blessing from God. (Psalm 127:3-5). The elderly are valued members of the community, for whom both their family and the wider community are expected to care.
- Holy Scripture commands us to be good neighbours to others, and deal with all other people (including former Brethren) openly, honestly and fairly and consistent with these principles, we should give our time, talents and money to assist those in need in the wider community, in so far as reasonable given our abilities and our available resources. (Matt 7:12, Matt 22:39, Eph 4:28).

Funding

Funding is sought through gifts from the congregation and Gift Aid is claimed on eligible donations. Funding is sometimes received from other charitable trusts with complementary objectives.

Financial review

Financial position

In the year ended 5 April 2025, the Trust had a modest deficit of incoming resources over resources expended. However the Trust still has free reserves that are, in their opinion, adequate. Total voluntary income received this year was £50517 compared to £27,892 in the previous year.

All funds held were unrestricted funds.

The Trustees have considered the level of reserves they wish to retain, appropriate to the charity's needs, based on its size and the level of its financial commitments. The Trust has no employees and its regular outgoings are minimal. Accordingly, the Trustees have decided to adopt a policy of maintaining a minimum level of reserves equating to 6 months operating costs. The congregation is kept regularly informed as to particular needs for funds, and other relevant matters and the Trustees aim to ensure that the Charity will be able to continue to fulfil its charitable objectives even if there is a temporary shortfall in income or unexpected expenditure, by raising a funds appeal to the congregation.

Free reserves at the year end were £70,352. (Free reserves previous year £64,120)

Statement of Trustees' responsibilities

The Trustees are responsible for preparing the Report of the Trustees and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

The law applicable to charities in England and Wales, the Charities Act 2011, Charity (Accounts and Reports) Regulations and the provisions of the Trust Deed require the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the Charity and of the incoming resources and application of resources, including the income and expenditure, of the Charity for that period. In preparing those financial statements, the Trustees are required to

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charity SORP;
- make judgements and estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the financial statements comply with the Charities Act 2011, the Charity (Accounts and Reports) Regulations and the provisions of the Trust Deed. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities. All transactions have been reviewed and approved by at least two trustees

NOTE 1. Basis of Preparation

1.1 These accounts have been prepared under the historic cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts.

The accounts have been prepared in accordance with :- The second edition of the Statement of Recommended Practice and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued in October 2019.

And with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)

And UK generally accepted practice.

The Charity constitutes a public benefit entity as defined by FRS 102

1.2 Going concern

The Trustees are of the opinion that the Trust remains a going concern for at least the next 12 months from the date of the signing of the accounts based on a review of the management accounts and forecasts.

1.3 Change of Accounting Policy

There were no changes in accounting policy

1.4 Changes to Accounting Estimates

There were no changes to accounting estimates

1.5 Material Prior Year Errors

There were no material prior year errors.

NOTE 2 Accounting Policies

2.1 Income

Recognition of income. These are included in the Statement of Financial Activities when:

- . The Charity becomes entitled to the resources
- . It is more likely than not that the Trustees will receive the resources
- . and the monetary value can be measured with sufficient reliability

Offsetting: There has been no offsetting of assets and liabilities or income and expenses unless required or permitted by the FRS 102 SORP or FRS 102.

Donations: Donations are only included in the SoFA when the general income recognition criteria are met (5.10 to 5.12 FRS 102 SORP)

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 5TH APRIL 2025 - Continued

Legacies: Legacies are included in the SoFA when receipt is probable that is when there has been a grant of probate, the executors have established that there are sufficient assets of the estate and any conditions attached to the legacy are either within the control of the Charity or have been met.

Tax reclaims on Donations and Gifts: Gift Aid receivable is included in income when there is a valid declaration from the donor. Any Gift Aid amount recovered on a donation is considered to be part of that gift and is treated as an addition to the same fund as the initial donation unless the donor or the terms of appeal have specified otherwise.

Volunteer Help: The value of any volunteer help received is not included in the accounts but is described in the Trustees Annual Report.

Income from Interest: This is included in the accounts when receipt is probable and the amount can be reliably measured.

2.2 Expenditure and Liabilities: Liabilities are recognised when it is more likely than not that there is a legal or constructive obligation committing the Charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

2.3 Assets: Tangible Fixed Assets for use by the Charity are capitalised if they can be used for more than one year and cost at least £500. They are valued at cost except for Freehold Property. These are valued every five years and valuation substituted for cost where this is materially different.

In accordance with this policy the Trustees undertook a valuation in March 2021 and concluded that the fair values of the three freehold properties (See Page 9) were not materially different from the cost amounts shown on the Balance Sheet. There had been no impairment nor material increase in value. This did not include any possible development values of the sites. The valuation was conducted a former Trustee (Mr J D Wallis) who is a retired Estate Agent.

Public Benefit & Outreach

2025

One of the Trust's principal activities that furthers its objects is providing a facility for the coordination of "outreach" work into the wider community.

The Trust has maintained its outreach activities. This report includes some of the things we have been engaged in.

Members of the Congregation, acting under the directions of the trustees and with their full and active encouragement, have continued with the "outreach" work which they have carried out for many years.

Gospel tracts and literature available from the Gospel Hall

The Trust maintains a display of gospel tracts, literature and Bibles in the foyer of its principal Gospel Hall and this fact is advertised on the Sign Board at the street entrance

Street preachings and tract distribution

We have maintained our longstanding committal to the open air preachings in the town centre of Newton Abbot. We have preaching every day Monday to Friday with at least two preachers on each occasion preaching and handing out gospel tracts. Over 20 Preachers from the community regularly preach.

Food Packs

We have resumed the provision of food packs to a local charity for onwards distribution, this has been donated to the Bovey food fridge and the local social supermarket

Contact and support

We have continued to support the local parish council in Ilsington on a regular basis. We are on their list as support snow wardens so that we can help them in times of snow by keeping areas open especially for the old and vulnerable. We have helped them fill their local salt bins on a regular basis and checked all grit bins in the Parish before winter.

Two members of the community have been trained by Teignbridge District Council emergency response team, in the management of a care centre in the case of emergency. We are thankful to report this has not been needed in the local community, but when this does happen, we are ready to help support them.

July 2024 Assisted Bovey Tracey Town Council in weeding paths in an extended area before Bovey In Bloom Event which helped them win an award.

Worked with the Parish council to Litter pick an area in the Parish

Worked with the Town Council to come up with ideas to help more deprived areas.

Some members of our Congregation assisted the Rapid Relief Team charity (RRT) in the following work

22 February 2025 Supported Dartmoor Search and Rescue on a major training exercise on Dartmoor

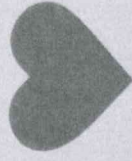
15 March 2025 Supported Rowcroft Hospice for a sponsored walk

Report of the trustees for the year ended 5 April 2024

The Trustees present their report along with the financial statements of the Charity for the year ended 5 April 2024. The financial statements have been prepared in accordance with the accounting policies set out on pages 10 and 11 and comply with the Trust Deed and applicable law.

Structure, governance and management

Governing document

The Charity is an unincorporated trust constituted by a Deed of Trust dated 30 September 1978, most recently amended by Deed of Variation dated 10 January 2014. The Trust was registered with the Charity Commission for England and Wales on 17 January 2014 under Charity Registration Number: 1155382

Recruitment and appointment of new trustees

The names of the Trustees who served during the year and since the year end are set out on page 1. None of the Trustees, nor any person connected with them, received any remuneration or expenses from the Charity in the year ended 5 April 2024 (2023: £nil).

The Trust operates 3 Gospel halls and Trustees are chosen from among the regular congregation of the halls. New Trustees are nominated by the existing Trustees or by the congregation and must be appointed by unanimous resolution of the congregation. They are selected according to their skills and experience and are expected to use both in furthering the objects of the Charity. Checks are made to ensure the Trustees' eligibility to act and incoming Trustees are made aware of their responsibilities by the existing Trustees, who ensure that new Trustees read the Trust Deed and relevant Charity Commission guidance.

Wider network

The Trustees maintain informal links with similar charities with a view to pooling experience considered useful in pursuing the objects of the Charity.

Risk management

The Trustees have identified and reviewed the major risks to which the Charity is exposed and confirm that they have established systems or procedures to manage and mitigate those risks.

Objectives and activities

Objectives and aims

The charitable purposes of the Charity are the advancement of the Christian religion for the public benefit, including by the carrying on of the service of God in accordance with the Old and New Testaments of the Holy Bible as followed by those Christians forming part of the world-wide fellowship known as the Plymouth Brethren Christian Church (the "Brethren") and any other charitable purposes connected with Brethren. The core doctrine of the Brethren and proper practices in furtherance of certain aspects of doctrine are summarised in two schedules to the Trust Deed.

Public benefit

The Trustees confirm that they have complied with their duty under section 4 of the Charities Act 2011 to have due regard to the Charity Commission's general guidance to charities on public benefit.

Main activities and achievements

Preston Down Trust

Report of the trustees for the year ended 5 April 2024

The Trust provides and maintains 3 Gospel halls where religious meetings are held by the local Brethren community. Details of the origins, teachings and way of life of the Brethren can be found on the website - www.plymouthbrethrenchristianchurch.org and in the schedules to the Trust Deed.

The Trust's main achievements this year have been to maintain its income at a sufficient level to meet its obligations and encouraging members of the Congregation to support the Rapid Relief Team charity (Registered Charity No:1161586) in providing food boxes for families suffering extreme financial hardship

Plans for Future Periods

Despite the increased cost of energy, the trustees feel that these increased costs are not significantly impacting on the ability of the charity to continue as a going concern

Meetings

Meetings held at the Gospel halls include the Lord's Supper (Communion), Gospel preachings, Bible readings and Bible addresses. There is a structured weekly schedule of meetings and, depending on the particular meeting, between 30 and 300 people normally attend these occasions.

The meetings are attended by the regular congregation and most are open to other properly disposed visitors. The notice board outside the Hall welcomes visitors and displays the times of Gospel preachings, along with a telephone number for those seeking further information or help. Gospel tracts, which are distributed by street preachers, also display this information.

Bibles and an extensive range of other Christian reading material are on display at the halls and visitors are free to help themselves.

Spreading the Gospel message and the life of a Christian

The Gospel halls are a base from which the regular congregation and others who attend the meetings are encouraged to spread the Christian Gospel, in word and deed.

Members of the congregation participate in a programme of street preaching and Gospel tracts are provided free of charge by the Charity to such preachers to be handed out to interested members of the public.

In addition to street preaching, members of the congregation also keep in touch with prison chaplains to provide gospel tracts and bibles as required. The trust operates a programme of providing regular packs of food and gospel literature to homeless and needy persons through local charities or hostels for the homeless.

In carrying out this work, the congregation considers itself to be living out its faith in practice, as particularly exemplified in the following extract from the schedule to the Trust Deed on living a Christian life:

- We seek and are encouraged to live exemplary lives in all our relationships with others in the wider community (including former Brethren), in accordance with the teachings of Holy Scripture (1 Tim 2:2).
- We regularly go out from our homes to preach on the streets, to distribute Christian literature and engage with the wider community (including former Brethren) in order to present eternal salvation, available to all men by faith in Jesus Christ. (2 Tim 4:2).
- We seek as members of the public to lead Christian lives as husbands and wives, parents, children, employers, employees and neighbours. (Col 3:22-25, Col 4:1).
- The preservation and protection of the family unit is fundamental and children are prized as a blessing from God. (Psalm 127:3-5). The elderly are valued members of the community, for whom both their family and the wider community are expected to care.
- Holy Scripture commands us to be good neighbours to others, and deal with all other people (including former Brethren) openly, honestly and fairly and consistent with these principles, we should give our time, talents and money to assist those in need in the wider community, in so far as reasonable given our abilities and our available resources. (Matt 7:12, Matt 22:39, Eph 4:28).

Funding

Funding is sought through gifts from the congregation and Gift Aid is claimed on eligible donations. Funding is sometimes received from other charitable trusts with complementary objectives.

Financial review

Financial position

In the year ended 5 April 2024, the Trust had a modest deficit of incoming resources over resources expended. However the Trust still has free reserves that are, in their opinion, adequate. Total voluntary income received this year was £27,892 compared to £29601 in the previous year.

All funds held were unrestricted funds.

The Trustees have considered the level of reserves they wish to retain, appropriate to the charity's needs, based on its size and the level of its financial commitments. The Trust has no employees and its regular outgoings are minimal. Free reserves at the year end were £64,120. (Free reserves previous year £65,120)

The Trustees confirm that they have complied with their duty under section 4 of the Charities Act 2011 to have due regard to the Charity Commission's general guidance to charities on public benefit.

The Trust provides and maintains 3 Gospel halls where religious meetings are held by the local Brethren community. Details of the origins, teachings and way of life of the Brethren can be found on the website - www.plymouthbrethrenchristianchurch.org and in the schedules to the Trust Deed.

The Trust's main achievements this year have been, in spite of COVID-19, lockdowns etc, to maintain its income at a sufficient level to meet its obligations and encouraging members of the Congregation to support the Rapid Relief Team charity (Registered Charity No:1161586) in providing food boxes for families suffering extreme financial hardship

Plans for Future Periods

Despite the increased cost of energy, the trustees feel that these increased costs are not significantly impacting on the ability of the charity to continue as a going concern

Meetings

Meetings held at the Gospel halls include the Lord's Supper (Communion), Gospel preachings, Bible readings and Bible addresses. There is a structured weekly schedule of meetings and, depending on the particular meeting, between 30 and 300 people normally attend these occasions.

The meetings are attended by the regular congregation and most are open to other properly disposed visitors. The notice board outside the Hall welcomes visitors and displays the times of Gospel preachings, along with a telephone number for those seeking further information or help. Gospel tracts, which are distributed by street preachers, also display this information.

Bibles and an extensive range of other Christian reading material are on display at the halls and visitors are free to help themselves.

Spreading the Gospel message and the life of a Christian

The Gospel halls are a base from which the regular congregation and others who attend the meetings are encouraged to spread the Christian Gospel, in word and deed.

Members of the congregation participate in a programme of street preaching and Gospel tracts are provided free of charge by the Charity to such preachers to be handed out to interested members of the public.

In addition to street preaching, members of the congregation also keep in touch with prison chaplains to provide gospel tracts and bibles as required. The trust operates a programme of providing regular packs of food and gospel literature to homeless and needy persons through local charities or hostels for the homeless.

In carrying out this work, the congregation considers itself to be living out its faith in practice, as particularly exemplified in the following extract from the schedule to the Trust Deed on living a Christian life:

- We seek and are encouraged to live exemplary lives in all our relationships with others in the wider community (including former Brethren), in accordance with the teachings of Holy Scripture (1 Tim 2:2).
- We regularly go out from our homes to preach on the streets, to distribute Christian literature and engage with the wider community (including former Brethren) in order to present eternal salvation, available to all men by faith in Jesus Christ. (2 Tim 4:2).

Funding

Funding is sought through gifts from the congregation and Gift Aid is claimed on eligible donations. Funding is sometimes received from other charitable trusts with complementary objectives.

Financial review

Financial position

In the year ended 5 April 2023, the Trust had a modest deficit of incoming resources over resources expended. However the Trust still has free reserves that are, in their opinion, adequate. Total voluntary income received this year was £29601 compared to £28821 in the previous year.

All funds held were unrestricted funds.

Reserves policy

The Trustees have considered the level of reserves they wish to retain, appropriate to the charity's needs, based on its size and the level of its financial commitments. The congregation is kept regularly informed as to particular needs for funds, and other relevant matters and the Trustees aim to ensure that the Charity will be able to continue to fulfil its charitable objectives even if there is a temporary shortfall in income or unexpected expenditure, by raising a funds appeal to the congregation.

Free reserves at the year end were £65,120. (Free reserves previous year £63,814)

NOTE 1. Basis of Preparation

1.1 These accounts have been prepared under the historic cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts.

From 18th March 2020 Preston Down Trust ceased using the 3 gospel halls which it operates owing to the COVID-19 pandemic and the general lockdown imposed by the Government. The halls were re-opened on 1st May 2022.

2.1 Income

Donations: Donations are only included in the SoFA when the general income recognition criteria are met (5.10 to 5.12 FRS 102 SORP)

Legacies: Legacies are included in the SoFA when receipt is probable that is when there has been a grant of probate, the executors have established that there are sufficient assets of the estate and any conditions attached to the legacy are either within the control of the Charity or have been met.

Tax reclaims on Donations and Gifts: Gift Aid receivable is included in income when there is a valid declaration from the donor. Any Gift Aid amount recovered on a donation is considered to be part of that gift and is treated as an addition to the same fund as the initial donation unless the donor or the terms of appeal have specified otherwise.

Volunteer Help: The value of any volunteer help received is not included in the accounts but is described in the Trustees Annual Report.

Income from Interest: This is included in the accounts when receipt is probable and the amount can be reliably measured.

2.2 Expenditure and Liabilities: Liabilities are recognised when it is more likely than not that there is a legal or constructive obligation committing the Charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

2.3 Assets: Tangible Fixed Assets for use by the Charity are capitalised if they can be used for more than one year and cost at least £500. They are valued at cost except for Freehold Property. These are valued every five years and valuation substituted for cost where this is materially different.

In accordance with this policy the Trustees undertook a valuation in March 2021 and concluded that the fair values of the three freehold properties (See Page 9) were not materially different from the cost amounts shown on the Balance Sheet. There had been no impairment nor material increase in value. This did not include any possible development values of the sites. The valuation was conducted by one of the Trustees (Mr J D Wallis) who is a retired Estate Agent.

Public Benefit & Outreach

2023

One of the Trust's principal activities that furthers its objects is providing a facility for the coordination of "outreach" work into the wider community.

The Trust has endeavoured to maintain its outreach activities as far as possible. This report includes some of the things we have been engaged in.

Members of the Congregation, acting under the directions of the trustees and with their full and active encouragement, have continued with the "outreach" work which they have carried out for many years.

Gospel tracts and literature available from the Gospel Hall

The Trust maintains a display of gospel tracts, literature and Bibles in the foyer of its principal Gospel Hall and this fact is advertised on the Sign Board at the street entrance.

Street preachings and tract distribution

In September 2022 we resumed our longstanding committal to the open air preachings in the town centre of Newton Abbot. We have preaching every day Monday to Friday with at least two preachers on each occasion preaching and handing out gospel tracts. Over 20 Preachers from the community regularly preach.

Food Packs

We have resumed the provision of food packs to a local charity for onwards distribution

Contact and support

We have continued to support the local parish council in Ilsington on a regular basis. We are on their list as support snow wardens so that we can help them in times of snow by keeping areas open especially for the old and vulnerable. We have helped them fill their local salt bins on a regular basis and checked all grit bins in the Parish before winter.

Two members of the community have been trained by Teignbridge District Council emergency response team, in the management of a care centre in the case of emergency. We are thankful to report this has not been needed in the local community, but when this does happen, we are ready to help support them.

We have joined with Rapid Relief Team (Registered Charity No:1161586) in providing an additional defibrillator in the local parish

This was as a result of the global COVID-19 pandemic and the general lockdown imposed by the government on 23rd March 2020. The Trust has resumed use of these Gospel Halls again. The trustees do not consider that the Covid-19 pandemic will have any effect on the ability of the trust to continue as a going concern.

Meetings

Meetings held at the Gospel halls include the Lord's Supper (Communion), Gospel preachings, Bible readings and Bible addresses. There is a structured weekly schedule of meetings and, depending on the particular meeting, between 30 and 300 people normally attend these occasions.

The meetings are attended by the regular congregation and most are open to other properly disposed visitors. The notice board outside the Hall welcomes visitors and displays the times of Gospel preachings, along with a telephone number for those seeking further information or help. Gospel tracts, which are distributed by street preachers, also display this information.

Bibles and an extensive range of other Christian reading material are on display at the halls and visitors are free to help themselves.

Spreading the Gospel message and the life of a Christian

The Gospel halls are a base from which the regular congregation and others who attend the meetings are encouraged to spread the Christian Gospel, in word and deed.

Members of the congregation normally participate in a programme of street preaching and Gospel tracts are provided free of charge by the Charity to such preachers to be handed out to interested members of the public. This activity has been suspended owing to the pandemic. It is intended that it will be recommenced as soon as is feasible

In addition to street preaching, members of the congregation also keep in touch with prison chaplains to provide gospel tracts and bibles as required. Until prevented by the pandemic, the trust operated a programme of providing regular packs of food and gospel literature to homeless and needy persons through local charities or hostels for the homeless. The trust intends to resume this programme as soon as is feasible

In carrying out this work, the congregation considers itself to be living out its faith in practice, as particularly exemplified in the following extract from the schedule to the Trust Deed on living a Christian life:

- We seek and are encouraged to live exemplary lives in all our relationships with others in the wider community (including former Brethren), in accordance with the teachings of Holy Scripture (1 Tim 2:2).
- We regularly go out from our homes to preach on the streets, to distribute Christian literature and engage with the wider community (including former Brethren) in order to present eternal salvation, available to all men by faith in Jesus Christ. (2 Tim 4:2).
- We seek as members of the public to lead Christian lives as husbands and wives, parents, children, employers, employees and neighbours. (Col 3:22-25, Col 4:1).
- The preservation and protection of the family unit is fundamental and children are prized as a blessing from God. (Psalm 127:3-5). The elderly are valued members of the community, for whom both their family and the wider community are expected to care.
- Holy Scripture commands us to be good neighbours to others, and deal with all other people (including former Brethren) openly, honestly and fairly and consistent with these principles, we should give our time, talents and money to assist those in need in the wider community, in so far as reasonable given our abilities and our available resources. (Matt 7:12, Matt 22:39, Eph 4:28).

Funding

Funding is sought through gifts from the congregation and Gift Aid is claimed on eligible donations. Funding is sometimes received from other charitable trusts with complementary objectives.

Financial review

Financial position

In the year ended 5 April 2022, the Trust had a modest deficit of incoming resources over resources expended. However the Trust still has free reserves that are, in their opinion, adequate. Total voluntary income received this year was £28221 compared to £38073 in the previous year.

All funds held were unrestricted funds.

Reserves policy

The Trustees have considered the level of reserves they wish to retain, appropriate to the charity's needs, based on its size and the level of its financial commitments. The Trust has no employees and its regular outgoings are minimal. Accordingly, the Trustees have decided to adopt a policy of maintaining no significant reserves. The congregation is kept regularly informed as to particular needs for funds, and other relevant matters and the Trustees aim to ensure that the Charity will be able to continue to fulfil its charitable objectives even if there is a temporary shortfall in income or unexpected expenditure, by raising a funds appeal to the congregation.

Free reserves at the year end were £63,814. (Free reserves previous year £58,730)

NOTE 1. Basis of Preparation

1.1 These accounts have been prepared under the historic cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts.

From 18th March 2020 Preston Down Trust ceased using the 3 gospel halls which it operates owing to the COVID-19 pandemic and the general lockdown imposed by the Government. The Trustees do not consider that the COVID-19 pandemic will have any effect on the ability of the Trust to continue as a going concern.

1.3 Change of Accounting Policy

There were no changes in accounting policy

1.4 Changes to Accounting Estimates

There were no changes to accounting estimates

1.5 Material Prior Year Errors

There were no material prior year errors.

NOTE 2 Accounting Policies

2.1 Income

Recognition of income. These are included in the Statement of Financial Activities when:

- . The Charity becomes entitled to the resources
- . It is more likely than not that the Trustees will receive the resources
- . and the monetary value can be measured with sufficient reliability

Offsetting: There has been no offsetting of assets and liabilities or income and expenses unless required or permitted by the FRS 102 SORP or FRS 102.

Donations: Donations are only included in the SoFA when the general income recognition criteria are met (5.10 to 5.12 FRS 102 SORP)

Legacies: Legacies are included in the SoFA when receipt is probable that is when there has been a grant of probate, the executors have established that there are sufficient assets of the estate and any conditions attached to the legacy are either within the control of the Charity or have been met.

Tax reclaims on Donations and Gifts: Gift Aid receivable is included in income when there is a valid declaration from the donor. Any Gift Aid amount recovered on a donation is considered to be part of that gift and is treated as an addition to the same fund as the initial donation unless the donor or the terms of appeal have specified otherwise.

Volunteer Help: The value of any volunteer help received is not included in the accounts but is described in the Trustees Annual Report.

Income from Interest: This is included in the accounts when receipt is probable and the amount can be reliably measured.

2.2 Expenditure and Liabilities: Liabilities are recognised when it is more likely than not that there is a legal or constructive obligation committing the Charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

2.3 Assets: Tangible Fixed Assets for use by the Charity are capitalised if they can be used for more than one year and cost at least £500. They are valued at cost except for Freehold Property. These are valued every five years and valuation substituted for cost where this is materially different.

In accordance with this policy the Trustees undertook a valuation in March 2021 and concluded that the fair values of the three freehold properties (See Page 9) were not materially different from the cost amounts shown on the Balance Sheet. There had been no impairment nor material increase in value. This did not include any possible development values of the sites. The valuation was conducted by one of the Trustees (Mr J D Wallis) who is a retired Estate Agent.

Public Benefit & Outreach

2022

One of the Trust's principal activities that furthers its objects is providing a facility for the coordination of "outreach" work into the wider community.

The Trust's activities have obviously been seriously impacted by the COVID-19 pandemic . The Trust has endeavoured to maintain its outreach activities as far as possible This report includes some of the things we have been engaged in.

Members of the Congregation, acting under the directions of the trustees and with their full and active encouragement, have continued with the "outreach" work which they have carried out for many years.

Gospel tracts and literature available from the Gospel Hall

The Trust maintains a display of gospel tracts, literature and Bibles in the foyer of its principal Gospel Hall and this fact is advertised on the Sign Board at the street entrance

Street preachings and tract distribution

In September 2022 we resumed our longstanding committal to the open air preachings in the town centre of Newton Abbot. We have preaching every day Monday to Friday with at least two preachers on each occasion preaching and handing out gospel tracts. Over 20 Preachers from the community regularly preach.

Food Packs

We have resumed the provision of food packs to a local charity for onwards distribution

Contact and support

We have continued to support the local parish council in Ilsington on a regular basis. We are on their list as support snow wardens so that we can help them in times of snow by keeping areas open especially for the old and vulnerable. We have helped them fill their local salt bins on a regular basis and checked all grit bins in the Parish before winter.

Two members of the community have been trained by Teignbridge District Council emergency response team, in the management of a care centre in the case of emergency. We are thankful to report this has not been needed in the local community, but when this does happen, we are ready to help support them.

We have expressed our willingness to pay for a defibrillator in the local parish

Some members of our Congregation assisted the Rapid Relief Team charity in the following work

On June 6th 2022 RRT supported Devon & Cornwall Police at a search and rescue training exercise on Dartmoor providing 120 meals, both breakfast and lunch.

On the 30th of June 2022 RRT were called by Devon & Cornwall Police to provide food at a live Search & rescue mission on Dartmoor for a vulnerable woman, thankfully she was found safe and well.

Again, in July 2022 RRT was called out by D&C Police for a similar event in Teignmouth but stood down as the person concerned was found safe and well.

On 3rd of September 2022 RRT supported Shekinah Mission at the Grow 4 life centre in Paignton providing food and refreshments at the Metal Health Day.

RRT has donated this year, 100 Snack packs to SW Ambulance service for the crews, 400 snack packs to Devon & Cornwall Police, 30 food boxes for Highweek Primary School and 5 food boxes to "Feed Devon" at Bovey Tracy.

Further plans for 2023

We shall aim to restore all our outreach activities at least to their pre-pandemic levels

We are open to further suggestions from the congregation which we will review and then put forward for approval at one of our regular trustee meetings.

The Trustees present their report along with the financial statements of the Charity for the year ended 5 April 2021. The financial statements have been prepared in accordance with the accounting policies set out on pages 10 and 11 and comply with the Trust Deed and applicable law.

Structure, governance and management

Governing document

The Charity is an unincorporated trust constituted by a Deed of Trust dated 30 September 1978, most recently amended by Deed of Variation dated 10 January 2014. The Trust was registered with the Charity Commission for England and Wales on 17 January 2014 under Charity Registration Number: 1155382

Recruitment and appointment of new trustees

The names of the Trustees who served during the year and since the year end are set out on page 1. None of the Trustees, nor any person connected with them, received any remuneration or expenses from the Charity in the year ended 5 April 2021 (2020: £nil).

The Trust operates 3 Gospel halls and Trustees are chosen from among the regular congregation of the hall. New Trustees are nominated by the existing Trustees or by the congregation and must be appointed by unanimous resolution of the congregation. They are selected according to their skills and experience and are expected to use both in furthering the objects of the Charity. Checks are made to ensure the Trustees' eligibility to act and incoming Trustees are made aware of their responsibilities by the existing Trustees, who ensure that new Trustees read the Trust Deed and relevant Charity Commission guidance.

Wider network

The Trustees maintain informal links with similar charities with a view to pooling experience considered useful in pursuing the objects of the Charity.

Risk management

The Trustees have identified and reviewed the major risks to which the Charity is exposed and confirm that they have established systems or procedures to manage and mitigate those risks.

Objectives and activities

Objectives and aims

The charitable purposes of the Charity are the advancement of the Christian religion for the public benefit, including by the carrying on of the service of God in accordance with the Old and New Testaments of the Holy Bible as followed by those Christians forming part of the world-wide fellowship known as the Plymouth Brethren Christian Church (the "Brethren") and any other charitable purposes connected with Brethren. The core doctrine of the Brethren and proper practices in furtherance of certain aspects of doctrine are summarised in two schedules to the Trust Deed.

Public benefit

The Trustees confirm that they have complied with their duty under section 4 of the Charities Act 2011 to have due regard to the Charity Commission's general guidance to charities on public benefit.

Main activities and achievements

Preston Down Trust

Report of the trustees (continued) For the year ended 5 April 2021

The Trust provides and maintains 3 Gospel halls where religious meetings are held by the local Brethren community. Details of the origins, teachings and way of life of the Brethren can be found on the website - www.plymouthbrethrenchristianchurch.org and in the schedules to the Trust Deed.

The Trust's main achievements this year have been, in spite of COVID-19, lockdowns etc, to maintain its income at a sufficient level to meet its obligations and encouraging members of the Congregation to support the Rapid Relief Team charity in providing food boxes for families suffering extreme financial hardship

The trustees have also established an Emergency Needs fund for the duration of the current pandemic and any resultant economic downturn. This is providing limited financial assistance by the way of grocery vouchers to households, who have experienced a recent and significant decrease in income due to the pandemic, such that it is likely to impact on the health and/or welfare of members of the household. The trust has appointed a Local Welfare Panel to manage the application process and to administer the vouchers to qualifying applicants.

Plans for Future Periods

From 18th March 2020, Preston Down Trust ceased using the three gospel halls, which it operates. This was as a result of the global COVID-19 pandemic and the general lockdown imposed by the government on 23rd March 2020. The Trust aims to use these Gospel Halls again once the general lockdown is lifted and it is deemed safe to do so. The trustees do not consider that the Covid-19 pandemic will have any effect on the ability of the trust to continue as a going concern.

Meetings

Meetings held at the Gospel halls include the Lord's Supper (Communion), Gospel preachings, Bible readings and Bible addresses. There is a structured weekly schedule of meetings and, depending on the particular meeting, between 30 and 300 people normally attend these occasions.

The meetings are attended by the regular congregation and most are open to other properly disposed visitors. The notice board outside the Hall welcomes visitors and displays the times of Gospel preachings, along with a telephone number for those seeking further information or help. Gospel tracts, which are distributed by street preachers, also display this information.

Bibles and an extensive range of other Christian reading material are on display at the halls and visitors are free to help themselves.

Spreading the Gospel message and the life of a Christian

The Gospel halls are a base from which the regular congregation and others who attend the meetings are encouraged to spread the Christian Gospel, in word and deed.

Members of the congregation normally participate in a programme of street preaching and Gospel tracts are provided free of charge by the Charity to such preachers to be handed out to interested members of the public. This activity has been suspended owing to the pandemic. It is intended that it will be recommenced as soon as is feasible

In addition to street preaching, members of the congregation also keep in touch with prison chaplains to provide gospel tracts and bibles as required. Until prevented by the pandemic, the trust operated a programme of providing regular packs of food and gospel literature to homeless and needy persons through local charities or hostels for the homeless. The trust intends to resume this programme as soon as is feasible

In carrying out this work, the congregation considers itself to be living out its faith in practice, as particularly exemplified in the following extract from the schedule to the Trust Deed on living a Christian life:

- We seek and are encouraged to live exemplary lives in all our relationships with others in the wider community (including former Brethren), in accordance with the teachings of Holy Scripture (1 Tim 2:2).
- We regularly go out from our homes to preach on the streets, to distribute Christian literature and engage with the wider community (including former Brethren) in order to present eternal salvation, available to all men by faith in Jesus Christ. (2 Tim 4:2).
- We seek as members of the public to lead Christian lives as husbands and wives, parents, children, employers, employees and neighbours. (Col 3:22-25, Col 4:1).
- The preservation and protection of the family unit is fundamental and children are prized as a blessing from God. (Psalm 127:3-5). The elderly are valued members of the community, for whom both their family and the wider community are expected to care.
- Holy Scripture commands us to be good neighbours to others, and deal with all other people (including former Brethren) openly, honestly and fairly and consistent with these principles, we should give our time, talents and money to assist those in need in the wider community, in so far as reasonable given our abilities and our available resources. (Matt 7:12, Matt 22:39, Eph 4:28).

Funding

Funding is sought through gifts from the congregation and Gift Aid is claimed on eligible donations. Funding is sometimes received from other charitable trusts with complementary objectives.

Financial review

Financial position

In the year ended 5 April 2021, the Trust had a modest deficit of incoming resources over resources expended owing to a decrease in donations. Total voluntary income received this year was £38,073 compared to £124,797 in the previous year.

All funds held were unrestricted funds.

Reserves policy

The Trustees have considered the level of reserves they wish to retain, appropriate to the charity's needs, based on its size and the level of its financial commitments. The Trust has no employees and its regular outgoings are minimal. Accordingly, the Trustees have decided to adopt a policy of maintaining no significant reserves. The congregation is kept regularly informed as to particular needs for funds, and other relevant matters and the Trustees aim to ensure that the Charity will be able to continue to fulfil its charitable objectives even if there is a temporary shortfall in income or unexpected expenditure, by raising a funds appeal to the congregation.

Free reserves at the year end were £58,730.

Statement of Trustees' responsibilities

The Trustees are responsible for preparing the Report of the Trustees and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

The law applicable to charities in England and Wales, the Charities Act 2011, Charity (Accounts and Reports) Regulations and the provisions of the Trust Deed require the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the Charity and of the incoming resources and application of resources, including the income and expenditure, of the Charity for that period. In preparing those financial statements, the Trustees are required to

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charity SORP;
- make judgements and estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the financial statements comply with the Charities Act 2011, the Charity (Accounts and Reports) Regulations and the provisions of the Trust Deed. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities. NOTE 1. Basis of Preparation

1.1 These accounts have been prepared under the historic cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts.

From 18th March 2020 Preston Down Trust ceased using the 3 gospel halls which it operates owing to the COVID-19 pandemic and the general lockdown imposed by the Government. The Trustees do not consider that the COVID-19 pandemic will have any effect on the ability of the Trust to continue as a going concern.

NOTE 2 Accounting Policies

2.1 Income

Recognition of income. These are included in the Statement of Financial Activities when:

- . The Charity becomes entitled to the resources
- . It is more likely than not that the Trustees will receive the resources
- . and the monetary value can be measured with sufficient reliability

Offsetting: There has been no offsetting of assets and liabilities or income and expenses unless required or permitted by the FRS 102 SORP or FRS 102.

Donations: Donations are only included in the SoFA when the general income recognition criteria are met (5.10 to 5.12 FRS 102 SORP)

Legacies: Legacies are included in the SoFA when receipt is probable that is when there has been a grant of probate, the executors have established that there are sufficient assets of the estate and any conditions attached to the legacy are either within the control of the Charity or have been met.

Tax reclaims on Donations and Gifts: Gift Aid receivable is included in income when there is a valid declaration from the donor. Any Gift Aid amount recovered on a donation is considered to be part of that gift and is treated as an addition to the same fund as the initial donation unless the donor or the terms of appeal have specified otherwise.

Volunteer Help: The value of any volunteer help received is not included in the accounts but is described in the Trustees Annual Report.

Income from Interest: This is included in the accounts when receipt is probable and the amount can be reliably measured.

2.2 Expenditure and Liabilities: Liabilities are recognised when it is more likely than not that there is a legal or constructive obligation committing the Charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

2.3 Assets: Tangible Fixed Assets for use by the Charity are capitalised if they can be used for more than one year and cost at least £500. They are valued at cost except for Freehold Property. These are valued every five years and valuation substituted for cost where this is materially different.

In accordance with this policy the Trustees undertook a valuation in March 2021 and concluded that the fair values of the three freehold properties (See Page 9) were not materially different from the cost amounts shown on the Balance Sheet. There had been no impairment nor material increase in value. This did not include any possible development values of the sites. The valuation was conducted by one of the Trustees (Mr J D Wallis) who is a retired Estate Agent.

There was a balance of £450 remaining at 5th April 2021 which consisted of a stock of food vouchers to be distributed in the near future.

No Trustee received any remuneration or other benefits from an employment with the Charity and no Trustee was reimbursed for any expenses (Last year Nil)

Public Benefit & Outreach

2021

One of the Trust's principal activities that furthers its objects is providing a facility for the coordination of "outreach" work into the wider community.

The Trust's activities have obviously been seriously impacted by the COVID-19 pandemic . The Trust has endeavoured to maintain its outreach activities as far as possible This report includes some of the things we have been engaged in.

Members of the Congregation, acting under the directions of the trustees and with their full and active encouragement, have continued with the "outreach" work which they have carried out for many years.

Gospel tracts and literature available from the Gospel Hall

The Trust maintains a display of gospel tracts, literature and Bibles in the foyer of its principal Gospel Hall and this fact is advertised on the Sign Board at the street entrance

Street preachings and tract distribution

Until 23 March 2020 we maintained our longstanding committal to the open air preachings in the town centre of Newton Abbot. We had at least 4 preachings per week handing out around 15 tracts each week. Over 30 Preachers from the community regularly preach.

It is intended to resume the street preaching and tract distribution when appropriate

Food Packs

We have had to suspend the provision of food packs but intend to resume this if possible

Contact and support

Until lockdown we have continued to support the local parish council meetings in Ilsington on a regular basis. We are on their list as support snow wardens so that we can help them in times of snow by keeping areas open especially for the old and vulnerable. We have helped them fill their local salt bins on a regular basis and checked all grit bins in the Parish before winter.

Two members of the community have been trained by Teignbridge District Council emergency response team, in the management of a care centre in the case of emergency. We are thankful to report this has not been needed in the local community, but when this does happen, we are ready to help support them.

Some members of our Congregation assisted the Rapid Relief Team charity in the following work

On 11 April 2021 providing food and drink to assist the emergency services in a “search and rescue” mission in Torquay

2nd July 2021, Supplying bottled water at a fund-raising event arranged by Rowcroft Hospice

20 food boxes have been provided through Coombeshead School, Newton Abbot . These boxes are designed to feed a family of 4 for 2/3 days

Upcoming events which RRT expects to support

Event arranged by Torbay Council, postponed until further notice due to CD-19

3rd December 2021, Event arranged by Shekinah Mission,

9th Oct 2021, assisting with a Police training event at Newquay Airport.

COVID-19 has curtailed Rapid Relief Team’s usual work

Further plans for 2022

We shall aim to restore all our outreach activities at least to their pre-pandemic levels

We are open to further suggestions from the congregation which we will review and then put forward for approval at one of our regular trustee meetings.
