Risk and Going Concern

The trustees have given due consideration to the major risks to which the charity is exposed, and are satisfied that systems, policies and procedures are in place to mitigate exposure to major risks. In particular the trustees have considered the impact of Covid-19 on its ability to raise funds and to deliver its mission. Having reviewed the budgets the trustees are confident that they can continue in operation for a period of at least twelve months from the date these reports are signed.

Reserves

The trustees seek to hold three months of operating costs in free reserves; based on the current year required free reserves total £12,000.
