## FABHD Committee's Report for the year ended 31st July 2025

**Section A: Overview of history, numbers, typical day, costs, and management.**

**Section B: Relating to the year 1.8.24 to 31.7.25.**

### A: Overview

Founded by two British Missionaries in 1961 in Kalimpong in Darjeeling District, India, Albella is a home and school run on Christian values but respectful of all religions by an all-Indian staff. It currently gives free education to approximately 140 children mostly aged 5-19, comprising approximately 100 boys and 40 girls. The girls all live with their parents who are too poor to be able to send them to school. All residents are invited to daily morning & evening prayers & Sunday service but many remain Hindus and there are a few Buddhists.

Albella has two sites, Senior and Junior, separated by a two minute walk. Though the main Senior site is not owned but rented for a small sum, it is permanently secured under Indian law. Albella Boys Home part-owns the leasehold of the Junior site where it has its own Bon Ami Primary School.

### **Costs and donations**

There are three main sources of funds for Albella: sponsors of resident boys (mostly in the UK) - individuals, churches, schools, or groups like Rotary; occasional donors; and a Danish agency funds some of Bon Ami Primary School costs and some capital projects.

**Each UK sponsor is given the name and photo of a particular resident boy whose annual total costs are estimated to be £336 so sponsors have been encouraged to try to meet that target or £28 per month.** By signing a Gift Aid form, the target has been only £268.80 per annum or £22.40 per month, given directly to Albella Boys Home. The Trustees are currently reviewing this amount. This pays for the boy's accommodation, food, clothes, school fees, two sets of uniform, books, stationery, shoes, socks, tie, tiny pocket money (with extra for Independence Day 15<sup>th</sup> August), birthday and Christmas presents. All boys are treated equally, so they each get similar presents on the one Birthday Day in July and at the Christmas party. Many sponsors give much more than our target and the surplus is used for the benefit of the home. A small proportion of that target figure goes towards funding the following: Albella's adjacent Bon Ami Primary School with its eight classes from Nursery to Class V; staff costs including our Principal, food-transporting vehicles; and the new photo and letter each Christmas giving sponsors the pleasure of reading about and seeing the changes in their boy or girl as they grow up.

The handful of sponsors who fund the education of girls are also given the name and photo of their own girl. As these girls are non-resident, costs are much lower, requiring an annual target figure of £100, approximately 1/3<sup>rd</sup> of the costs of a resident boy.

### **Management**

There are two committees, one in India and FABHD in the UK. They exchange their minutes and accounts and their comments on them. In May 2024 the Indian Committee appointed Naomi (daughter of the former Principal Heshron Rahmi) as the new Principal. Naomi is well known to four of the UK trustees and this is seen as a positive appointment. It should be noted that her appointment was not advocated by her father but he is supportive of her appointment. They have been in a period of transition from May 2024.

Contact between the Principal, Naomi Lygdoh-Rahmi, and the UK officers is at least monthly. Naomi and the UK Chairman are in regular contact about Albella.

The Indian Management Committee consists of 6 volunteers and the Principal who writes the minutes. Its Chairman is a retired lecturer from Kalimpong Government College. Her name is Mrs Rinzi Namchu. Her late husband was a pastor and principal of Mirik Bible School. Albella Boys Home Trust is registered in India under the Indian Societies Registration Act 1860, Charitable Trust Deed no.Trust/718/10A/VOL/BI/A-109. Albella is also registered for receiving foreign grants (FCRA no.146980019) with the Ministry of Home Affairs, New Delhi. This FCRA registration was re-confirmed in December 2024 for a period of five years. Its accounts are audited in India and those audited statements of accounts go to India's Ministry of Home Affairs and also to the Indian Government's Income Tax Department, both online and hard copies.

Friends of Albella Boys Home, Darjeeling (FABHD), a society which was registered as a charity with the UK Charity Commission in 2014, retained its working name of Albella Boys Home so no change was needed to bank accounts or to regular bank gifts from sponsors. The FABHD Committee pays the Principal an annual allowance, which is the only salary she receives. The Committee consists of volunteers and aims to meet, physically or virtually, twice a year for a 90 minute meeting. When meetings are physical, they are generally followed by lunch and take place in a different committee member's house each time. No travelling or hospitality expenses are given. Its offices are the homes of its unpaid officers, Chairman, Administrator and Treasurer. The Chairman's letter regularly encourages existing sponsors to join the committee. Those interested are invited first as observers after which the existing committee members decide on whether to approve the observer as a new committee member.

Administration costs for 2024-25 were only £66 equating to 0.15% of income. This is lower than normal as the invoice for website costs was not submitted before the 31<sup>st</sup> July and will be included next year. The main expenses are the cost of our website, postage, paper, ink, copying, but no advertising; otherwise, all money is available to India. Sponsors get only one postal mailing a year in early December, with a photo and a Christmas card, a report from the Principal, Treasurer's statement, and letter from the Chairman.

### **B. Relating to the year 1.8.24 to 31.7.25**

1. **Public benefit:** Having considered the Charity Commission's general guidance on public benefit, the Committee is confident that their Charity's activities meet the public benefit requirement.
2. **Constitution and accounts:** Our Constitution (as a society) and our accounts are on the website, along with this annual report. Thanks to Niall Burroughs, our accounts have again been finalised and published after an independent examination by Jeremy Evans FCA, who generously waives all fees.
3. **Communications:** As reported in 2019, we have registered the domain name [albellaboyshome.org.uk](http://albellaboyshome.org.uk) for a period of 10 years and the website [www.albellaboyshome.org.uk](http://www.albellaboyshome.org.uk) is operational but remains "work in progress". It is hoped that it will prove useful to existing donors and as a means of recruiting new sponsors, especially when they view the remarkably low running costs of FABHD. An increasing number of sponsors have downloaded a Gift Aid form and Banker's Order and, instead of continuing to use Stewardship (whose administration charges were recently increased), now pay FABHD direct, saving costs and increasing the tax relief for FABHD via our Treasurer.
4. **Committee:** The Committee comprises Chairman, Treasurer, and six members.
5. **Albella Residents:** Following the pandemic, things have almost returned to normal although some boys have gone down with fevers and coughs as would usually be expected of school age children.
6. **Sponsors:** Each committee member takes on the responsibility to find at least one new sponsor or significant donation each year. Most sponsors remain with Albella for 10-20 years, and some much longer, and this loyalty is much appreciated. Inevitably there is some turnover of sponsors (below 10% each year) through death, old age, and changing circumstances especially when times are tough.
7. **Water problems:** The supply from the bore well which was drilled in 2016 has provided a much-needed supply of fresh water with this well being able to produce in excess of 2,000 litres of water daily. The Monsoon this year has caused no serious problems at Albella and all the underground water tanks are filled to capacity: this with the bore well supply eases the water problems at Albella.
8. **Gas:** The high cost of cooking gas continues although the supply has been much better during this year, and the usage of gas has been greatly reduced.
9. **Landslides and earthquakes:** There has been no experience of earthquakes during this reporting year but there were significant floods which washed away the road to Siliguri.
10. **Computers:** The introduction of new computers remains an issue. One of the problems associated with their introduction is the very poor internet connectivity in the area but we remain keen to resolve the whole issue as we believe that it will greatly assist the older boys with their studies for their higher-class examinations. We still intend to supply each teacher in the Bon Ami school with a device and a screen to allow the teachers to move away from writing everything with chalk on a blackboard. We have recently started that process by providing funds for two multi-purpose screens to be used by Bon Ami. We have also funded an internet connection for Teachers' use. The teachers will be able to download information of interest and use that information within the classrooms.
11. **Reserves policy:** Our reserves policy remains unchanged, that is broadly not to build up reserves in the absence of a specific project. The cash held at the year-end in part reflects an accumulation of General donations the use of which is under discussion with the Principal.

Naomi is well known to four of the UK trustees and this is seen as a positive appointment. It should be noted that her appointment was not advocated by her father but he is supportive of her appointment. They have been in a period of transition from May 2024.

Its offices are the homes of its unpaid officers, Chairman, Administrator and Treasurer. The Chairman's letter regularly encourages existing sponsors to join the committee. Those interested are invited first as observers after which the existing committee members decide on whether to approve the observer as a new committee member.

Total administration costs for 2023-24 were only £253 equating to 0.65% of income. The main expenses are the cost of our website, postage, paper, ink, copying, but no advertising; otherwise, all money is available to India. Sponsors get only one postal mailing a year in early December, with a photo and a Christmas card, a report from Heshron, Treasurer's statement, and letter from the Chairman.

## **B. Relating to the year 1.8.23 to 31.7.24**

1. **Public benefit:** Having considered the Charity Commission's general guidance on public benefit, the Committee is confident that their Charity's activities meet the public benefit requirement.
2. **Constitution and accounts:** Our Constitution (as a society) and our accounts are on the website, along with this annual report. Thanks to Niall Burroughs, our accounts have again been finalised and published after an independent examination by Jeremy Evans FCA, who generously waives all fees.
3. **Communications:** As reported in 2019, we have registered the domain name [albellaboyshome.org.uk](http://albellaboyshome.org.uk) for a period of 10 years and the website [www.albellaboyshome.org.uk](http://www.albellaboyshome.org.uk) is operational but remains "work in progress". It is hoped that it will prove useful to existing donors and as a means of recruiting new sponsors, especially when they view the remarkably low running costs of FABHD. An increasing number of sponsors have downloaded a Gift Aid form and Banker's Order and, instead of continuing to use Stewardship (whose administration charges were recently increased), now pay FABHD direct, saving costs and increasing the tax relief for FABHD via our Treasurer.
4. **Committee:** The Committee comprises Chairman, Treasurer, and six members.
5. **Albella Residents:** Following the pandemic, things have almost returned to normal although some boys have gone down with fevers and coughs over the last few months which has kept Ebi busy. Heshron has been actively looking for boys that can be helped and there are now 107 boys although this is still below pre-pandemic levels. It is hoped that more boys will be able join this year.
6. **Sponsors:** Each committee member takes on the responsibility to find at least one new sponsor or significant donation each year. Most sponsors remain with Albella for 10-20 years, and some much longer, and this loyalty is much appreciated. Inevitably there is some turnover of sponsors (below 10% each year) through death, old age, and changing circumstances especially when times are tough.

7. **Water problems:** The supply from the bore well which was drilled in 2016 has provided a much-needed supply of fresh water with this well being able to produce in excess of 2,000 litres of water daily. The Monsoon this year has caused no serious problems at Albella and all the underground water tanks are filled to capacity: this with the bore well supply eases the water problems at Albella. During this season of forced closure the demand for water has reduced significantly but Heshron, the staff and the boys are very careful not to waste this precious commodity.
8. **Gas:** The high cost of cooking gas continues although the supply has been much better during this year, and the usage of gas has been greatly reduced.
9. **Landslides and earthquakes:** There has been no experience of earthquakes during this reporting year but there were significant floods which washed away the road to Siliguri.
10. **Computers:** The introduction of new computers remains an issue. One of the problems associated with their introduction is the very poor internet connectivity in the area but we remain keen to resolve the whole issue as we believe that it will greatly assist the older boys with their studies for their higher-class examinations. We still intend to supply each teacher in the Bon Ami school with a device and a screen to allow the teachers to move away from writing everything with chalk on a blackboard. The teachers will be able to download information of interest and use that information within the classrooms.
11. **Reserves policy:** Our reserves policy remains unchanged, that is broadly not to build up reserves in the absence of a specific project. The cash held at the year-end in part reflects an accumulation of General donations the use of which is under discussion with the Principal. These discussions were put on hold due to the Covid 19 crisis, but we hope to move things forward this year. Although the pandemic restrictions have been lifted, we have experienced a number of problems transferring funds to India this year. We believe these have now been resolved, with the help of our bank and we plan to increase the amount we send this year.

### **A: Overview**

Founded by two British Missionaries in 1961 in Kalimpong in Darjeeling District, India, Albella is a home and school run on Christian values but respectful of all religions by an all-Indian staff. It currently gives free education to approximately 140 children mostly aged 5-19 (compared with 241 pre-Covid), comprising approximately 100 boys and 40 girls. The reduction of approximately 100 children is due to non-returners after the pandemic. The home is in the process of checking on those who have not returned and slowly offering available places again to families in need. The girls all live with their parents who are too poor to be able to send them to school. All residents are invited to daily morning & evening prayers & Sunday service but many remain Hindus and there are a few Buddhists.

Albella has two sites, Senior and Junior, separated by a two minute walk. Though the main Senior site is not owned but rented for a small sum, it is permanently secured under Indian law. Albella Boys Home part-owns the leasehold of the Junior site where it has its own Bonami Primary School.

### **A typical day**

The Principal, Heshron Rahmi, and his wife Ebi (who retired as a very senior doctor in 2012), live on the main site and get up at sunrise about 5am, followed by the Senior secondary boys, who do over an hour's study and some gardening duties before breakfast and prayers. All meals are served on the Senior site in the dining room that can hold 140+. Prayers and Sunday services are held in the meeting room that can hold 200 for those who wish to attend.

Cooking is mostly by gas even though gas cylinder prices have tripled in recent years. Many vegetables are grown in the garden, supervised by Ebi who is a keen gardener (and prize-winning orchid grower!). Bonami's two cows give each boy some milk two or three times a week but powdered milk is always used for tea. All residents are given two meals a day at 7am and 6pm, usually rice, dal, vegetable curry, including meat & egg thrice in a week. The boys who walk to one of three secondary schools drink only water during the day but get tea when they return at 3.30pm. The Bonami Primary boys are given their free tea & snacks at noon. After sunset about 6.30pm, the big boys study till prayers at 8.30pm, whereas smaller boys have prayers at 7pm before bed at 7.30. Prayers lasting 15-20 minutes include a Bible-based talk (using the Bible they are each given on entry to ABH) and some lively singing, using talented musicians on drums, guitars and flutes. For recreation Albella has its own fenced-in basketball/volleyball ground; the use of a nearby field for football and cricket; two TVs (one on each site); a table tennis room; and a gym for the older boys. Most of the boys are Nepali (Gurkhas). Only occasionally are they naughty – punishments are cleaning drains or carrying manure; but expulsion follows drug use or smoking.

### **Costs and donations**

There are three main sources of funds for Albella: sponsors of resident boys (mostly in the UK) - individuals, churches, schools, or groups like Rotary; occasional donors; and a Danish agency funds most of Bonami Primary School costs and some capital projects.

**Each UK sponsor is given the name and photo of a particular resident boy whose annual total costs are estimated to be £336 so sponsors have been encouraged to try to meet that target or £28 per month.**

By signing a Gift Aid form, the target has been only £268.80 per annum or £22.40 per month, given directly to Albella Boys Home. This pays for the boy's accommodation, food, clothes, school fees, two sets of uniform, books, stationery, shoes, socks, tie, tiny pocket money (with extra for Independence Day 15<sup>th</sup> August), birthday and Christmas presents. All boys are treated equally, so they each get similar presents on the one Birthday Day in July and at the Christmas party. Many sponsors give much more than our target and the surplus is used for the benefit of the home. A small proportion of that target figure goes towards funding the following: Albella's adjacent Bonami Primary School with its eight classes from Nursery to Class V; staff costs including our Principal, Heshron Rahmi; food-transporting vehicles; and the new photo and letter each Christmas giving sponsors the pleasure of reading about and seeing the changes in their boy or girl as they grow up.

The handful of sponsors who fund the education of girls are also given the name and photo of their own girl. As these girls are non-resident, costs are much lower, requiring an annual target figure of £100, approximately 1/3<sup>rd</sup> of the costs of a resident boy.

## **Management**

There are two committees, one in India and FABHD in the UK. They exchange their minutes and accounts and their comments on them. Email contact between the Principal, Heshron, and the UK officers is usually weekly, and at times more frequently between Heshron and the UK Chairman. Heshron's management is so good there is no need for regular visits to Albella. A self-funded visit was made in May 2023 by the chairman, Mark Brett and his wife Sarah (a committee member) and their son.

The Indian Management Committee consists of 6 volunteers and the Principal who writes the minutes. Its Chairman is a retired lecturer from Kalimpong Government College. Her name is Mrs Rinzi Namchu. Her late husband was a pastor and principal of Mirik Bible School. Albella Boys Home Trust is registered in India under the Indian Societies Registration Act 1860, Charitable Trust Deed no.Trust/718/10A/VOL/BI/A-109. Albella is also registered for receiving foreign grants (FCRA no.146980019) with the Ministry of Home Affairs, New Delhi. Its accounts are audited in India and those audited statements of accounts go to India's Ministry of Home Affairs and also to the Indian Government's Income Tax Department, both online and hard copies.

Friends of Albella Boys Home, Darjeeling (FABHD), a society, which was registered as a charity with the UK Charity Commission in 2014, retained its working name of Albella Boys Home so no change was needed to bank accounts or to regular bank gifts from sponsors. The FABHD Committee pays the Principal an annual allowance, which is the only salary he receives. A further allowance to help him when he retires, that had been built up over the years, was transferred to him in 2017-18. ## FABHD Committee's Report for the year ended 31st July 2022

**Section A: Overview of history, numbers, typical day, costs, and management.**

### A: Overview

Founded by two British Missionaries in 1961 in Kalimpong in Darjeeling District, India, Albella is a home and school run on Christian values but respectful of all religions by an all-Indian staff. It currently gives free education to approximately 140 children mostly aged 5-19 (compared with 241 pre-Covid), comprising approximately 100 boys and 40 girls. The reduction of approximately 100 children is due to non-returners after the pandemic. The home is in the process of checking on those who have not returned and slowly offering available places again to families in need. The girls all live with their parents who are too poor to be able to send them to school. All residents are invited to daily morning & evening prayers & Sunday service but many remain Hindus and there are a few Buddhists.

Albella has two sites, Senior and Junior, separated by a two minute walk. Though the main Senior site is not owned but rented for a small sum, it is permanently secured under Indian law. Albella Boys Home part-owns the leasehold of the Junior site where it has its own Bonami Primary School.

### **A typical day**

The Principal, Heshron Rahmi, and his wife Ebi (who retired as a very senior doctor in 2012), live on the main site and get up at sunrise about 5am, followed by the Senior secondary boys, who do over an hour's study and some gardening duties before breakfast and prayers. All meals are served on the Senior site in the dining room that can hold 140+. Prayers and Sunday services are held in the meeting room that can hold 200 for those who wish to attend.

Cooking is mostly by gas even though gas cylinder prices have tripled in recent years. Many vegetables are grown in the garden, supervised by Ebi who is a keen gardener (and prize-winning orchid grower!). Bonami's two cows give each boy some milk two or three times a week but powdered milk is always used for tea. All residents are given two meals a day at 7am and 6pm, usually rice, dal, vegetable curry, including meat & egg thrice in a week. The boys who walk to one of three secondary schools drink only water during the day but get tea when they return at 3.30pm. The Bonami Primary boys are given their free tea & snacks at noon. After sunset about 6.30pm, the big boys study till prayers at 8.30pm, whereas smaller boys have prayers at 7pm before bed at 7.30. Prayers lasting 15-20 minutes include a Bible-based talk (using the Bible they are each given on entry to ABH) and some lively singing, using talented musicians on drums, guitars and flutes. For recreation Albella has its own fenced-in basketball/volleyball ground; the use of a nearby field for football and cricket; two TVs (one on each site); a table tennis room; and a gym for the older boys. Most of the boys are Nepali (Gurkhas). Only occasionally are they naughty – punishments are cleaning drains or carrying manure; but expulsion follows drug use or smoking.

### **Costs and donations**

There are three main sources of funds for Albella: sponsors of resident boys (mostly in the UK) - individuals, churches, schools, or groups like Rotary; occasional donors; and a Danish agency funds most of Bonami Primary School costs and some capital projects.

**Each UK sponsor is given the name and photo of a particular resident boy whose annual total costs are estimated to be £336 so sponsors have been encouraged to try to meet that target or £28 per month.** By signing a Gift Aid form, the target has been only £268.80 per annum or £22.40 per month, given directly to Albella Boys Home. This pays for the boy's accommodation, food, clothes, school fees, two sets of uniform, books, stationery, shoes, socks, tie, tiny pocket money (with extra for Independence Day 15<sup>th</sup> August), birthday and Christmas presents. All boys are treated equally, so they each get similar presents on the one Birthday Day in July and at the Christmas party. Many sponsors give much more than our target and the surplus is used for the benefit of the home. A small proportion of that target figure goes towards funding the following: Albella's adjacent Bonami Primary School with its eight classes from Nursery to Class V; staff costs including our Principal, Heshron Rahmi; food-transporting vehicles; and the new photo and letter each Christmas giving sponsors the pleasure of reading about and seeing the changes in their boy or girl as they grow up.

The handful of sponsors who fund the education of girls are also given the name and photo of their own girl. As these girls are non-resident, costs are much lower, requiring an annual target figure of £100, approximately 1/3<sup>rd</sup> of the costs of a resident boy.

## Management

There are two committees, one in India and FABHD in the UK. They exchange their minutes and accounts and their comments on them. Email contact between the Principal, Heshron, and the UK officers is usually weekly, and at times more frequently between Heshron and the UK Chairman. Heshron's management is so good there is no need for regular visits to Albella. A self-funded visit was made in March 2019 by the then chairman, Alan Pickett (remains a committee member), one committee member (now chairman) Mark Brett, and his wife Sarah (now also a committee member).

The Indian Management Committee consists of 6 volunteers and the Principal who writes the minutes. Its Chairman is a retired lecturer from Kalimpong Government College. Her name is Mrs Rinzi Namchu. Her late husband was a pastor and principal of Mirik Bible School. Albella Boys Home Trust is registered in India under the Indian Societies Registration Act 1860, Charitable Trust Deed no.Trust/718/10A/VOL/BI/A-109. Albella is also registered for receiving foreign grants (FCRA no.146980019) with the Ministry of Home Affairs, New Delhi. Its accounts are audited in India and those audited statements of accounts go to India's Ministry of Home Affairs and also to the Indian Government's Income Tax Department, both online and hard copies.

Friends of Albella Boys Home, Darjeeling (FABHD), a society which was registered as a charity with the UK Charity Commission in 2014, retained its working name of Albella Boys Home so no change was needed to bank accounts or to regular bank gifts from sponsors. The FABHD Committee pays the Principal an annual allowance, which is the only salary he receives. A further allowance to help him when he retires, that had been built up over the years, was transferred to him in 2017-18. The Committee consists of volunteers and aims to meet, physically or virtually, twice a year for a 90 minute meeting. When meetings are physical, they are generally followed by lunch and take place in a different committee member's house each time. No travelling or hospitality expenses are given. Its offices are the homes of its unpaid officers, Chairman, Administrator and Treasurer. The Chairman's letter regularly encourages existing sponsors to join the committee. Those interested are invited first as observers after which the existing committee members decide on whether to approve the observer as a new committee member.

Total administration costs for 2021-22 were only £288 (£144 for our web hosting arrangements this year and the same for the previous year) equating to 0.67% of income. The main expenses are the cost of our website, postage, paper, ink, copying, but no advertising; otherwise, all money is available to India. Sponsors get only one postal mailing a year in early December, with a photo and a Christmas card, a report from Heshron, Treasurer's statement, and letter from the Chairman.

## **B. Relating to the year 1.8.21 to 31.7.22**

1. **Public benefit:** Having considered the Charity Commission's general guidance on public benefit, the Committee is confident that their Charity's activities meet the public benefit requirement.
2. **Constitution and accounts:** Our Constitution (as a society) and our accounts are on the website, along with this annual report. Thanks to Niall Burroughs, our accounts have again been finalised and published after an independent examination by Jeremy Evans FCA, who generously waives all fees.
3. **Communications:** As reported in 2019, we have registered the domain name [albellaboyshome.org.uk](http://albellaboyshome.org.uk) for a period of 10 years and the website [www.albellaboyshome.org.uk](http://www.albellaboyshome.org.uk) is operational but remains "work in progress". It is hoped that it will prove useful to existing donors and as a means of recruiting new sponsors, especially when they view the remarkably low running costs of FABHD. An increasing number of sponsors have downloaded a Gift Aid form and Banker's Order and, instead of continuing to use Stewardship (whose administration charges were recently increased), now pay FABHD direct, saving costs and increasing the tax relief for FABHD via our Treasurer.
4. **Committee:** The Committee, who are "Charity Trustees", said goodbye to Hugh Woodd who retired in November 2021, after being Treasurer over 8 years and thanked him for his faithful service. Niall Burroughs took over as Treasurer at the same time. The Committee therefore still comprises Chairman, Administrator, Treasurer, and four members.
5. **Albella Residents:** Due to the Coronavirus pandemic in India, all schools and hostels remained closed until November 2021 and students were sent home to their families. Only eight boys remained at Albella as they either had no close family or felt they would be a burden for their very poor mother. To alleviate hardship and possible starvation for the Albella boys, the day scholars at Bonami and the supported girls and their parent/guardian, Heshron was able to set up a scheme whereby essential grocery items and clothing could be obtained from selected stores. Regular maintenance of the compounds is carried out by staff who spend two weeks per month at Albella. On-line lessons for the Bonami pupils are offered by the Bonami teachers. The senior boys are also able to access on-line education, however the take up of these classes has been limited. When Albella reopened, only 96 boys returned as 44 decided to obtain work instead of continuing with their education. Heshron is actively looking for boys that Albella can help.

6. **Sponsors:** Each committee member takes on the responsibility to find at least one new sponsor or significant donation each year. Most sponsors remain with Albella for 10-20 years, and some much longer, and this loyalty is much appreciated. Inevitably there is some turnover of sponsors (below 10% each year) through death, old age, and changing circumstances especially when times are tough.
7. **Water problems:** The supply from the bore well which was drilled in 2016 has provided a much-needed supply of fresh water with this well being able to produce in excess of 2,000 litres of water daily. The Monsoon this year has caused no serious problems at Albella and all the underground water tanks are filled to capacity: this with the bore well supply eases the water problems at Albella. During this season of forced closure the demand for water has reduced significantly but Heshron, the staff and the boys are very careful not to waste this precious commodity.
8. **Gas:** The high cost of cooking gas continues although the supply has been much better during this year, and the usage of gas has been greatly reduced.
9. **Landslides and earthquakes:** There has been no experience of earthquakes during this reporting year. The monsoon season caused the main road to Siliguri to be closed on several occasions due to landslips and there was loss of life along that route.
10. **Computers:** The introduction of new computers remains an issue. One of the problems associated with their introduction is the very poor internet connectivity in the area but we remain keen to resolve the whole issue as we believe that it will greatly assist the older boys with their studies for their higher-class examinations. During our recent visit we were able to take this issue forward. We intend to supply each teacher in the Bonami school with a device and a screen to allow the teachers to move away from writing everything with chalk on a blackboard. The teachers will be able to download information of interest and use that information within the classrooms. However this too is on hold due to the pandemic shutdown.
11. **Reserves policy:** Our reserves policy remains unchanged, that is broadly not to build up reserves in the absence of a specific project. The cash held at the year-end in part reflects an accumulation of General donations the use of which is under discussion with the Principal. These discussions have been effectively put on hold due to the Covid 19 crisis, which crisis has also affected the normal transfers of sponsorship and other donations to India. There was, in addition, a period during which it was not possible to make bank transfers following the introduction of new requirements relating to "Foreign Contributions" in India. This is still an issue although a new license has been issued until March 2023 to allow bank transfers to take place.

## **A: Overview**

Founded by two British Missionaries in 1961 in Kalimpong in Darjeeling District, India, Albella is a home and school run on Christian values by an all-Indian staff. It gives free education to 232 children mostly aged 5-19 (compared with 241 in 2018-19), comprising 190 boys and 42 girls. The majority of the children who would now be at Albella but for the pandemic lockdown have one or both the parents living but in economically poor circumstances such that they cannot support their children for their education & upkeep. There are now only 5 boys who are totally orphans. The girls all live with their parents who are too poor to be able to send them to school. All residents attend daily morning & evening prayers & Sunday service, and some continue to be practising Christians after they leave, but many remain Hindus and a few Buddhists.

Albella has two sites, Senior and Junior, separated by a two minute walk. Though the main Senior site is not owned but rented for a small sum, it is permanently secured under Indian law. Albella Boys Home part-owns the leasehold of the Junior site where it has its own Bonami Primary School. The composition of the 232 children supported by Albella as at 23<sup>rd</sup> March 2020 at the start of the lockdown when the home effectively had to close (see B.5 on page 4), was as follows:

RESIDENTS 140 boys:

Albella Main site: 18 attending Bonami Primary School  
67 boys attending city high schools

Bonami Junior site: 55 boys (assisted by 4 resident elderly 'mothers') attending Bonami Primary School.

NON-RESIDENTS 92:

25 Bonami Day Scholars - all junior boys attending Bonami Primary School.

7 College B.A. students no longer resident.

42 Girls, all attending city schools: consisting of 17 non-resident girls funded by those FABHD sponsors who opted to fund girls and 25 non-resident girls funded by an agency in Denmark.

18 Denmark boys (funded by a Danish charity through Albella) who attend city high schools but live with their relatives.

BONAMI PRIMARY SCHOOL on Junior site: 98. In recent years, there has been an increase in the number of free Government primary schools in the area where children are also provided with a free mid-day meal. Also the living standard of the local people has risen sharply in the past few years. More parents are now in a position to support their children's education financially, preferring to send their children to a pay school rather than a charitable school. But wherever there is real need Albella will continue to take in more day scholars, and if there is room, more junior residents. Bonami pupils are taught in 8 different classes by 8 teaching staff plus 1 who is both Albella's electrician and the teacher of vocational electrical studies to Bonami standard V pupils. The medium of instruction is initially Nepali but becomes English from class IV upwards. Except for some textbooks to study Nepali and Hindi, all textbooks for other subjects are in English, helped by teachers' explanations in Nepali. The subjects throughout classes I to V are: English, Nepali, Hindi, Maths, Science, History/Social studies, General Knowledge, Scripture, and Drawing.

Cooking is mostly by gas even though gas cylinder prices have tripled in recent years. Many vegetables are grown in the garden, supervised by Ebi who is a keen gardener (and prize-winning orchid grower!). Bonami's two cows give each boy some milk two or three times a week but powdered milk is always used for tea. All residents are given two meals a day at 7am and 6pm, usually rice, dal, vegetable curry, including meat & egg thrice in a week. The boys who walk to one of three secondary schools drink only water during the day but get tea when they return at 3.30pm. The Bonami Primary boys are given their free tea & snacks at noon. After sunset about 6.30pm, the big boys study till prayers at 8.30pm, whereas smaller boys have prayers at 7pm

before bed at 7.30. Prayers lasting 15-20 minutes include a Bible-based talk (using the Bible they are each given on entry to ABH) and some lively singing, using talented musicians on drums, guitars and flutes. For recreation Albella has its own fenced-in basketball/volleyball ground; the use of a nearby field for football and cricket; two TVs (one on each site); a table tennis room; and a gym for the older boys. Most of the boys are Nepali (Gurkhas). Only occasionally are they naughty – punishments are cleaning drains or carrying manure; but expulsion follows drug use or smoking.

### **Costs and donations**

Albella has always been run on faith that God will provide the money. There are three main sources: sponsors of resident boys (mostly in the UK) - individuals, churches, schools, or groups like Rotary; occasional donors; and a Danish agency funds most of Bonami Primary School costs and some capital projects.

Each sponsor is given the name and photo of a particular resident boy whose annual total costs are estimated to be £336 so sponsors have been encouraged to try to meet that target or £28 per month. By signing a Gift Aid form, the target has been only £268.80 per annum or £22.40 per month, given directly to Albella Boys Home. This pays for the boy's accommodation, food, clothes, school fees, two sets of uniform, books, stationery, shoes, socks, tie, tiny pocket money (with extra for Independence Day 15<sup>th</sup> August), birthday and Christmas presents. All boys are treated equally, so they each get similar presents on the one Birthday Day in July and at the Christmas party. Many sponsors give much more than our target and the surplus is used for the benefit of the home. A small proportion of that target figure goes towards funding the following: Albella's adjacent Bonami Primary School with its eight classes from Nursery to Class V; staff costs including our Principal, Heshron Rahmi; food-transporting vehicles; and the new photo and letter each Christmas giving sponsors the pleasure of reading about and seeing the changes in their boy or girl as they grow up.

The handful of sponsors who fund the education of girls are also given the name and photo of their own girl. As these girls are non-resident, costs are much lower, requiring an annual target figure of £100, approximately 1/3<sup>rd</sup> of the costs of a resident boy.

### **Management**

There are two committees, one in India and FABHD in the UK. They exchange their minutes and accounts and their comments on them. Email contact between the Principal, Heshron, and the UK officers is usually weekly, and at times more frequently between Heshron and the UK Chairman. Heshron's management is so good there is no need for regular visits to Albella. A self-funded visit was made in March 2019 by the then chairman, Alan Pickett, one committee member (now chairman), Mark Brett, and his wife Sarah (now also a committee member). This was primarily to identify possible future projects that could be funded from UK. A total of seven projects to improve the facilities at Albella and Bonami were identified but have been put on hold due to the pandemic. They also spent a considerable time with the boys playing team games using sports equipment that was kindly donated by Mark and Sarah Brett.

The Indian Management Committee consists of 6 volunteers and the Principal who writes the minutes. Its Chairman is a retired lecturer from Kalimpong Government College. Her name is Mrs Rinzi Namchu. Her late husband was a pastor and principal of Mirik Bible School. Albella Boys Home Trust is registered in India under the Indian Societies Registration Act 1860, Charitable Trust Deed no.Trust/718/10A/VOL/BI/A-109. Albella is also registered for receiving foreign grants (FCRA no.146980019) with the Ministry of Home Affairs, New Delhi. Its accounts are audited in India and those audited statements of accounts go to India's Ministry of Home Affairs and also to the Indian Government's Income Tax Department, both online and hard copies.

Friends of Albella Boys Home, Darjeeling (FABHD), a society which was registered as a charity with the UK Charity Commission in 2014, retained its working name of Albella Boys Home so no change was needed to bank accounts or to regular bank gifts from sponsors. The FABHD Committee pays Heshron an annual allowance, which is the only salary he receives. A further allowance to help him when he retires, that had been built up over the years, was transferred to him in 2017-18. The Committee consists of volunteers and aims to meet, physically or virtually, twice a year for a 90 minute meeting. When meetings are physical, they are generally followed by lunch and take place in a different committee member's house each time. No travelling or hospitality expenses are given. Its offices are the homes of its unpaid officers, Chairman, Administrator and Treasurer. The Chairman's letter regularly encourages existing sponsors to join the committee. Those interested are invited first as observers after which the existing committee members decide on whether to approve the observer as a new committee member.

Total administration costs for 2020-21 were only £237.60 (£93.60 as shown in the accounts plus the creditor of £144 for our web hosting arrangements) equating to 0.48% of income. The main expenses are the cost of our website, postage, paper, ink, copying, but no advertising; otherwise all money is available to India. Sponsors get only one postal mailing a year in early December, with their boy's or girl's photo and letter, a report from Heshron, Treasurer's statement, and letter from the Chairman. We are pleased to report that we have received donations specifically to cover the cost of the website.

## **B. Relating to the year 1.8.20 to 31.7.21**

1. **Public benefit:** Having considered the Charity Commission's general guidance on public benefit, the Committee is confident that their Charity's activities meet the public benefit requirement.
2. **Constitution and accounts:** Our Constitution (as a society) and our accounts are on the website, along with this annual report. Thanks to Hugh Woodd, our accounts have again been neatly and quickly finalised and published after an independent examination by Jeremy Evans FCA, who generously waives all fees.
3. **Communications:** As reported in 2019, we have registered the domain name [albellaboyshome.org.uk](http://albellaboyshome.org.uk) for a period of 10 years and the website [www.albellaboyshome.org.uk](http://www.albellaboyshome.org.uk) is operational but remains "work in progress". It is hoped that it will prove useful to existing donors and as a means of recruiting new sponsors, especially when they view the remarkably low running costs of FABHD. An increasing number of sponsors have downloaded a Gift Aid form and Banker's Order and, instead of continuing to use Stewardship (whose administration charges were recently increased), now pay FABHD direct, saving costs and increasing the tax relief for FABHD via our Treasurer.
4. **Committee:** The Committee, who are "Charity Trustees", welcomed Niall Burroughs as a new Committee member at their meeting on 15<sup>th</sup> May 2021. He will take over as Treasurer when Hugh Woodd retires in November 2021. In November 2020, Caroline Brereton sadly felt obliged to resign as a Committee member due to her other commitments. The Committee therefore still comprises Chairman, Administrator, Treasurer, and five members.
5. **Albella Residents:** This year started quietly with no undue problems caused by the Gorkhaland independence movement for Albella Boys Home. Due to the Coronavirus pandemic in India, all schools and hostels were closed in March 2020 and students were sent home to their families. Only eight boys remained at Albella as they either had no close family or felt they would be a burden for their very poor mother. Albella, along with all schools and homes for children, remained closed at the time of writing this report and it is not expected that they will be allowed to re-open until November at the earliest. To alleviate hardship and possible starvation for the Albella boys, the day scholars at Bonami and the supported girls and their parent/guardian, Heshron was able to set up a scheme whereby essential grocery items and clothing could be obtained from selected stores. Regular maintenance of the compounds is carried out by staff who spend two weeks per month at Albella. On-line lessons for the Bonami pupils are offered by the Bonami teachers. The senior boys are also able to access on-line education, however the take up of these classes has been limited.
6. **Sponsors:** Each committee member takes on the responsibility to find at least one new sponsor each year. Most sponsors remain with Albella for 10-20 years, and some much longer, and this loyalty is much appreciated. Inevitably there is some turnover of sponsors (below 10% each year) through death, old age, and changing circumstances especially when times are tough.
7. **Water problems:** The mains water supply continues to be inadequate during the dry season, but the supply from the bore well which was drilled in 2016 has provided a much-needed supply of fresh water with this well being able to produce in excess of 2,000 litres of water daily. The Monsoon this year has caused no serious problems at Albella and all the underground water tanks are filled to capacity: this with the bore well supply eases the water problems at Albella. During this season of forced closure the demand for water has reduced significantly but Heshron, the staff and the boys are very careful not to waste this precious commodity.
8. **Gas:** The high cost of cooking gas continues although the supply has been much better during this year, and the usage of gas has been greatly reduced.
9. **Landslides and earthquakes:** There has been no experience of earthquakes during this reporting year. The monsoon season caused the main road to Siliguri to be closed on several occasions due to landslips and there was loss of life along that route.
10. **Computers:** The introduction of new computers remains an issue. One of the problems associated with their introduction is the very poor internet connectivity in the area but we remain keen to resolve the whole issue as we believe that it will greatly assist the older boys with their studies for their higher-class examinations. During our recent visit we were able to take this issue forward. We intend to supply each teacher in the Bonami school with a device and a screen to allow the teachers to move away from writing everything with chalk on a blackboard. The teachers will be able to download information of interest and use that information within the classrooms. However this too is on hold due to the pandemic shutdown.
11. **Reserves policy:** Our reserves policy remains unchanged, that is broadly not to build up reserves in the absence of a specific project. The cash held at the year-end in part reflects an accumulation of General donations the use of which is under discussion with the Principal. These discussions have been effectively put on hold due to the Covid 19 crisis, which crisis has also affected the normal transfers of sponsorship and other donations to India. There was, in addition, a period during which it was not possible to make transfers following the introduction of new requirements relating "Foreign Contributions" in India. These new requirements were finally satisfied in June. We received a large gift of £5,000 during 2018-19, which was paid over to India in the year 2019-20 for the general benefit of Albella Boys Home.
