Objects: FOR THE BENEFIT OF THE PUBLIC TO RELIEVE THE SUFFERING OF ANIMALS IN NEED OF CARE AND ATTENTION AND, IN PARTICULAR, TO PROVIDE AND MAINTAIN RESCUE HOMES OR OTHER FACILITIES FOR THE RECEPTION, CARE AND TREATMENT OF SUCH ANIMALS. TO PROMOTE HUMANE BEHAVIOUR TOWARDS ANIMALS BY PROVIDING APPROPRIATE CARE, PROTECTION, TREATMENT AND SECURITY FOR ANIMALS WHICH ARE IN NEED OF CARE AND ATTENTION, BY REASON OF SICKNESS, MALTREATMENT, POOR CIRCUMSTANCES OR ILL-USAGE AND TO EDUCATE THE PUBLIC IN MATTERS PERTAINING TO ANIMAL WELFARE IN GENERAL AND THE PREVENTION OF CRUELTY AND SUFFERING AMONG ANIMALS.

Activities: RESCUE AND WELFARE OF NEGLECTED, ILL-TREATED AND ABANDONED ANIMALS. OPERATION OF A RESCUE CENTRE FOR A VARIETY OF RODENTS, FELINES, EQUINES, REPTILES, FISH AND CANINES. PROVIDING MAINTENANCE, VETERINARY AND GENERAL HEALTH-CARE. RELIEVING THE PUBLIC OF THE STRESS OF CARING FOR ANIMALS THEY CAN NO LONGER AFFORD TO KEEP. EDUCATING THE PUBLIC IN ANIMAL-WELFARE AND RELATED ISSUES.
