Objects: THE RELIEF OF THE PHYSICAL AND MENTAL SICKNESS OF PERSONS IN NEED BY REASON OF ADDICTION, IN PARTICULAR BY THE PROVISION OF ACCESS TO COUNSELLING AND SUPPORT. THE RELIEF OF FINANCIAL HARDSHIP AMONG PEOPLE LIVING IN OR WITH ADDICTION BY PROVIDING SUCH PERSONS WITH ACCESS TO TREATMENT WHICH THEY COULD NOT OTHERWISE AFFORD THROUGH LACK OF MEANS. THE RELIEF OF FINANCIAL HARDSHIP, EITHER GENERALLY OR INDIVIDUALLY, OF PEOPLE CURRENTLY RECEIVING TREATMENT FOR ADDICTION IN WESTERN COUNSELLING BY PAYING FOR ITEMS TO MEET BASIC COMFORT NEEDS - E.G. CLOTHING, TOILETRIES, SERVICES FOR GENERAL HEALTH AND WELLBEING. THE RELIEF OF FINANCIAL HARDSHIP, EITHER GENERALLY OR INDIVIDUALLY, OF PEOPLE LIVING IN GENESIS RECOVERY HOUSING BY PAYING FOR ITEMS TO ACHIEVE EMPLOYMENT OR FULL INDEPENDENT LIVING - E.G. CLOTHING, TOILETRIES, STATIONERY, BASIC HOUSEHOLD ITEMS, SERVICES FOR GENERAL HEALTH AND WELLBEING.

Activities: assisting addicted individuals and their families by providing access to treatment/counselling.
