Report of the Management Committee

The management committee, whose members are the trustees of Streatham Drop-in Centre, presents its report and independently examined financial statements for the year ending 31st March 2025.

Status

The charity's constitution is its governing document. The charity was registered on 8th June 2004 and 1st April 2005 took over all assets, liabilities and operations from the unincorporated association of the same name.

Charity's Objective

The charity's main objective is to support people who are refugees, asylum seekers and/or those who are similarly disadvantaged.

Annual Review

- The treasurer of the charity and the trustees stepped down from their roles from the charity the annual review for the charity; the process is extremely demanding since the trustees stepped down.
- Further to the above, the treasurer's signature could not be attested, we have not onboarded a new treasurer.

Following the short of trustees, the SDIC team is working hand in hand to ensure that the family learning services maintains relationships in the community and work in partnership with other charities to deliver a wide range of educational, musical and outdoor activities to the communities we are set up to support.

The major organisational changes have caused the charity a lot of slowed experience with the departure of the co-ordinator who stepped down because of health issues, and the constraints in funding prevented the remaining board of trustees to re-hire a coordinator. Therefore, the trustees started to provide direct support and oversight to the staff to enable the continuation of our services but also to establish a funding strategy and execute it.

We comment that despite all odds, the Streatham drop-in Centre for Asylum Seekers and Refugees has proven that, even in the hardest of times, it strives to

respond to the needs of the most vulnerable and provides holistic services which include family learning for both children and parents, Health advice and advocacy as well as welfare support for users experiencing extreme poverty.

Homework & Family Learning

Our team continued to inspire the parents by involving them in the organising of community, cultural, and religious events, creating networks among them and showing them how best to contribute to their community and personal development despite major organisational challenges and reduction in funding.

Advice & Support Services

Our advice lead support by:

- Ensuring access to Lambeth emergency support, health and housing services as well as Lambeth foodbank
- Enabling continuation and facilitation of health and immigration advice from Lambeth.

Our Supporters

Streatham Drop-In Centre relied on the previous donors for grants.

We also wish to thank local faith communities English Martyrs Church, St Peters Church, Clapham Methodist Church, Music For Children and Faith Together in Lambeth, together with Downings LLP, Streatham Food Festival and many other individual donors and volunteers, for reassuring of their contributions and support.

Financial review

The charity started the financial year 2024/2025 with reserves that were restricted, since the departure of our treasurer made this aspect challenging, we are actively looking for a new treasurer. However, we have not received any grants or donations this year. Our reserves policy is to hold three to six months running costs in free reserves as recommended by the Charity Commission. Our budgeted expenditure for 2023/24 is £45,000. We aim to hold between £21,000 and £42,000 in unrestricted funds.

The Trustees responsibilities

The trustees are required under the constitution of the charity to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of its results for that period. In preparing those financial statements the trustees are required to:

- a) select suitable accounting policies and apply them consistently.
- b) make judgments and estimates that are reasonable and prudent; and
- c) prepare the financial statement on a going concern basis unless it is inappropriate to assume that the charity will continue in business.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity. They are responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Public Benefit

The trustees confirm that they have complied with the duty in Section 4 of the Charities Act 2011 to have due regard to the Charity Commission's general guidance on public benefit, 'Charities and Public Benefit'.

Notes to the accounts

1. Accounting Policies

Basis of accounting: These financial statements have been prepared in accordance with the charity's constitution, the Charities Act 2011 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2016). The charity is a Public Benefit Entity as defined by FRS 102.

The accounts are prepared in sterling, which is the functional currency of the charity.

The accounts have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

Going concern

At the time of approving the financial statements, the trustees have a reasonable expectation that the CIO has adequate resources to continue in operational existence for the foreseeable future. The trustees therefore continue to adopt the going concern basis of accounting in preparing the financial statements.

Tangible fixed assets: Capitalisation threshold of £250 applies and any capitalised items are depreciated at the rate of 25% per annum on cost.

Fund accounting: Funds held by the charity are either:

- unrestricted general funds: these are funds which can be used in accordance with the charitable objects at the discretion of the Executive Committee;
- restricted funds: these are funds which can only be used for particular restricted purposes within the objects of the charity, restrictions arise when specified by the donor or when funds are raised for particular restricted purposes

Investment policy is to account for interest as and when received.

Incoming resources: voluntary income received in the form of grants and donations is recognised in the Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on specific performance, are recognised when the charity becomes unconditionally entitled to the grant.

Resources expended: Expenditure is recognised on an accruals basis as a liability is incurred.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity, and include the independent examiners fee and costs associated with the management of the charity

Taxation: The charity is provisionally exempt from tax on income and gains to the extent that these are applied to its charitable objects. No tax charges have arisen in the charity.

2. Principal Funders

The Walcott Foundation granted 3-year funding totalling £75,000. This grant started on August 1 2020

BBC Children in Need Appeal granted 3-year funding totalling £85,136. This grant started on October 1 2018.

The Trust for London gave 1-year funding totalling £29,061 for 2021/22.

Report of the Management Committee

The management committee, whose members are the trustees of Streatham Drop-in Centre, presents its report and independently examined financial statements for the year ending 31st March 2022.

Status

The charity's constitution is its governing document. The charity was registered on 8th June 2004 and 1st April 2005 took over all assets, liabilities and operations from the unincorporated association of the same name.

Charity's Objective

The charity's main objective is to support people who are refugees, asylum seekers and/or those who are similarly disadvantaged.

Annual Review

After responding effectively to the challenges posed by the pandemic and embedding the provision of services remotely by listening to our users and learning new ways of working, the SDIC team worked tirelessly to successfully maintain our services as well as meticulously and safely plan for the return to the charity premises and face-to-face meetings with our users. Initially focussing on the family learning support for children and adults as the priority was to address the impacts of isolation experienced by children following extended lockdowns.

It was in fact a very difficult year for the team as the charity coordinator was on leave for health reasons for a substantial part of that year (total of 4 members of staff in 21-22). Besides, the availability of volunteers was very scarce until the very end of the lockdown. The high turnaround of trustees at the end of the year added to the challenge faced by the staff, who still provided new trustees with the input and information required to conduct their reviews in the absence of the charity coordinator.

Streatham drop-in Centre for Asylum Seekers and Refugees demonstrated that, even in the hardest of times, it strives to respond to the needs of the most vulnerable and provides holistic services which include family learning for both children and parents including English For Speakers of Other Languages (ESOL), Health advice and advocacy as well as welfare support for users experiencing extreme poverty.

Homework & Family Learning

Our homework and family learning showed very high levels of resilience and a strong capability to adapt, consistently achieving high attendance throughout the pandemic from both children and parents during their weekly online sessions. The process of returning to the "classroom" settings was managed very smoothly and within a strict covid-19 safety protocol, the children and parents were welcomed back in new temporary premises in Sep-21 due to works being conducted at English Martyrs church hall. Our family learning homework support leader shortlisted and visited suitable and affordable premises to

resume face-to-face services in September 2021. They also ensured the children re-joined the highly impactful young growers' project which provided interactive outdoor and educational activities within the Streatham Community Gardens. With the relaxation of the rules, the children also enjoyed a visit to the cinema before Christmas, followed by a small party with Christmas presents that were also donated by another charity (mainly books and toys).

The funders were very impressed with the progress of the children based on the end of year report as well as the continuation of services to vulnerable children during the pandemic therefore they decided to extend the funding for another three years.

Advice & Support Services

Our advice services also performed exceptionally despite the lack of face-to-face contacts. Our advice lead supported many vulnerable and destitute families on a range of issues (made worse by the partial closure of many public services) by:

- Facilitating access to Lambeth covid emergency support and Lambeth foodbank with weekly groceries, nappies, formulae milk, wipes (forms had to be filled in weekly on behalf of many families to enable weekly deliveries throughout the pandemic, 4 pages of forms for each delivery which was very time consuming),
- Supporting victims of domestic violence which unfortunately increased during this time,
- Enabling continuation and facilitation of online health and immigration advice from Lambeth,
- Supporting families with special needs, as no specialist care was available, by providing tools and advice to keep children busy and stimulated, sending as many toys and books that the charity could find through donations and initiatives.

Acknowledgements

All this would not have been possible without the continuing support of our funders throughout this difficult time including and not limiting to BBC Children In Need, The Walcott Foundation, The Borough Cadbury Trust, Trust For London and all our individual donors. We are immensely grateful for their support.

Financial Review

The charity began the financial year 2021/22 with reserves of £55,569 of which £41,527 were unrestricted. There was a surplus for the year on unrestricted funds of £1,843. At 31st March 2022 there were unrestricted funds carried forward of £43,370 and restricted funds totalling £7,426. Our reserves policy is to hold three to six months running costs in free reserves as recommended by the charity commission. Our budgeted expenditure for 2022/2023 is £80,000. We aim to hold between £21,000 and £42,000 in unrestricted funds.

Despite the difficult year and constraints in receiving new grants and donations, the trustees are confident the charity stands in good financial stead.





Independent Examiner's report to the Trustees of the Streatham Drop-in Centre

I report on the accounts of the charity for the year ended March 31 2022, which are set out on pages 6 to 12.



Notes to the accounts

1. Accounting Policies

Basis of accounting: These financial statements have been prepared in accordance with the charity's constitution, the Charities Act 2011 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2016). The charity is a Public Benefit Entity as defined by FRS 102.

The accounts are prepared in sterling, which is the functional currency of the charity.

The accounts have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

Going concern

At the time of approving the financial statements, the trustees have a reasonable expectation that the CIO has adequate resources to continue in operational existence for the foreseeable future. The trustees therefore continue to adopt the going concern basis of accounting in preparing the financial statements.

Tangible fixed assets: Capitalisation threshold of £250 applies and any capitalised items are depreciated at the rate of 25% per annum on cost.

Fund accounting: Funds held by the charity are either:

- unrestricted general funds: these are funds which can be used in accordance with the charitable objects at the discretion of the Executive Committee;
- restricted funds: these are funds which can only be used for particular restricted purposes within the objects of the charity, restrictions arise when specified by the donor or when funds are raised for particular restricted purposes

Investment policy is to account for interest as and when received.

Incoming resources: voluntary income received in the form of grants and donations is recognised in the Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on specific performance, are recognised when the charity becomes unconditionally entitled to the grant.

Resources expended: Expenditure is recognised on an accruals basis as a liability is incurred.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity, and include the independent examiners fee and costs associated with the management of the charity

Taxation: The charity is provisionally exempt from tax on income and gains to the extent that these are applied to its charitable objects. No tax charges have arisen in the charity.

Report of the Management Committee

The Management Committee, whose members are the trustees of Streatham Drop-in Centre, presents its report and independently examined financial statements for the year ending 31st March 2021.

Status

The charity's constitution is its governing document. The charity was registered on 8th June 2004 and on 1st April 2005 took over all assets, liabilities and operations from the unincorporated association of the same name.

Charity's objectives

The charity's main objective is to support people who are refugees, asylum seekers and/or those who are similarly disadvantaged.

Annual Review

In April 2020 our charity transformed from a bustling drop-in Centre to providing services remotely. We responded quickly to Covid-19 challenges. This was achieved by listening to users, learning new skills and developing new ways of working.

Streatham Drop-in Centre for Asylum Seekers and Refugees strives to respond to need and to provide holistic support. Services include advice and information, health advice and advocacy, English for Speakers of Other Languages (ESOL), creche and play, a woman's wellbeing activities and welfare support for users experiencing abject poverty.

Advice is provided on welfare and housing rights. People are introduced to a wide range of local services and where appropriate referred to specialist provision including legal and advocacy services.

Our health equality focus is enhanced through partnership agreement with the "Three Boroughs Health Inclusion Team, Guy's and St Thomas' NHS Foundation Trust." Their nurse, the refugee specialist caseworker, and a wellbeing specialist provide services so essential for our user group. The creche is often a gateway to Children Centre and primary school. Our homework and family learning initiative provides educational support for primary school children while empowering parents to play a greater role in their families education.

In response to Covid-19 we adapted existing services and developed new initiatives. The people we work with experience disadvantage, poverty, and exclusion. Many live in poor standard, overcrowded, temporary accommodation.

Covid-19 represents a major threat to people, who do not share the mainstream welfare safety net and when access to community and support networks is restricted.

In April 2020 we spoke to users and listened to their concerns. It was important to reassure people that although the Centre would be closed service delivery would continue, albeit remotely.

Responding to expressed needs we:

- strengthened access to basic living needs for people facing food insecurity
- provided updated Covid-19 advice in community languages
- generated ideas for home-creche and play with families
- provided additional support to children impacted by school closure
- increased the level of contact and support for elders and vulnerable households
- provided greater support to children with additional needs

Two COVID-19 initiatives developed:

We launched a Lambeth Crowdfunder to provide toys, books, and games for 150 children who experience exceptional poverty and lacked play opportunities during the "lockdown" period.

Our funding target of £5,250 was exceeded thanks to the generosity and support of local charities and community groups, trade unions, faith communities, and friends.

Most presents were delivered for Christmas 2020. This initiative also provided the opportunity to liaise and support the 66 participating families.

Provision of laptops, tablets, and mobiles to digitally excluded:

Covid-19 highlighted the impact of digital divide on the most disadvantaged. Families, no longer able to attend activities at the charity, asked for help with getting IT needed to support their children.

In collaboration with the then newly formed Lambeth TechAid, (now Community TechAid) we were able to roll out provision of laptops, tablets, and mobile phones. Participants in the homework and family learning group were among the first to receive revamped laptops. This allowed us to successfully adapt the model of service delivery to working remotely. Soon well organised, weekly online sessions were provided using digital platforms (Zoom). Likewise meeting with parents were conducted online.

This has been achieved by successful upskilling of staff team, children, and parents.

Streatham Drop-in Centre is grateful for grants from BBC Children in Need, Trust for London, London Churches Refugee Fund, The London Community Foundation, Thrale Almhouse and Relief in Need Charity and Barrow Cadbury Trust.

We are immensely grateful for donations from the Lambeth Foodbank Fund and individual donors.

Financial review

The charity began the financial year 2020/21 with reserves of £36,579 of which £10,698 were restricted. There was a surplus for the year on unrestricted funds of £15,646. At 31 March 2021 there were unrestricted funds carried forward of £41,527 and restricted funds totalled £14,042. Our reserves policy is to hold three to six months running costs in free reserves as recommended by the Charity Commission. Our budgeted expenditure for 2021/22 is £84,000. We aim to hold between £21,000 and £42,000 in unrestricted funds.

Statement of trustees' responsibilities

The trustees are required to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the CIO and of its results for that period. In preparing those financial statements the trustees are required to:

- a) Select suitable accounting policies and apply them consistently;
- b) Make judgments and estimates that are reasonable and prudent;
- c) Prepare the financial statements on a going concern basis unless it is inappropriate to assume that the charity will continue in existence.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity. They are responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Public Benefit


