GIVE SANCTUARY FOR THOSE DEEMED UNSUITABLE FOR REHOME DUE TO AGE, ILL HEALTH OR DISABILITY. PROMOTE IMPROVED CARE AND WELFARE OF SMALL ANIMALS VIA EDUCATION OF THE GENERAL PUBLIC. PROVIDE FREE ADVICE AND INFORMATION FOR THE GENERAL PUBLIC BY HOLDING AND ATTENDING PUBLIC EVENTS TO IMPROVE ANIMAL WELFARE.
