REPORT OF THE TRUSTEES

The Trustees of The Friends of the National Museum of Bermuda (UK), a Charitable Incorporated Organisation, (the Charity) present their Annual Report and Financial Statements for the year ended 5 April 2025. These comply with the governing documents of the Charity, the relevant Statement of Recommended Practice (the Charities SORP 2015), Financial Reporting Standard 102 and the Charities Act 2011.

The Friends of the National Museum of Bermuda (UK) was incorporated, and recognised as a Charity in England and Wales, on 15 May 2014. It operates under a standard Charitable Incorporated Organisation (CIO) Constitution, which was adopted formally by the Trustees of the Charity on 2 December 2014.

OBJECTS OF THE CHARITY

The objects of the Charity are:

- to promote and foster research (and to publish such research) on any territorial and maritime historical subjects whether or not relating to the Museum or the Islands of Bermuda; and
- to promote the permanent preservation of such maritime artefacts and relics of historical archaeological and technical interest as the Trustees may consider appropriate wheresoever the same shall be situated; and
- to promote and maintain in perpetuity the Museum and the historical buildings and gun emplacements within the area of the historic fortifications of the old Royal Naval Dockyard situate at the northern end of the Ireland Island within the Parish of Sandys in Bermuda as a maritime museum for the study and general knowledge of all maritime subjects for the enjoyment of and with the object of advancing the education of the public.

GOVERNANCE AND MANAGEMENT

The Trustees manage the activities of the Charity and meet formally at least once a year. There is contact and correspondence as necessary throughout the year as business of the Charity demands.

As required by the Charity's Constitution, the Trustees serve for three-year terms, which are renewable. Trustees who served during the year ended 5 April 2025 are:

ACTIVITIES AND OPERATIONS FOR THE YEAR ENDED 5 April 2025

During the financial year ended 5 April 2025, the Charity continued to receive the remaining installments of pledges made to the National Museum of Bermuda's multi-year *Future of History* campaign, which officially came to an end in September 2022, with pledges due by the end of calendar 2025. A total of £76,877 was raised by the Charity towards the campaign. The *Future of History Campaign* raised well over its US\$8,500,000 target to preserve and share Bermuda's history, heritage and culture for residents, visitors, and those interested in Bermuda's pivotal role in the Atlantic World's history. The campaign proceeds are being used to underpin education programmes to students, teachers and everyone interested in Bermuda, as well as provide for expansion, and to ensure operational stability.

Integral to the expansion pillar is stabilising and drying-out the Casemates Barracks, built for the Royal Marines between 1839-43. This work began during the 2025 financial year and included making the building watertight, an important step in the multi-year restoration project. The Barracks are the some of the oldest surviving buildings in the Bermuda Historic Naval Dockyard and are an important example of British naval and military-built heritage. When fully restored, Casemates Barracks will house both the Bermuda National Archives and the Centre for Atlantic World History. See also <https://nmb.bm/campaign/> for further information. £2,300 (2024: £5,650) in respect of pledges made during the Campaign was received during the 2025 financial year. The Charity also continued to collect modest donations to support the ongoing operations of the National Museum of Bermuda.

In addition, further subscriptions to support the publication of *Bermuda Sentinel: The Royal Naval Base 1795-1950*, an authoritative history of the Bermuda Historic Naval Dockyard and its buildings by Dr Jonathan Coad, FSA, a Trustee of the Charity were received. UK-based Subscribers donated £6,826 (2024: £1,050) towards this publication during the 2025 financial year.

Grants of £19,352 were made in 2025 (2024: £0), of which £18,152 (2024: £0) supported the Future of History Campaign, and £1,200 (2024: £0) represented subscriptions to *Bermuda Sentinel*.

The Trustees continuously review the Charity's operating procedures and consider revisions to its risk management and compliance procedures to reflect current best practice. The Trustees have also reviewed the Charity's financial systems and procedures.

PUBLIC BENEFIT

The Trustees have complied with their duty to have due regard to the Charity Commission's public benefit guidance when exercising their powers and duties to which that guidance is relevant. In providing practical and financial support for the National Museum of Bermuda the Trustees are satisfied that they contribute public benefit both to the preservation of important aspects of Bermuda and British heritage and to historical education at every level from primary through tertiary and post-graduate study.

GENERAL DATA PROTECTION REGULATION

The Trustees have reviewed carefully the extent to which the General Data Protection Regulation (GDPR) affects the Charity. In July 2019, the Charity adopted a Privacy Policy that complies with the

GDPR. All members of the Charity have received a copy of the revised policy, which is available on request from the Registered Office.

For the purposes of the GDPR, and as stated in the Charity's Privacy Policy, the Treasurer is the Charity's Data Controller and Data Processor.

TRUSTEES' AND EXECUTIVE COMMITTEE'S RESPONSIBILITIES IN THE PREPARATION OF FINANCIAL STATEMENTS

The Trustees (who are also the Executive Committee of the Charity) are responsible for preparing the Trustees' Annual Report and Financial Statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

In preparing those financial statements, the Trustees are required to:

- Select suitable accounting policies and then apply them consistently;
- Observe the methods and principles in the Charities SORP;
- Make judgements and estimates that are reasonable and prudent;
- State whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Charity will continue on that basis.

The Trustees and Executive Committee are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the financial statements comply with the applicable law. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The Trustees are responsible for the maintenance and integrity of the corporate and financial information on the Charity Commissioners' website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

Risk Management

The major risks to which the Trustees believe the Charity is exposed are discussed at Trustee meetings and are reviewed at least annually. The Trustees believe that, as far as is practical, these risks are managed in an appropriate manner.

The Charity's governing documents and policies are reviewed regularly to ensure that they keep pace with developments in best practice.

Grant making policy

At present, the Charity only awards grants in support of projects proposed by the National Museum of Bermuda, which are reviewed and approved by the Trustees of the Charity before being made. Grants of £19,352 were made to the National Museum of Bermuda during 2025 (2024: £0).

Reserves

The Trustees' policy with regard to reserves is to make suitable expenditure on the ongoing activities of the Charity, whilst maintaining adequate funds to deal with current and medium term needs and having the necessary provision to deal with unforeseen circumstances. As at 5 April 2025, the Charity's free reserves were £13,578 (2024: £22,604).

Going Concern

After making appropriate enquiries, the Trustees have a reasonable expectation that the Charity has adequate resources to continue in operational existence for the foreseeable future. For this reason they continue to adopt the going concern basis in preparing the financial statements.

Independent examiner

In view of the scale of the Charity's activities and net assets, neither an independent examination nor an audit of the Financial Statements is required. However, the Trustees have resolved to have an independent examination, and this has been carried out by Sue Kowszun BA FCA DChA.

ACTIVITIES AND OPERATIONS FOR THE YEAR ENDED 5 April 2024

During the financial year ended 5 April 2024, the Charity continued to receive pledges made to the National Museum of Bermuda's multi-year *Future of History* campaign, which officially came to an end in September 2022, with pledges due by the end of 2024. The Chairman and Honorary Treasurer acted as co-chairs of the UK and US Friends Division of the Campaign and the UK Friends were successful in securing donations towards the Campaign (some spread over several years), exceeding the target set for the UK. The *Future of History Campaign* aimed to raise US\$8,500,000 to preserve and share Bermuda's history, heritage and culture for residents, visitors, and those interested in Bermuda's pivotal role in the Atlantic World's history. The campaign proceeds will underpin education programmes to students, teachers and everyone interested in Bermuda, as well as provide for expansion, and to ensure operational stability.

Integral to the expansion pillar is stabilising and drying-out the Casemates Barracks, built for the Royal Marines between 1839-43. This work began during the 2024 financial year. The Barracks are the some of the oldest surviving buildings in the Bermuda Historic Naval Dockyard and represent important examples of British naval and military-built heritage. It is intended that the Casemates will become home to both the Bermuda National Archives and the Centre for Atlantic World History. See also <https://nmb.bm/campaign/> for further information. £5,650 (2023: £10,327) in respect of pledges made during the Campaign was received during the 2024 financial year. The Charity also continued to collect modest donations to support the ongoing operations of the National Museum of Bermuda.

In February 2024, UK-based supporters of the National Museum of Bermuda were invited to subscribe to the publication of *Bermuda Sentinel: The Royal Naval Base 1795-1950*, an authoritative history of the Bermuda Historic Naval Dockyard and its buildings by Dr Jonathan Coad, FSA, a Trustee of the Charity. UK-based Subscribers donated £1,050 (2023: £0) towards this publication during the 2024 financial year.

No grants were made in 2024. In 2023, a grant of £4,225 was made, of which £2,000 was to support operations in Bermuda (helping to mitigate the effects of multiple forced closures during the Covid-19 pandemic) and £2,225 to support the Future of History Campaign.

The Trustees continuously review the Charity's operating procedures and consider revisions to its risk management and compliance procedures to reflect current best practice. The Trustees have also reviewed the CIO's financial systems and procedures.

ACTIVITIES AND OPERATIONS FOR THE YEAR ENDED 5 April 2023

During the financial year ended 5 April 2023, the CIO was actively involved in the National Museum of Bermuda's multi-year *Future of History* campaign, which officially came to an end in September 2022. The Chairman and Honorary Treasurer acted as co-chairs of the UK and US Friends Division of the Campaign and the UK Friends were successful in securing donations towards the Campaign (some spread over several years), exceeding the target set for the UK. £10,327 (2022: £54,150) was received during the 2023 financial year. The CIO also continued to collect modest donations to support the ongoing operations of the National Museum of Bermuda.

The National Museum of Bermuda *Future of History Campaign* aimed to raise US\$8,500,000 to preserve and share Bermuda's history, heritage and culture for residents, visitors, and those interested in Bermuda's pivotal role in the Atlantic World's history. The campaign proceeds will underpin education programmes to students, teachers and everyone interested in Bermuda, as well as provide for expansion, and to ensure operational stability. Integral to the expansion pillar is stabilising and drying-out the Casemates Barracks, built for the Royal Marines between 1839-43. The Barracks are some of the oldest surviving buildings in the Bermuda Historic Naval Dockyard and represent important examples of British naval and military-built heritage. It is intended that the Casemates will become home to both the Bermuda National Archives and the Centre for Atlantic World History. See also <https://nmb.bm/campaign/> for further information.

Grants of £4,225 were made in 2023 (2022: £60,000). Of this total, £2,000 (2022: £10,000) was to support operations in Bermuda (helping to mitigate the effects of multiple forced closures during the Covid-19 pandemic) and £2,255 (2022: £50,000) to support the Future of History Campaign.

The Trustees continuously review the CIO's operating procedures and consider revisions to its risk management and compliance procedures to reflect current best practice. The Trustees have also reviewed the CIO's financial systems and procedures.

ACTIVITIES AND OPERATIONS FOR THE YEAR ENDED 5 April 2022

Throughout the financial year ended 5 April 2022, the CIO was actively involved in the National Museum of Bermuda's multi-year *Future of History* campaign, which officially comes to an end in September 2022. The Chairman and Honorary Treasurer act as co-chairs of the UK and US Friends Division of the Campaign and were successful in securing donations towards the Campaign, (some spread over a few years) exceeding the target set for the UK, of which £54,150 was received during the 2022 financial year. The CIO also continued to collect modest donations to support the ongoing operations of the National Museum of Bermuda.

The National Museum of Bermuda *Future of History Campaign* aims to raise US\$8,500,000 to preserve and share Bermuda's history, heritage and culture for residents, visitors, and those interested in Bermuda's pivotal role in the Atlantic World's history. The campaign proceeds will underpin education programmes to students, teachers and everyone interested in Bermuda, as well as to provide for expansion, and to ensure operational stability. Integral to the expansion pillar is stabilising and drying-out the Casemates Barracks, built for the Royal Marines between 1839-43. The Barracks are some of the oldest surviving buildings in the Bermuda Historic Naval Dockyard and represent important examples of British naval and military built heritage. It is intended that the Casemates will become home to both the Bermuda National Archives and the Centre for Atlantic World History. See also <https://nmb.bm/campaign/> for further information.

The CIO helped organise a reception and lecture on the Bermuda Dockyard and Fortress given by one of its Trustees, Jonathan Coad, on 10 March 2022. This event, in co-ordination with the Bermuda Society, Hiscox Ltd and the National Museum itself, was both enjoyable and successful in raising the profile of the Museum to a wider British audience, including potential financial supporters.

Grants of £60,000 were made in 2022 (2021: £nil). Of this total, £10,000 was to support operations in Bermuda (helping to mitigate the effects of multiple forced closures during the Covid-19 pandemic) and £50,000 supporting the Future of History Campaign.

The Trustees are continuing their review of the CIO's operating procedures and consider revisions to its risk management and compliance procedures to reflect current best practice. The Trustees have also reviewed the CIO's financial systems and procedures.

PUBLIC BENEFIT

The Trustees have complied with their duty to have due regard to the Charities Commission's public benefit guidance when exercising their powers and duties to which that guidance is relevant. In providing practical and financial support for the National Museum of Bermuda; the Trustees are satisfied that they contribute public benefit both to the preservation of important aspects of Bermuda and British heritage and to historical education at every level from primary through tertiary and post-graduate study.

GENERAL DATA PROTECTION REGULATION

In May 2018 the General Data Protection Regulation (GDPR) came into effect. It represented a significant change and consolidation of existing Data Protection law. The Trustees have reviewed carefully the extent to which the GDPR affects the Charity. In July 2019, the Charity adopted a
