1. Reference and Administrative Details

The trustees present their annual report together with the financial statements for the year ended 31 March 2025.

2. Structure, Governance and Management

Burundi Education is governed by its governing document. The trustees are responsible for the management and administration of the charity and for ensuring that its activities further its charitable purposes.

The trustees meet as required and make decisions collectively. All trustees are aware of and act in accordance with their legal duties and responsibilities under charity law.

3. Objectives

The charity's objects are:

1. **To advance education** of children and young people from poor communities by providing education opportunities, improving the capacity of their teachers, and providing educational tools and such other support as the trustees may determine.
2. **To prevent or relieve poverty or financial hardship** by the provision of education, training, and all necessary support to enable beneficiaries to generate a sustainable income and become self-sufficient.

4. Activities and Public Benefit

The trustees have had due regard to the Charity Commission's guidance on public benefit. The charity's activities focus on education and skills development, which contribute to improved opportunities and long-term poverty reduction for beneficiaries in Burundi.

5. Achievements and Performance

During the year, the charity operated on a small scale due to limited income. Funds were used to support education-related activities in line with the charity's objects.

The trustees consider that, despite modest resources, the charity's work continues to make a positive contribution toward improving educational outcomes and long-term self-sufficiency.

6. Financial Review

For the year ended 31 March 2025:

- **Total income:** £1,321
- **Total expenditure:** £1,500

This resulted in a **deficit of £179**, which was met from reserves brought forward.

The **closing cash balance at 31 March 2025 was £630.05**.

7. Reserves Policy

Due to the small size of the charity and its limited income, the trustees do not maintain a formal reserves policy. Reserves are reviewed regularly to ensure the charity can meet short-term obligations.

8. Plans for the Future

The trustees plan to:

- Continue delivering education-focused support aligned with the charity's objects
- Seek additional funding and donations
- Strengthen the sustainability of the charity's activities

9. Statement of Trustees' Responsibilities




