Trustees of Grandmother Clara's Dream are responsible for fundraising to support the work of the Educandário Creche Comunitária Sonho da Vovó Clara (ECCSVC). ECCSVC is a not for profit community school offering free of charge education and childcare to the community of Mata Escura in Salvador, Brazil.

ECCSVC is a registered charity in Brazil. There are 3 existing trustees of Grandmother Clara's Dream. Any new trustees must be appointed by a properly convened meeting of the existing trustees. New trustees are appointed for a term of 3 years after which time they may put themselves forward for reappointment at a properly convened meeting of trustees.

The constitution allows for a minimum of 3 and a maximum of 12 trustees. All charity trustees give their time freely and no remuneration was paid during the year. Trustees are entitled to be reimbursed from Grandmother Clara's Dream for reasonable expenses incurred when acting on behalf of the charity, however no expenses have been claimed for the financial year 2024/25

None of the trustees receive any personal benefit as a result of carrying out the charity's purpose –we do not receive any gifts or enhance our business/personal reputations in any way via our work for Grandmother Clara's Dream. Charity trustees must declare the nature and extent of any interest, direct or indirect which he or she has in any proposed transaction or arrangement entered into by Grandmother Clara's Dream that has not been previously declared. Charity trustees must also absent themselves from any conversations of trustees in which it is possible that a conflict of interest will arise between his or her duty to act solely in the interests of Grandmother Clara's Dream.

The ECCSVC school project is supported by the fundraising work of Grandmother Clara's Dream. Trustee and Chairperson Emma Astles

established ECCSVC in its current form in 2010. Emma Astles aims to remain in regular contact with the ECCSVC staff via email conversations to ensure that the school is being effectively and safely managed and that funds are being spent correctly. Emma Astles reports the details of her conversations with ECCSVC management to the other Grandmother Clara's Dream Trustees and any questions or problems which arise are discussed, with decisions taken at properly convened trustee meetings.

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the aims and objectives of Grandmother Clara's Dream and in planning future activities and setting policy for the year. Grandmother Clara's Dream benefits children aged 2-16 years in the favela of Mata Escura on the outskirts of the city Salvador in Northern Brazil by fundraising to support to the work of Educandário Creche Comunitária Sonho da Vovó Clara (ECCSVC).

ECCSVC is an independent community school, which operates without religious or political bias and offers free of charge education and child care to underprivileged children aged 2-16 years. The community of Mata Escura is deeply affected by violent crime, illiteracy, unemployment and a lack of quality housing and amenities. Many families are torn apart by drug trafficking and abuse.

There are 2 state schools in the favela, which accept children from age 7 upwards. However, lessons at these schools are regularly cancelled due to a lack of teaching staff and when they are operating children attend for 3 hour "half day" sessions only. Owing to the short school sessions, children are often fending for themselves for the majority of the day – and this can put them at risk

Another major issue faced by the inhabitants of Salvador's favelas is poor public health, nutrition and sanitation. Studies carried out in 2010 revealed that 10.72% of the city's babies are classified as seriously underweight at birth and 10.21% of children aged 6 and under are suffering from the effects of malnutrition.

So, how does ECCSVC benefit the local public in Mata Escura? ECCSVC offers a safe, caring, educational environment for the children of this community. It provides a place where local children can play, develop and learn. Students receive first time teaching in literacy, numeracy, social sciences, natural sciences, arts and crafts. ECCSVC also provides reinforcement classes to older children and teenagers – helping them with their homework and providing teaching on the regular occasions when lessons at the local state school are cancelled and, perhaps most importantly, keeping them off the streets in a positive environment, away from the gangs. All teaching is conducted in Portuguese and all the school's services are offered free of charge and free from religious and political bias.

ECCSVC also strives to combat malnutrition by providing daily fruit, breakfast and 2 hot meals for the children. This helps to improve their vitamin intake and reduce their susceptibility to illness. Whenever possible ECCSVC also provides weekend and holiday food packages to help ensure the children are fed whilst not at school.

So, how does this relate to the activities of our charity, Grandmother Clara's Dream? ECCSVC as described above is supported with donations of funds raised by Grandmother Clara's Dream to assist them in their work in the community of Mata Escura.

ECCSVC is a registered charity in Brazil. The funds Grandmother Clara's Dream raises are used to support the continued operation of ECCSVC.

Grandmother Clara's Dream raises funds through donations from family, friends and former volunteers at ECCSVC, who have seen the work first hand.

With the funds we raise, Grandmother Clara's Dream previously sent a bi-monthly bank transfer to ECCSVC in Brazil. This transfer contributed to salaries for the school staff. This transfer also helped to cover food and fresh fruit for the students, teaching supplies and an agreed contingency for maintenance of the school buildings and petty cash. Grandmother Clara's Dream Chairperson Emma Astles discussed the transfer amount with the ECCSVC staff prior to sending the funds and if any adjustments were required these were discussed and approved by all trustees. We are very careful to ensure that ECCSVC does not have a shortage or an unmanageable excess each month.

In July 2023 Grandmother Clara's Dream ceased accepting donations and transfers to ECCSVC were paused indefinitely. The school director, sadly passed away following a long battle with cancer. The director owned the land upon which the school was built and was responsible for all the school's financial management – including the complex process of visiting the bank every 2 months to confirm receipt and withdraw the funds we sent. In early 2023 we started to receive notification that our bi-monthly transfers were being returned to the charity bank account by the banking system – it became clear that the transfer procedure we had been using for the previous 8 years was no longer functioning and nobody from ECCSVC was claiming the funds on the Brazilian side. We reached out to the school, but communications became increasingly irregular and the situation unclear. We immediately informed a regular donor to cease his monthly contribution and we have paused transfers to the school indefinitely whilst we try to establish what is happening.

Grantmaking Policy - Grandmother Clara's Dream was established to support the work of the Educandário Creche Comunitária Sonho da Vovó Clara (ECCSVC) community school – this is the sole purpose of Grandmother Clara's Dream. Grandmother Clara's Dream only makes grants to ECCSVC and does not support any other individuals, groups or projects. Currently we do not intend to expand our purpose to include support for other individuals, groups or projects.

No activity took place in 2024/25 – neither fundraising or grantmaking. The intention is to wind up Grandmother Clara's Dream in the near future. A bereavement at the ECCSVC and a number of staff changes have meant that we no longer have close lines of communication with the school and following the death of the school's director they currently do not have a bank account to which we can transfer funds. We are currently working on a solution to this banking issue to enable us to send the remaining funds in the charity account prior to winding up. We still support the school's aims and purpose, but we no longer see a role for Grandmother Clara's Dream and have recognised that it is time to wind things up in absence of connections to the team on the ground in Brasil.

Brief statement of the charity's policy on reserves

It has always been Grandmother Clara's Dream policy to maintain a balance on unrestricted funds which equates to at least 2 months unrestricted payments – to cover emergency situations that may arise from time to time. However, we are currently reviewing this policy and the role of our charity moving forward. In recent years ECCSVC had success in securing local funding in Brazil and our role has become a less critical one - we have switched to playing a supporting role - providing additional funds - no longer critical to the school's continuing operation. In addition, the school's long time director very sadly passed away, leaving the future operation on pause whilst new administrative structures were put in place at the school. As a result of this upheaval bank transfers have been uncollected and have been returned to our charity account. It has also been increasingly difficult to maintain regular contact with the school. We know that the school is still in operation and we still remain hopeful that lines of communication will be restored, but we have been careful to ensure that no new donations are accepted and we have begun to discuss the possibility of closing down the charity.

Adding bank balances brought forward at the beginning of the financial year and returned bank transfer, the balance carried forward at 31st March 2025 totalled £1147.41 . This amount will shortly be transferred in full to ECCSVC and Grandmother Clara's Dream will be wound up once that has been arranged.

Grandmother Clara's Dream only makes grants to ECCSVC and does not support any other individuals, groups or projects. Currently we do not intend to expand our purpose to include support for other individuals, groups or projects. The reason for this is that we know ECCSVC in great depth - the school in its current form was established by one of our Trustees, who spent 2 years managing the operation. We have first-hand experience of the poor conditions in the favela of Mata Escura and the need for this school to continue its good work. We have witnessed the effects of the lack of quality, reliable schooling in Mata Escura, and the great need for childcare to assist parents seeking employment to support their families. We also have excellent lines of communication with the staff on the ground and understanding of the challenges, costs and bureaucracy they face, all of which allows us to work effectively together.

We would not get involved in a project that we did not have this level of understanding of and therefore we do not intend to expand to support other projects. We are currently not accepting donations, so there will not be an increase in available funds.

Summary of the main achievements of the charity during the year

During the financial year 2023/24 we can summarize the main achievements of Grandmother Clara's Dream as follows:

-Raised a total of £100 through fundraising from family and friends.

Fundraising has been put on hold in 23/24 whilst we assess our next steps.

Following the sad passing of the ECCSVC's former director and financial administrator communication with the school has become erratic. Repeated bank transfers were returned unclaimed by the bank. As a result we have ceased to accept donations. We have also paused all transfers indefinitely whilst we assess the situation and as it was clear they were no longer being received.

We have begun to discuss the possibility of closing down the charity.

In anticipation of this discussion we approached the major donor for GCD over the last 2 financial years. As it has been impossible recently to successfully transfer funds to the school we asked if he would like his donations returned. He assured us that he was happy for us to continue trying to reestablish the relationship with the ECCSVC and if this was not possible to donate his contribution to a similar Brazil-based educational charity – this is an option we are currently researching.

Brief statement of the charity's policy on reserves

It has always been Grandmother Clara's Dream policy to maintain a balance on unrestricted funds which equates to at least 2 months unrestricted payments – to cover emergency situations that may arise from time to time. However, we are currently reviewing this policy and the role of our charity moving forward. In recent years ECCSVC had success in securing local funding in Brazil and our role has become a less critical one - we have switched to playing a supporting role - providing additional funds - no longer critical to the school's continuing operation. In addition, the school's long time director very sadly passed away, leaving the future operation on pause whilst new administrative structures were put in place at the school. As a result of this upheaval bank transfers have been uncollected and have been returned to our charity account. It has also been increasingly difficult to maintain regular contact with the school. We know that the school is still in operation and we still remain hopeful that lines of communication will be restored, but we have been careful to ensure that no new donations are accepted and we have begun to discuss the possibility of closing down the charity.

ECCSVC is a not for profit community school offering free of charge education and childcare to the community of Mata Escura in Salvador, Brazil. ECCSVC is a registered charity in Brazil.

There are 3 existing trustees of Grandmother Clara's Dream. Any new trustees must be appointed by a properly convened meeting of the existing trustees. New trustees are appointed for a term of 3 years after which time they may put themselves forward for reappointment at a properly convened meeting of trustees. The constitution allows for a minimum of 3 and a maximum of 12 trustees.

All charity trustees give their time freely and no remuneration was paid during the year. Trustees are entitled to be reimbursed from Grandmother Clara's Dream for reasonable expenses incurred when acting on behalf of the charity, however no expenses have been claimed for the financial year 2022/23.

None of the trustees receive any personal benefit as a result of carrying out the charity's purpose – our work is very low key, we do not receive any gifts or enhance our business/personal reputations in any way via our work for Grandmother Clara's Dream.

The ECCSVC school project is supported by the fundraising work of Grandmother Clara's Dream. Trustee and Chairperson Emma Astles established ECCSVC in its current form in 2010. ECCSVC is administrated by volunteer school manager Eliana Barbosa. Emma Astles remains in contact with the ECCSVC staff via email and phone conversations to ensure that the school is being effectively and safely managed and that funds are being spent correctly. Emma Astles reports the details of her conversations with ECCSVC management to the other Grandmother Clara's Dream Trustees and any questions or problems which arise are discussed, with decisions taken at properly convened trustee meetings.

Summary of the objects of the charity set out in its governing document

To advance the education, relieve poverty and promote the good health of the pupils at the Educandário Creche Comunitária Sonho da Vovó Clara (ECCSVC) Community School in the poverty stricken favela of Mata Escura in Salvador, Brazil, in particular but not exclusively by the provision of grants for teaching staff, food and materials at the school.

To create sustainable local employment in the community of Mata Escura, Salvador, Brazil.

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the aims and objectives of Grandmother Clara's Dream and in planning future activities and setting policy for the year. Grandmother Clara's Dream benefits children aged 2-16 years in the favela of Mata Escura on the outskirts of the city Salvador in Northern Brazil by fundraising to support to the work of Educandário Creche Comunitária Sonho da Vovó Clara (ECCSVC).

ECCSVC is an independent community school, which operates without religious or political bias and offers free of charge education and child care to underprivileged children aged 2-16 years. The community of Mata Escura is deeply affected by violent crime, illiteracy, unemployment and a lack of quality housing and amenities. Many families are torn apart by drug trafficking and abuse.

There are 2 state schools in the favela, which accept children from age 7 upwards. However, lessons at these schools are regularly cancelled due to a lack of teaching staff and when they are operating children attend for 3 hour "half day" sessions only. Owing to the short school sessions, children are often fending for themselves for the majority of the day – and this can put them at serious risk of becoming involved with the local gangs. With schooling so erratic many children drop out early and others never enter the education system.

Crime and gang culture attracts many adolescents, who are drawn by the notion of an easy route to improving their financial status and feel there are few other options open to them. The number of adolescents involved in drug trafficking in the city has increased 800% in the last 10 years.

Another major issue faced by the inhabitants of Salvador's favelas is poor public health, nutrition and sanitation. Studies carried out in 2010 revealed that 10.72% of the city's babies are classified as seriously underweight at birth and 10.21% of children aged 6 and under are suffering from the effects of malnutrition.

So, how does ECCSVC benefit the local public in Mata Escura? ECCSVC offers a safe, caring, educational environment for the children of this community. It provides a place where local children can play, develop and learn. Students receive first time teaching in literacy, numeracy, social sciences, natural sciences, arts and crafts. ECCSVC also provides reinforcement classes to older children and teenagers – helping them with their homework and providing teaching on the regular occasions when lessons at the local state school are cancelled and, perhaps most importantly, keeping them off the streets in a positive environment, away from the gangs.

ECCSVC also strives to combat malnutrition by providing daily fruit, breakfast and 2 hot meals for the children. This helps to improve their vitamin intake and reduce their susceptibility to illness. Whenever possible ECCSVC also provides weekend and holiday food packages to help ensure the children are fed whilst not at school.

So, how does this relate to the activities of our charity, Grandmother Clara's Dream? The work of ECCSVC as described above is supported with funding raised by Grandmother Clara's Dream, both here in the UK and online. 100% of our financial resources are allocated to supporting the continued operation of ECCSVC.

Grandmother Clara's Dream raises funds through donations from family, friends and former volunteers at ECCSVC, who have seen the work first hand.

With the funds we raise, Grandmother Clara's Dream send a regular bank transfer to ECCSVC in Brazil. This transfer amount helps cover the school salaries.

This transfer also contributes to food and fresh fruit for the students, teaching supplies and an agreed contingency for maintenance of the school buildings and petty cash. These costs normally total around £150 per month, with some seasonal variations. .

During 22/23 the school was forced to close for long periods owing to the after effects of the pandemic and the illness and death of long time school director Sr. Eraldo Barbosa. Owing to both these factors activities at the school were greatly interrupted throughout the year.

ECCSVC is an independent community school, which operates without religious or political bias and offers free of charge education and child care to underprivileged children aged 2-16 years. The community of Mata Escura is deeply affected by violent crime, illiteracy, unemployment and a lack of quality housing and amenities. Many families are torn apart by drug trafficking and abuse.

There are 2 state schools in the favela, which accept children from age 7 upwards. However, lessons at these schools are regularly cancelled due to a lack of teaching staff and when they are operating children attend for 3 hour "half day" sessions only. Owing to the short school sessions, children are often fending for themselves for the majority of the day – and this can put them at serious risk of becoming involved with the local gangs. With schooling so erratic many children drop out early and others never enter the education system.

Crime and gang culture attracts many adolescents, who are drawn by the notion of an easy route to improving their financial status and feel there are few other options open to them. The number of adolescents involved in drug trafficking in the city has increased 800% in the last 10 years.

Another major issue faced by the inhabitants of Salvador's favelas is poor public health, nutrition and sanitation. Studies carried out in 2010 revealed that 10.72% of the city's babies are classified as seriously underweight at birth and 10.21% of children aged 6 and under are suffering from the effects of malnutrition.

So, how does ECCSVC benefit the local public in Mata Escura? ECCSVC offers a safe, caring, educational environment for the children of this community. It provides a place where local children can play, develop and learn. Students receive first time teaching in literacy, numeracy, social sciences, natural sciences, arts and crafts. ECCSVC also provides reinforcement classes to older children and teenagers – helping them with their homework and providing teaching on the regular occasions when lessons at the local state school are cancelled and, perhaps most importantly, keeping them off the streets in a positive environment, away from the gangs. The activities that ECCSVC undertakes for the benefit of the local public in Mata Escura are enabled by the fundraising activities of Grandmother Clara's Dream.

Whilst ECCSVC is a registered charity in Brazil and despite countless appeals and requests, attracting local government support has proven impossible. The funds Grandmother Clara's Dream raises cover all ECCSVC's costs and 100% of our financial resources are allocated to the continued operation of ECCSVC.

Grandmother Clara's Dream raises funds through donations from family, friends and former volunteers at ECCSVC, who have seen the work first hand. We also raise donations through a page on the fundraising site GlobalGiving.com. We also maintain a Facebook page with regular updates and photos from the school. This helps to keep our supporters engaged, raise awareness and attract new donors.

With the funds we raise, Grandmother Clara's Dream send a bi-monthly bank transfer to ECCSVC in Brazil. This transfer amount covers the school salaries as follows:

- School Teaching Staff: £275.00 or R\$1200/month, £3,300 or R\$14,400/year
- Teaching Assistant: £140.00 or R\$615/month, £1680 or R\$7,380/year
- Teaching Assistant: £130.00 or R\$600/month, £1560 or R\$7,200/year
- School Cook: £175 or R\$750/month, £2100 or R\$9000/year

We are very careful to ensure that ECCSVC does not have a shortage or an unmanageable excess each month. Salary amounts for ECCSVC staff are agreed annually, following discussions with staff and are approved by all trustees. We are committed to ensuring that salaries remain above the minimum wage for Brazil, they are modest but fair and above average for the local community.

This transfer also covers food and fresh fruit for the students, teaching supplies and an agreed contingency for maintenance of the school buildings and petty cash. These costs normally total around £150 per month, with some seasonal variations.

When funds for food supplies are required Grandmother Clara's Dream Chairperson Emma Astles discusses the transfer amount with the ECCSVC staff prior to sending the funds and any adjustments are discussed and approved by all trustees.

During 21/22 the school was forced to close for long periods owing to the pandemic and operations were repeatedly interrupted. In addition our volunteer school director Sr. Eraldo Barbosa was diagnosed with terminal cancer. Owing to both these factors activities at the school were greatly interrupted throughout the year. This can be evidenced by the fact that only one transfer was made to ECCSVC in 21/22.

We have witnessed the effects of the lack of good quality, reliable schooling in Mata Escura, and the great need for childcare to assist parents seeking employment to support their families. We also have excellent lines of communication with the staff on the ground and understanding of the challenges, costs and bureaucracy they face, all of which allows us to work effectively together.

We would not get involved in a project that we did not have this level of understanding of and therefore we do not intend to expand to support other projects. If Grandmother Clara's Dream were to experience an increase in funding we would use this to expand the work of ECCSVC to allow more students to enrol and ensure an improved pupil-teacher ratio.

During 20/21 our local staff were able to obtain some government assistance with food supplies and enrolled onto a food donation program, which helps food businesses donate supplies that are safe to eat, but would otherwise go to waste. This assistance helped reduce food costs to around £80/month. Payments were not regular in 20/21 as the school was forced to close for long periods owing to the pandemic and operations were repeatedly interrupted

When funds for food supplies are required Grandmother Clara's Dream Chairperson Emma Astles discusses the transfer amount with the ECCSVC staff prior to sending the funds and any adjustments are discussed and approved by all trustees.

We also send a separate transfer to cover tuition fees for our school teacher Andrea Veiga. Andrea was born and raised in the Mata Escura area. She left school without qualifications. She discovered a passion for teaching when she started at the school as an assistant in 2010. In 2016 we began supporting Andrea to train formally as a teacher. Grandmother Clara's Dream sends a monthly transfer to cover her tuition fees at a local college. She is undertaking a 4 year part-time teacher training degree. If Grandmother Clara's Dream were to experience an increase in funding we would use this to expand the work of ECCSVC to allow more students to enrol and ensure an improved pupil-teacher ratio.

Summary of the main achievements of the charity during the year

During the financial year 2020/21 we can summarize the main achievements of Grandmother Clara's Dream as follows:

- Raised a total of £300 through online fundraising from family and friends. This was an improvement on our target of £250.
- Funded 8 hours schooling per day for approximately 90 days of the year, which equates to 720 teaching hours for year 2020/21. Opening hours were drastically affected in 2020/21 as the school was required to close and cease all operations under Brazilian lockdown restrictions.
- Helped to fund 3 meals per day for 45 students for approximately 90 days of the year, which equates to 12,150 meals for the year 2020/21.
- Funded 1 piece of fresh fruit per day for 45 students for 90 days of the year, which equates to 4050 pieces of fruit handed out for the year 2020/21.
- Funded regular paid employment for 4 members of the local community supporting them during the chaos of the pandemic.

Brief statement of the charity's policy on reserves

It is Grandmother Clara's Dream policy to maintain a balance on unrestricted funds which equates to at least 2 months unrestricted payments – equivalent to £2060 – to cover emergency situations that may arise from time to time. We appreciate that this may not always be possible as our priority must be payment of school salaries and food for the ECCSVC students. If we reach this reserve threshold we will request ECCSVC freeze new pupil enrolment and make any appropriate cutbacks in expenditure, without affecting the welfare and education of its students, in order to protect our emergency reserve. The balance of £2363 held on unrestricted funds at year end met and exceeded our target.

Adding bank balances brought forward at the beginning of the financial year, the balance carried forward at 31st March 2020 totalled £2363.
