
### **Reserves policy**

### **Independent Examiner's Report to the Trustees of Endee Charitable Trust**

I report on the accounts of Emdee Charitable Trust for the year ended 31 March 2024, which are set out on pages 4 to 7.

#### **Respective responsibilities of trustees and examiner**


