TRUSTEES' REPORT FOR THE YEAR ENDED 31 DECEMBER 2024

The Trustees present their annual report together with the financial statements of The Ella Roberta Family Foundation for the year 1 January 2024 to 31 December 2024.

Objectives and activities

a. Policies and objectives

The Ella Roberta Family Foundation campaigns for Clean Air for All in the UK and worldwide. Ella Roberta died a sudden death aged 9, from an asthma attack directly caused by air pollution. The Coroner's inquest, concluded on 16th December 2020, and his Prevention of Future Deaths report can be found on our website here: <https://ellaroberta.org/campaigns/inquest-coroners-report>

In setting objectives and planning for activities, the Trustees have given due consideration to general guidance published by the Charity Commission relating to public benefit, including the guidance 'Public benefit: running a charity (PB2)'.

b. Achievements and performance

Issued in 2021, after the landmark second inquest into Ella's death, Coroner Philip Barlow released a Prevention of Future Deaths Report (PFD). He highlighted three concerns which pose ongoing risk to life:

1. World Health Organisation's (WHO) guidelines should be seen as minimum requirements for air pollution targets.
2. The need to raise public awareness about air pollution and its effects and increase the capacity to monitor air quality.
3. Improve patient advice about the impacts of air pollution, including addressing medical and nursing training, professional guideline levels and in undergraduate and postgraduate education.

The Foundation continues to campaign to make the Coroner's three recommendations a reality. The PFD report has shaped the narrative and broader campaign to clean up the air for all UK citizens. The Foundation's work is also to advocate for these guidelines to be followed by governments, councils, medical professionals, all over the world.

Our trustees, the founder and small team of employees have focused on several activities throughout the year, all of which are aligned to the charity's objectives and the PFD recommendations. Highlights include:

1.Reduce air pollution: national air pollution limits should be in line with WHO guidelines.

The Foundation continued its policy and public affairs work, specifically campaigning for the UK government to set new air quality targets to those recommended in the WHO 2021 guidelines. This included twelve, high level meetings with MPs, policymakers and members of the Greater London Authority over the course of the year.

After successfully making its way through the House of Lords in 2023, The Clean Air (Human Right's) Bill, also known as Ella's Law, continued through the legislative process and had its first reading in the House of Commons in January 2024. Unfortunately, Parliament was dissolved ahead of the general election before it could have its second reading. Ella's Law aims to establish clean air as a human right and sets out a pathway for the UK to reach the minimum air quality standards as set by the World Health Organisation (WHO). The Foundation will continue to advocate for Ella's Law.

ERFF's founder, Rosamund spoke at an event hosted by the UK Environmental Law Association (UKELA) about her experience of litigation, social and racial justice and air pollution.

Towards the end of the year, Rosamund attended a Ministerial roundtable hosted by the new Air Quality Minister Emma Hardy MP. The purpose of the meeting was to look at the opportunities for taking forward the recommendations from the Air Quality Information System (AQIS) review, in addition to discussing the role that the health community and health professionals have in this area, as well as the opportunities to engage with the wider public and communities.

Following the release of new data on child asthma deaths in England between 2019-2023 (National Child Mortality Database's thematic report 'Child Deaths due to Asthma or Anaphylaxis), Rosamund released a statement calling on the Government to act now to prevent more senseless child deaths from asthma. Key points from the report that Rosamund references in her statement are:

- There were 54 child deaths due to asthma between April 2019 and March 2023
- That's 1 death every 4 weeks (aged 2-17)
- All of the 54 children who died had been exposed to air pollution above WHO guidelines
- The death rate is 4 times higher in deprived areas

The Foundation continues to campaign for an Asthma & Allergy Tsar to champion the cause within government and hold decision makers to account on their actions.

2.Raise awareness of the dangers of air pollution amongst the general public.

The PFD report found that most people were not aware of the impact air pollution has on their and their children's, health or where to get find information about air pollution levels. By sharing Ella's story and her campaign work, Rosamund believes she is enabling people to make informed decisions so they can lower their exposure to air pollution and to advocate for their families to health professionals and politicians demanding change to clean up the air they breathe.

Rosamund continues to raise awareness of air pollution and its effects by giving talks and presentations across the UK and globally. Her impact has been far-reaching with media appearances on podcasts, TV, radio and news publications outside of the UK. Notable international engagements included interviews with CBC's (Canadian Broadcasting Corporation), Radio One 'What on Earth' show. CBC Radio is the largest radio network in Canada; the 'What on Earth' show has between 1,000-10,000 monthly listeners. As well as the US based Institute for Science & Policy for their 'Clearing the Air' podcast.

International TV appearances included TRT's World Roundtable news discussion show, TRT World is the English-language channel of the Turkish Radio and Television Corporation (TRT), Türkiye's national public broadcaster. TRT's English-language international news channel alone reaches 260 million homes in 190 countries. Rosamund was interviewed by ARD TV, a popular TV channel in Germany with the second highest audience share. She was also interviewed by a Brazilian TV network as part of a larger piece about the impact of air pollution, which is expected to reach 11 million viewers.

Additionally, Rosamund gave interviews to a leading Italian daily newspaper, Corriere della Sera (with a substantial digital audience of over 3.9 million daily unique users and a daily print circulation of around 269,000 copies). As well as for an article in Spanish publication, Público, a popular online publication, has 7.6 million unique monthly visitors to its website.

UK podcast guest appearances included Quentin Wilson's, Stop Burning Stuff podcast which reaches a global audience of over 3 million. She also appeared on the investigative and current affairs weekly podcast, Media Storm as well as on The Mummafesto podcast, hosted by Stella Creasy, Labour and Cooperative MP for Walthamstow.

Rosamund regularly features in the UK media; during the period she was interviewed by The Times and The Guardian and ITN and could be heard on Times Radio speaking about the "direct link" between PM 2.5 and its impact on health, BBC Radio London, BBC Radio 5 and LBC. Rosamund was also interviewed live by Kay Burley on the ever-popular Sky News' Breakfast show, commenting on the expansion of ULEZ and the invisible threat to children's lungs as new data shows that most playgrounds in Britain exceed World Health Organization (WHO) limits on air pollution. Rosamund's views were also shared in an interview with the British Medical Journal for a feature on the prevention of future deaths reports.

Throughout the year, Rosamund was a guest speaker at several conferences, including the 10th Wired Health Festival in London. She discussed the right to clean air, sharing her own personal story in a Q&A session as well as participating in a panel discussion: 'The Climate Crisis Is a Health Crisis' alongside The Lancet's, Marina Romanello. The conference was attended by over 600 people. She was also a guest speaker at The Grantham Centre Annual Symposium at Sheffield University. She took part in a Q&A panel discussion hosted by Grantham Centre for Sustainable Futures co-director. Rosamund also attended the Austrian World Summit in Vienna, as a guest of Arnold and the Schwarzenegger Institute, to help showcase artist Dryden Goodwin's artwork "Breathe".

Towards the end of the period, Rosamund was a subject for the Taylor Wessing Photographic Commission. The National Portrait Gallery received over 37,000 visitors to the exhibition; her portrait now hangs in the National Portrait Gallery's prestigious permanent collection.

Rosamund visited Manchester to meet fellow campaigners and health professionals who shared their experiences of air pollution in the city region ahead of the Foundation's meeting with Mayor of Manchester, Andy Burnham, scheduled for January 2025.

On International Clean Air Day in September, Rosamund joined cyclists in Mountsfield Park, Lewisham for the start (and end) of Ride for Their Lives: a grassroots collective of healthcare workers who cycle to galvanise action on the air quality crisis. Cyclists travelled through the local community, past Ella's old school and Lewisham Hospital where Ella spent so much of her last few years.

The Foundation also partnered with outdoor clothing brand Patagonia on the international series 'Running Up for Air' which aims to raise awareness globally about air pollution. The Foundation were Patagonia's partner in the UK and attended an event where Rosamund spoke, as well as an event in London where runners aimed to raise awareness about the link between the impact of air pollution on physical activity.

3. Educate health professionals: ensure health professionals are aware of the dangers of air pollution, and that they tell their patients about it.

In the PFD report, the coroner was concerned that the dangers of air pollution were not being sufficiently communicated to patients and their carers by the medical profession. He recommended that this should be addressed through undergraduate and postgraduate training, as well as the professional medical bodies. In addition to this, the Foundation is committed to promoting research into the links between air pollution and asthma, so that the medical profession and members of the public can better understand the health risks and how they can be treated.

Throughout the period, Rosamund continued to focus on engaging with health professionals and students; notable events included her taking part in a one-to-one Q&A discussion at the Association of Respiratory Nurses (ARNS) Annual Conference where Rosamund shared her personal story and campaign work with over 240 professionals who attended.

Rosamund was a guest speaker at the Institute of Health Visiting Leadership Conference, "Change for the better: Leading towards a fairer and equitable future", which brought together health visitors, health visiting leaders, policymakers, academics and partners from around the UK. Rosamund shared her story before taking part in a Q&A panel discussion hosted by IHV's CEO, Alison Morton. The conference was attended in-person by 200 professionals and just under 100 individuals online.

Rosamund was also pleased to be able to share her campaign work at a University College London Hospitals, in-person training event in Windsor. Focussing on green health and air pollution, she addressed 40-50 doctors training as GPs in Camden.

Rosamund gave a talk to student healthcare professionals at St George's, University College London. The teaching event focused on health inequalities and raising awareness about the impact of air pollution. Rosamund was in-conversation with Professor Debs Harding, Professor of Learning and Innovation for Practice, St George's School of Health and Medical Sciences.

As a guest of Professor Sir Stephen Holgate, Rosamund visited Southampton where she delivered two talks for Clean Air South, a new partnership to tackle air pollution across central southern England. Rosamund spent the morning with Clean Air South delegates at the University of Southampton's (UoS) Future Towns Innovation Hub. She then met medical students, nurses and consultants at University Hospital Southampton. At UHS, Rosamund also visited the National Institute for Health and Care Research (NIHR) Southampton Clinical Research Facility to see trials that are improving treatments for children with asthma and other conditions. She was introduced to Nikita, a 13-year-old who is part of a trial for children with severe asthma.

Rosamund attended an online pan-London training workshop: Learning from asthma and allergy child deaths. The event was hosted by North Central London Child Death Overview Panel and NHS England. The session aimed to share the learning from child death reviews undertaken across London in order to improve practice, learn from individual cases and also themes that have been identified through child deaths.

ERFF's Structure, Governance and management

During 2024, Andrea Carey Fuller resigned as a Trustee on 6 March 2024, Joseph Taylor resigned on 18 January 2024 and Jennifer Davis resigned on 18 January 2024, Emily Steadman and Hannah Omolulu, were appointed as Trustees on 16 May 2024. Rosamund Kissi Debrah, Barbara Gray and Sharon Farnley continued as Trustees.

Financial review

a. Going concern

After making appropriate enquiries, the Trustees have a reasonable expectation that the Charity has adequate resources to continue in operational existence for the foreseeable future. For this reason, they continue to adopt the going concern basis in preparing the financial statements. NOTES TO THE FINANCIAL STATEMENTS

1 General information

Ella Roberta Family Foundation is a charitable incorporated organisation registered in England and Wales under charity number 1158212 and company number CE001609.

2 Accounting policies

2.1 Basis of accounting

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) - Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Charities Act 2011.

The financial statements have been prepared to give a "true and fair " view and have departed from the Charities (Accounts and Reports) Regulation 2008 only to the extent required to provide a "true and fair" view. This departure has involved following the Charity SORP (FRS 102), published in October 2019 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

The Ella Roberta Family Foundation meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

2.2 Income

All income is recognised once the Charity has entitlement to the income. It is probable that the income will be received and the amount of income receivable can be measured reliably.

Grants are included in the Statement of Financial Activities on receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the balance sheet. Where income is received in advance of entitlement of receipt, its recognition is deferred and included in creditors as deferred income. Where entitlement occurs before income is received, the income is accrued.

2.3 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer the economic benefit to a third party, it is probable that the economic benefit will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to the activity. Shared costs which contribute to more than one activity and support costs

which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Expenditure on raising funds includes all expenditure incurred by the Charity to raise funds for its charitable purposes and includes costs of all fundraising activities events and non-charitable trading.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the Charity's objectives, as well as any associated support costs.

All expenditure is inclusive of irrecoverable VAT.

2.4 Tangible fixed assets and depreciation

Tangible assets costing £100 or more are capitalised and recognised when future economic benefits are probable and the cost or value of the asset can be measured reliably.

Tangible fixed assets are initially recognised at cost. After recognition, under the cost model, tangible fixed assets are measured at cost less accumulated depreciation and any accumulated impairment losses. All costs incurred in bringing a tangible fixed asset into its intended working condition should be included in the measurement of cost.

Depreciation is charged so as to allocate the cost of tangible fixed assets less their residual value over their estimated useful lives, using the straight line basis method.

Depreciation is provided on the basis

Office structure	10% of cost
Office equipment	25% of cost

2.5 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

2.6 Cash at bank and in hand.

Cash at bank and in hand includes cash and short term high liquidity investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

2.7 Liabilities and provisions

Liabilities are recognised where there is an obligation at the balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably.

2.8 Financial instruments

The Charity only has financial assets and financial liabilities of a kind that qualify as a basic financial instrument. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value, with the exception of bank loans which are subsequently measured at amortised costs using the effective interest method.

2.9 Pensions

The Charity operates a defined contribution pension scheme and the pension charge represents the amount payable by the Charity to the fund in respect of the year.

2.10 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the Charity and which have not been designated for other purposes.

Designated funds comprise unrestricted funds that have been set aside by the Trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements.

Restricted funds are funds which are to be used in accordance with the specific restrictions imposed by donors or which have been raised by the Charity for particular purposes. The costs of raising and administering such funds are charged against the specific fund. The aim and the use of each restricted fund is set out in the notes to the financial statements.

The Trustees present their annual report together with the financial statements of The Ella Roberta Family Foundation for the 1 January 2023 to 31 December 2023.

Objectives and activities

a. Policies and objectives

The Ella Roberta Family Foundation campaigns for Clean Air for All in the UK and worldwide. Ella Roberta died a sudden death aged 9, from an asthma attack directly caused by air pollution. The Coroner's inquest, concluded on 16th December 2020, and his Prevention of Future Deaths report can be found on our website here: <https://ellaroberta.org/campaigns/inquest-coroners-report>

In setting objectives and planning for activities, the Trustees have given due consideration to general guidance published by the Charity Commission relating to public benefit, including the guidance 'Public benefit: running a charity (PB2)'.

Achievements and performance

Rosamund's profile, reputation and reach continued to grow as she gave over fifty talks/presentations at conferences and events both in the UK and internationally as well contributing to working groups and roundtable discussions. She continued to expand her media presence by engaging with journalists and podcasters across a range of titles and shows. These events provide an opportunity for Rosamund to deliver a campaigning message for clean air, connecting the cause of Ella's death and 8.8 million deaths worldwide every year, to air pollution.

At the start of the year Rosamund campaigned alongside Caroline Lucas for the Government to give time to the Clean Air (Human Rights) Bill. This was eventually introduced to Parliament by Caroline in January 2023. By March it was evident that the Conservative-led UK Government was not going to make time for the Bill as it had been pushed down the Bill agenda to No 85/100. The Chair of ERFF supported Rosamund's efforts by writing to Keir Starmer and the Conservative Environment Network to see if they could put any pressure on the Government to give time to the Clean Air Bill given that it had already successfully completed its progress in the House of Lords.

Rosamund attended the Mayor of London's briefing of the Healthy Air working group and the Healthy Cities Summits in March and in the same month contributed to international events such as the Spanish LovexAir Climate Impact on Health event; the Earth Convention webinar; and the Portugal Health Summit.

Julian Knxx's film, Black Corporeal (Breathing by Numbers), narrated by Rosamund, was shown at the GLA in April. Rosamund met with the Conservative Environment Network then went on to support the Environmental Rights Bill at an online event.

Rosamund annually supports the Royal College of Physicians; in March she spoke at their 'Med23' conference along with Professor Stephen Holgate as well as attending their annual conference in June.

Rosamund won the vote for the Female Black Icon mural as part of Brockley Max art festival in Lewisham: "Rosamund Adoo-Kissi-Debrah received the most votes from the public and it is no surprise as her tireless work campaigning to introduce the Clean Air (Human Rights) Bill - or "Ella's law", named after her daughter, who died 10 years ago this year from the effects of air pollution. Her campaigning will save thousands of lives and a mural is a testament to both Rosamund and Ella." <https://brockleymax.co.uk/murals/>

Children and Young People with Asthma Air quality conference is another regular event that Rosamund attends every year to lend her support to their cause.

On Clean Air Day in June, the ERFF Foundation launched a Parliamentary petition to generate support to get the Clean Air (Human Rights) Bill debated:

Much of June and July was focused on the planned expansion of the Ultra Low Emission Zone (ULEZ). Rosamund, her children and the Foundation were relieved that the High Court supported Sadiq's plans to expand ULEZ to the whole of outer London by the end of August 2023. Rosamund took part in interviews leading up to the Court Case and extensively following the decision on Sky News with Kate Burley; BBC Radio4 Today; TalkTV; iNews and LBC with Nick Ferrari:

Following the High Court Judgement at the end of July 2023, enabling the Mayor of London to roll out the extension to the ULEZ, Rosamund made a plea in both press and other media, asking people to "make it work".

Also that month Rosamund filmed a talk for a conference in Manila entitled "Better Air Quality"; and was invited to speak about her campaign work on the following of podcasts: "The Guilty Feminist" (aired on 23rd October) and the Royal Society of Chemistry podcast (aired 22nd November). She was also interviewed by The Lancet Magazine and the Psychologist Magazine.

a. Going concern

After making appropriate enquiries, the Trustees have a reasonable expectation that the Charity has adequate resources to continue in operational existence for the foreseeable future. Structure, governance and management

a. Constitution

The Ella Roberta Family Foundation is a registered charity, number 1158212, and is constituted under a Trust deed.

b. Methods of appointment or election of Trustees

Statement of Trustees' responsibilities

1 General information

Ella Roberta Family Foundation is a charitable incorporated organisation registered in England and Wales under charity number 1158212 and company number CE001609.

2 Accounting policies

2.1 Basis of accounting

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) - Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Charities Act 2011.

The financial statements have been prepared to give a "true and fair " view and have departed from the Charities (Accounts and Reports) Regulation 2008 only to the extent required to provide a "true and fair" view. This departure has involved following the Charity SORP (FRS 102).published in October 2019 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

The Ella Roberta Family Foundation meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

2.2 Income

All income is recognised once the Charity has entitlement to the income. It is probable that the income will be received and the amount of income receivable can be measured reliably.

Grants are included in the Statement of Financial Activities on receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the balance sheet. Where income is received in advance of entitlement of receipt, its recognition is deferred and included in creditors as deferred income. Where entitlement occurs before income is received, the income is accrued.

2.3 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer the economic benefit to a third party, it is probable that the economic benefit will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to the activity. Shared costs which contribute to more than one activity and support costs

2.3 Expenditure (continued)

which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Expenditure on raising funds includes all expenditure incurred by the Charity to raise funds for its charitable purposes and includes costs of all fundraising activities events and non-charitable trading.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the Charity's objectives, as well as any associated support costs.

All expenditure is inclusive of irrecoverable VAT.

2.4 Tangible fixed assets and depreciation

Tangible assets costing £100 or more are capitalised and recognised when future economic benefits are probable and the cost or value of the asset can be measured reliably.

Tangible fixed assets are initially recognised at cost. After recognition, under the cost model, tangible fixed assets are measured at cost less accumulated depreciation and any accumulated impairment losses. All costs incurred in bringing a tangible fixed asset into its intended working condition should be included in the measurement of cost.

Depreciation is charged so as to allocate the cost of tangible fixed assets less their residual value over their estimated useful lives, using the straight line basis method.

Depreciation is provided on the basis

Office structure	10% of cost
Office equipment	25% of cost

2.5 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

2.6 Cash at bank and in hand.

Cash at bank and in hand includes cash and short term high liquidity investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

2.7 Liabilities and provisions

Liabilities are recognised where there is an obligation at the balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably.

2.8 Financial instruments

The Charity only has financial assets and financial liabilities of a kind that qualify as a basic financial instrument. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value, with the exception of bank loans which are subsequently measured at amortised costs using the effective interest method.

2.9 Pensions

The Charity operates a defined contribution pension scheme and the pension charge represents the amount payable by the Charity to the fund in respect of the year.

2.10 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the Charity and which have not been designated for other purposes.

Designated funds comprise unrestricted funds that have been set aside by the Trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements.

Restricted funds are funds which are to be used in accordance with the specific restrictions imposed by donors or which have been raised by the Charity for particular purposes. The costs of raising and administering such funds are charged against the specific fund. The aim and the use of each restricted fund is set out in the notes to the financial statements.
