TO PROMOTE FOR THE BENEFIT OF THE PUBLIC THE CONSERVATION, PROTECTION AND IMPROVEMENT OF THE NATURAL ENVIRONMENT OF PONDHEAD INCLOSURE, LYNDHURST, HAMPSHIRE, BY PROMOTING ITS BIOLOGICAL DIVERSITY (FLORA AND FAUNA), INCLUDING BY ENSURING THAT THERE IS A SUCCESSION PLAN FOR ITS FUTURE COPPICE AND WOODLAND UNDERSTORY MANAGEMENT, AND FACILITATING PUBLIC ACCESS TO IT INSOFAR AS THIS IS COMPATIBLE WITH THE FOREGOING. B. TO ADVANCE THE EDUCATION OF THE PUBLIC IN THE CONSERVATION, PROTECTION AND IMPROVEMENT OF THE NATURAL ENVIRONMENT OF PONDHEAD INCLOSURE, LYNDHURST, INCLUDING THROUGH SCHOOL VISITS AND THE PROMOTION OF VOLUNTEERING OPPORTUNITIES.

**Activities:** We are a conservation charity set up to restore 76 hectares of woodland which form part of the Crown lands of the New Forest, known as Pondhead Inclosure near Lyndhurst, Hampshire. We operate under a 10 year license from the Forestry Commission and our aim is to improve the area's biodiversity and public enjoyment by management of the woodland with a team of conservation volunteers.
