Activities: (1)To relieve the needs of people in Bangladesh.(2) The relief of financial need and suffering among victims of natural or other kinds of disaster. (3) To promote humane behaviour towards animals. (4) To act as a resource for young people:(a) advancing in life and helping young people by developing their skills;(b) advancing education;(c) relieving unemployment.
