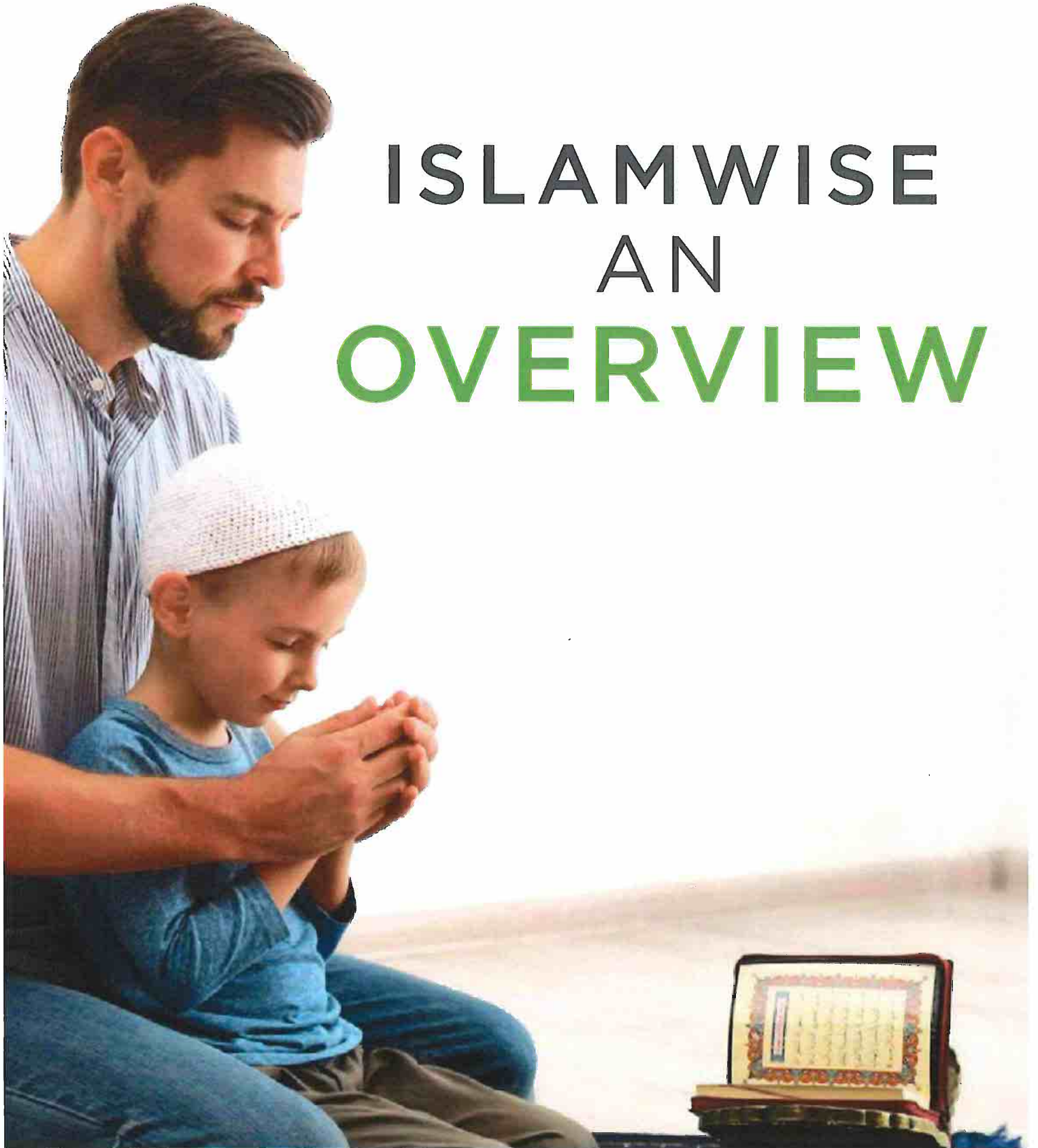

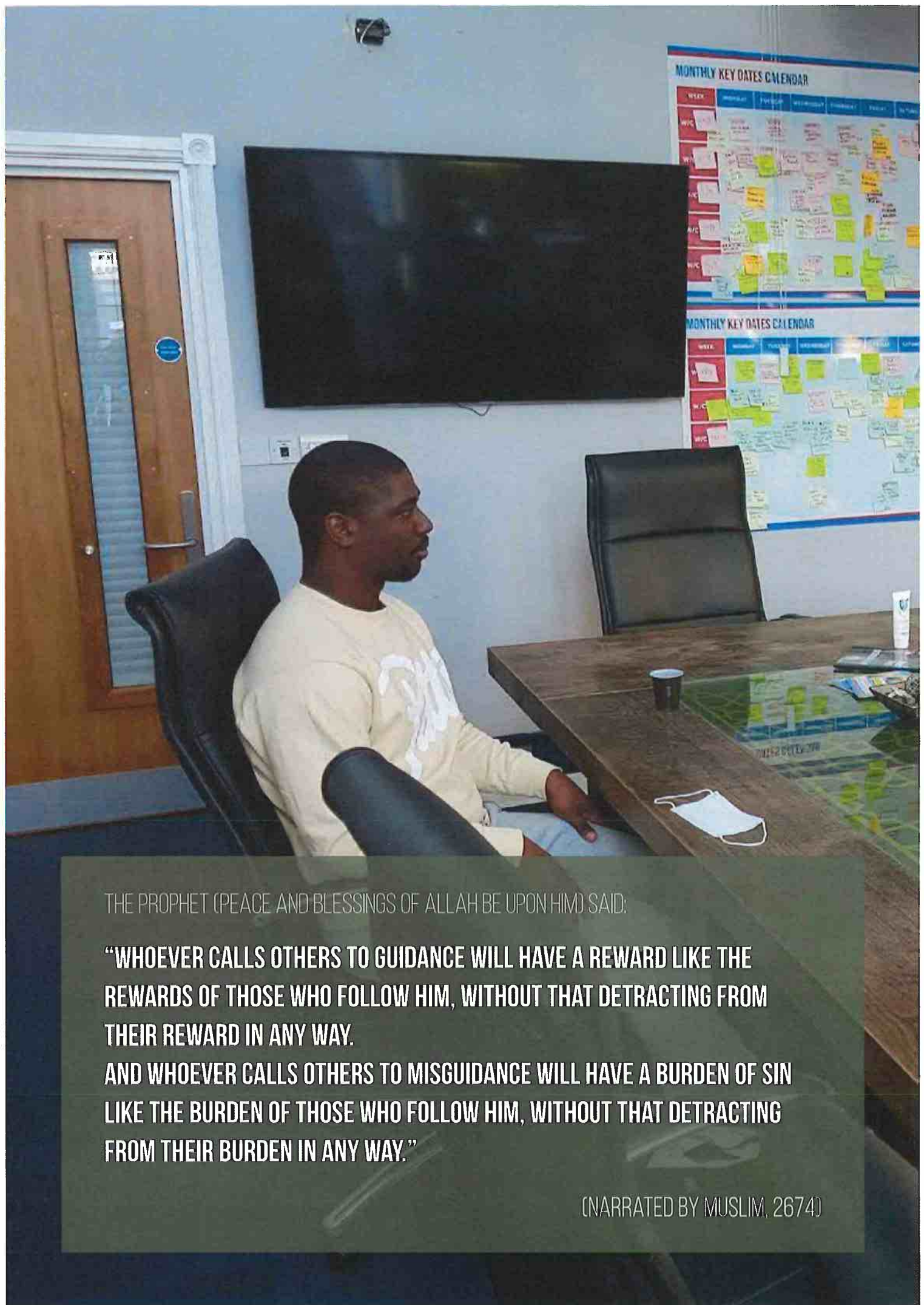

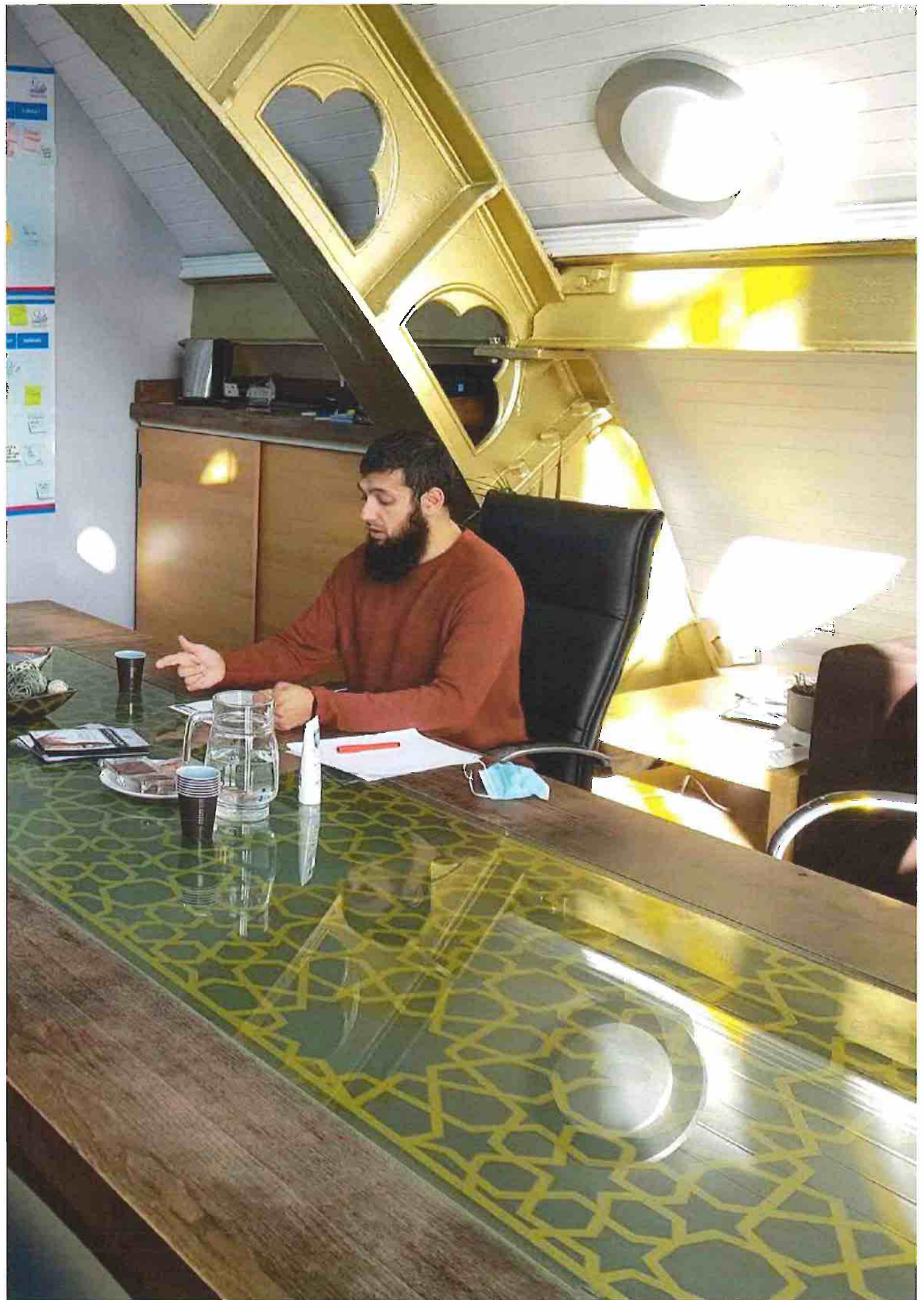

We continued to see a high number of enquiries from those interested in Islam and the services Islamwise has to offer. This led to **over 100 Shahadahs**, the distribution of **thousands of Qurans** and delivery of **over 400 hours** of Arabic and Quran lessons to revert Muslims!

At Islamwise, we have put in every effort to continue offering as much support and as many of our services as possible. Where we were unable to run any service, we endeavoured to develop and offer the best guidance and support possible to all.

We hope this annual report will give you an overview of the services and support that **you**, our sponsors and supporters, have made possible. As well as the hard work of our staff and volunteers.

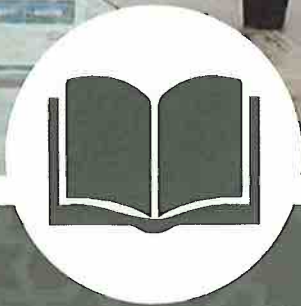

# Events & Open Days



Alongside sending out literature and Qurans to people, our team also get involved with inviting the public to learn more about Islam. We have done this at events such as mosque open days, school visits, supporting on dawah stalls, distributing gifts to corporate guests and even our own events.

For example: this year for Eid al Adha, the Islamwise team and volunteers went out to Birmingham town centre to hand out gifts and English translations of the Quran. Many of those who engaged with us were very grateful for the opportunity to take home a translation and other literature to increase their understanding of Islam.



These events are amazing opportunities to showcase Islam to new and wider audiences. We have repeatedly heard from recipients that they have always wanted a copy of the Quran, but didn't know where to get one from.

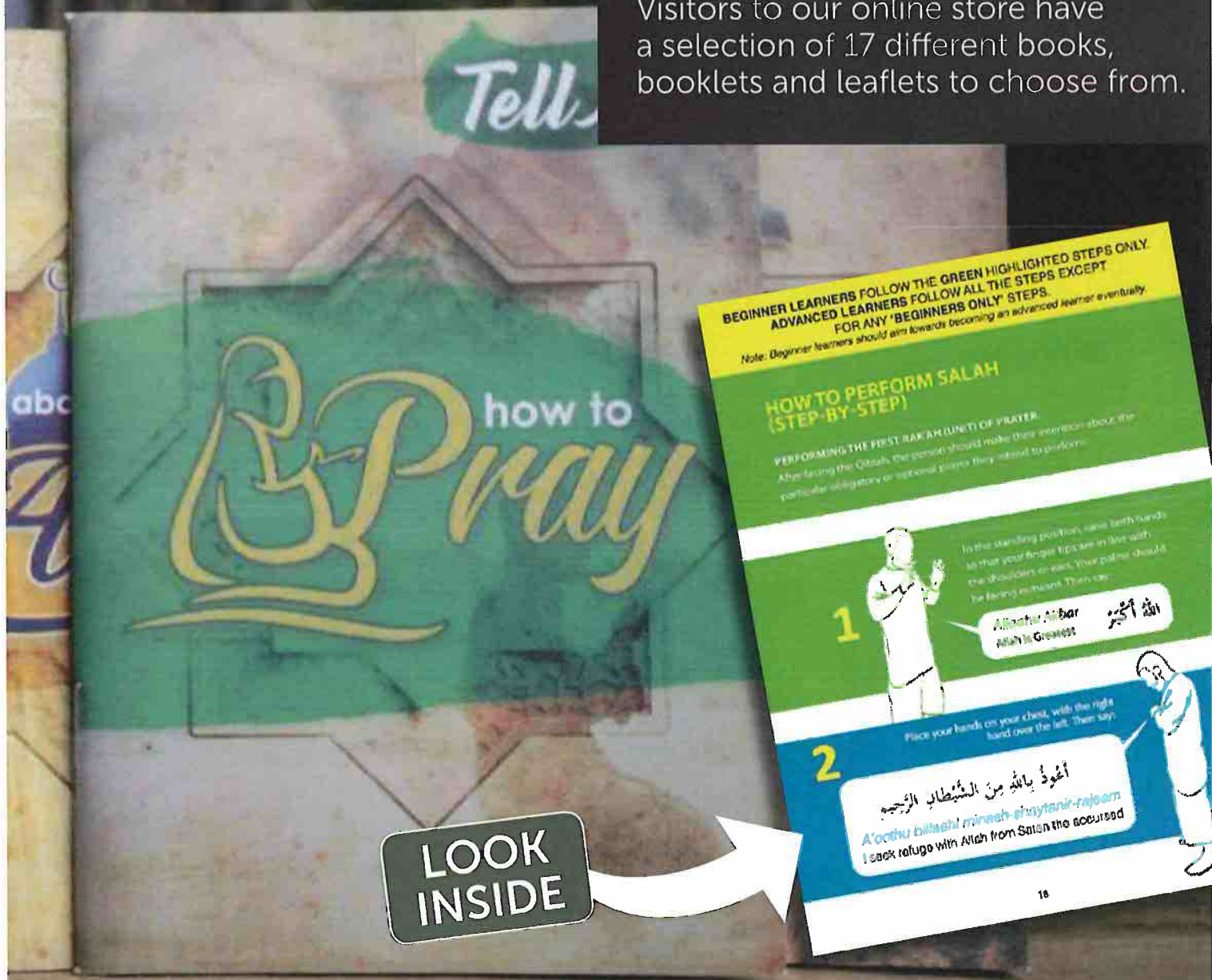

## LITERATURE AND QURAN DISTRIBUTION

Islamwise sends literature to individuals who are interested in Islam around the world!

Visitors to our online store have a selection of 17 different books, booklets and leaflets to choose from.



Our most popular request is for the translation of The Quran, followed by our booklets; Tell Me About Islam, Tell Me About Allah and Tell Me How to Pray. We saw a dramatic increase in the number of orders received, in fact we saw a total of 262 orders placed via our website alone! To facilitate access to our material to those abroad, our popular "Tell Me" series of books are also available as a digital download.





## IN 2021 WE HAD

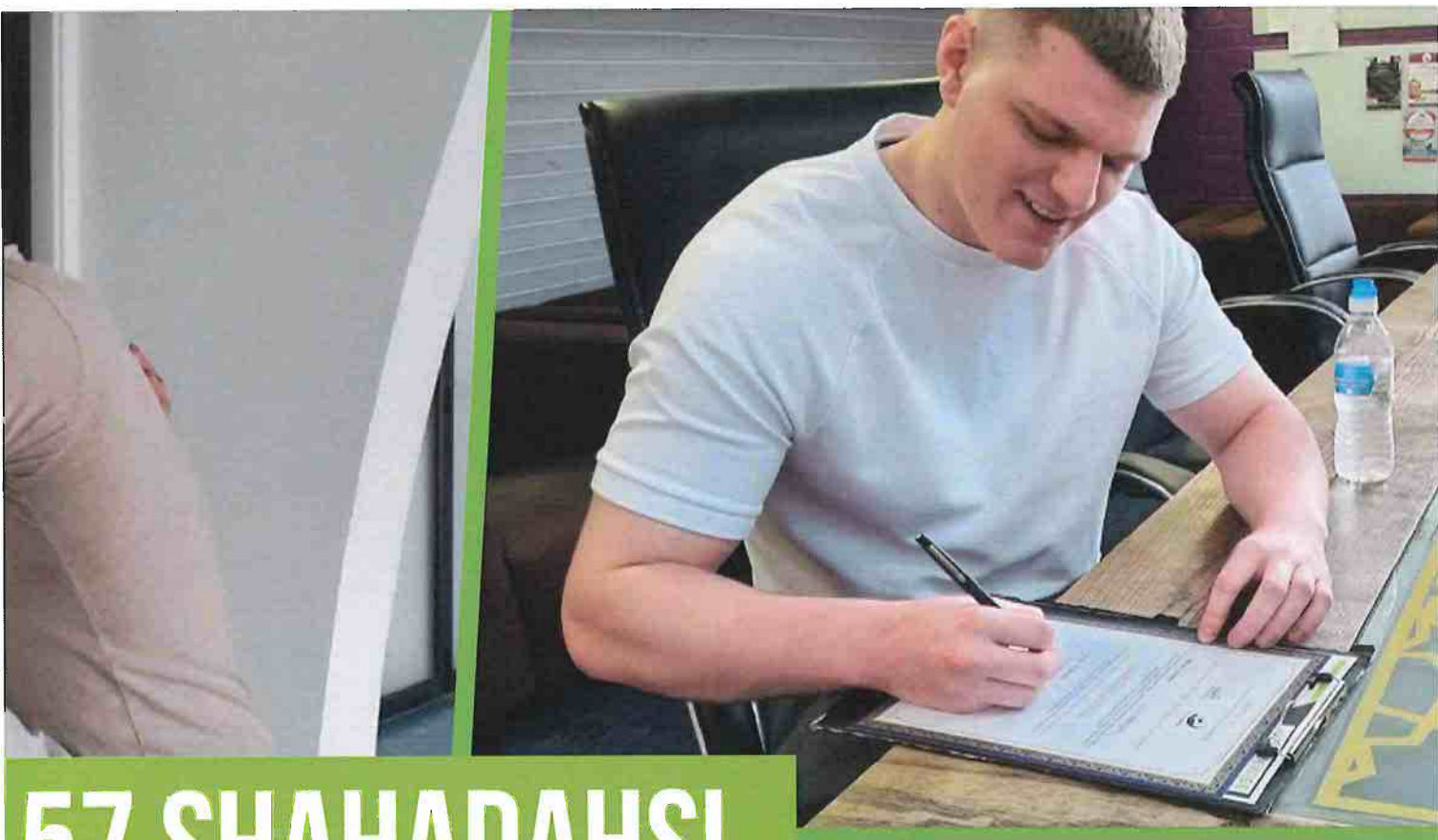

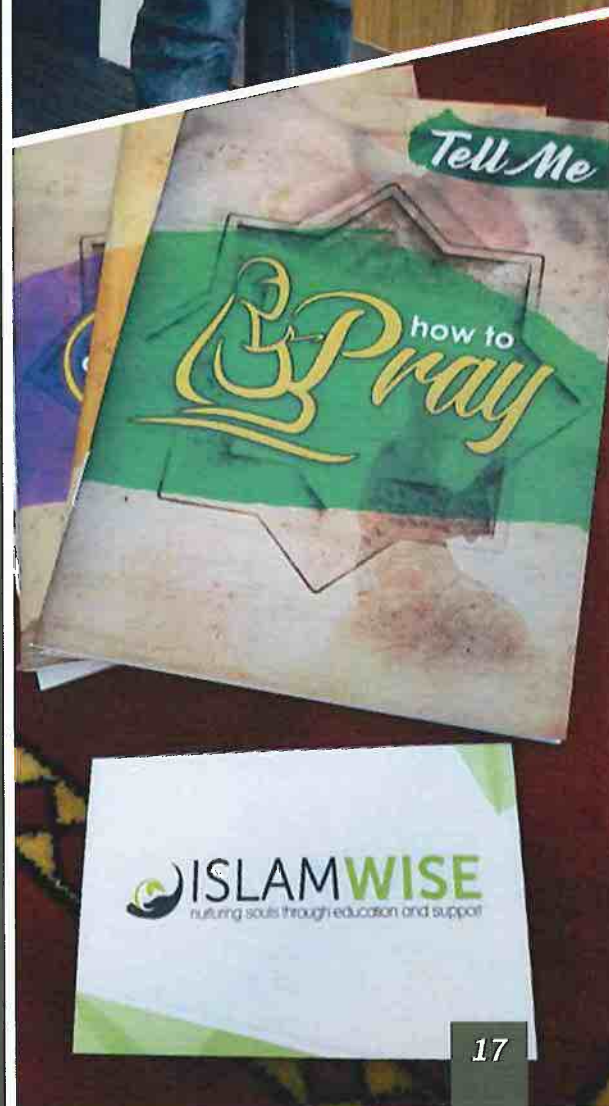


# NEW MUSLIM WELCOME PACKS

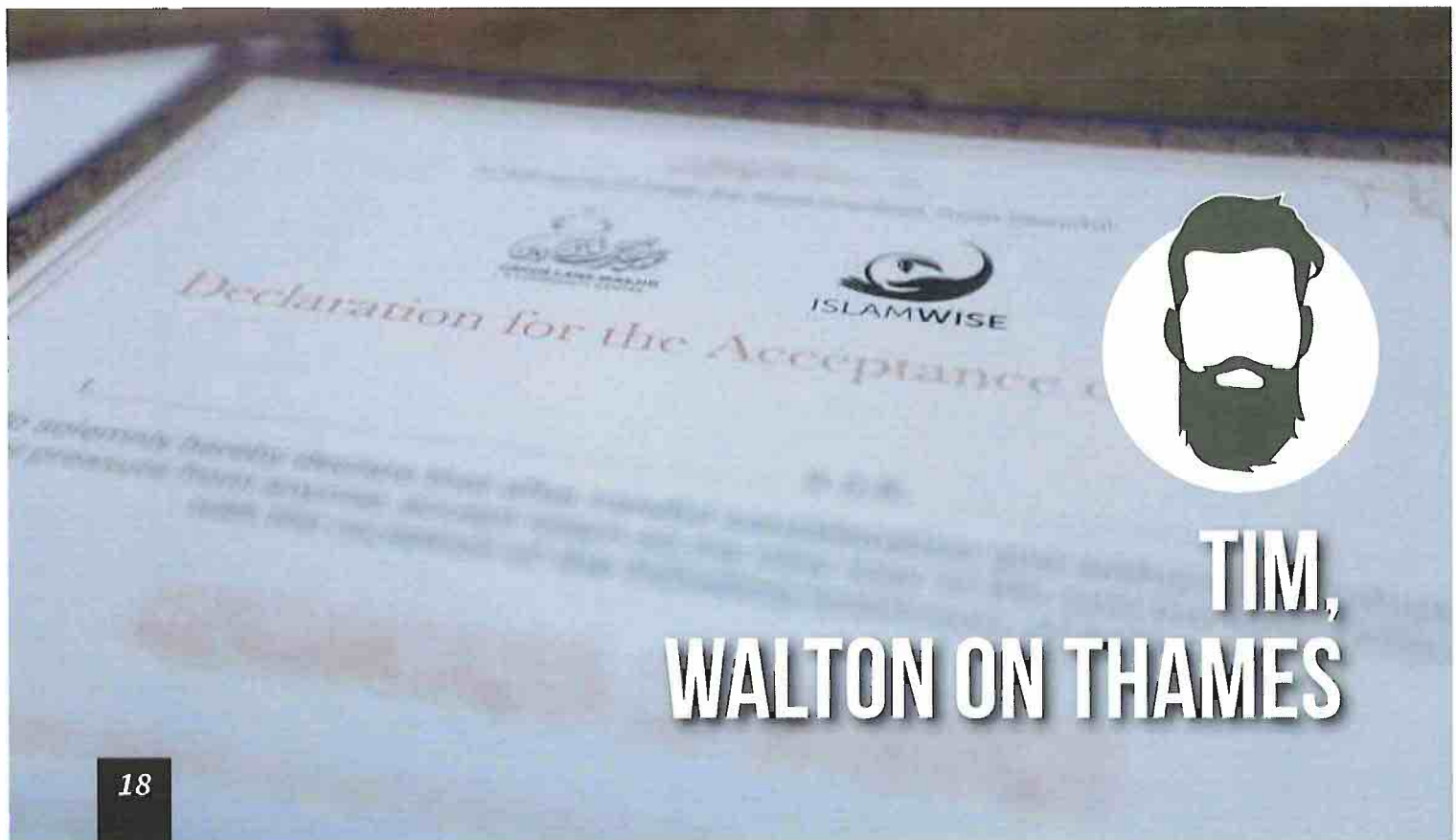

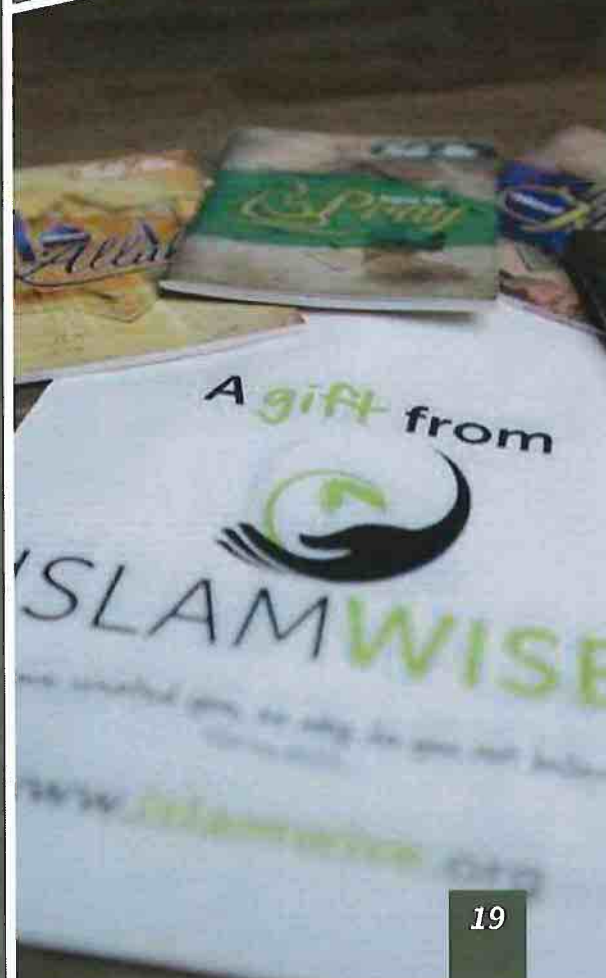
In 2021 we met a young lady who didn't practise any religion, however she had some good Muslim company and their company aroused an interest in Islam.

At Islamwise we are there to support our brothers and sisters through the many trials and decisions that we all endure. In 2021 we guided a number of the reverts we support through many events, including:

- The Nikkah, the process of the Islamic marriage
- The Janazah, funerals and questions around the burial rights of a Muslim
  - Wills, guidance on Islamic wills
- Counselling, guiding those in need towards the professional they require
  - Zakat, financial assistance for those in need



# Mentoring

We offer support and guidance to new Muslims every day. The support is in many forms and not limited to educating but also providing somewhere for new Muslims to go for emotional and social support.

The holistic wellbeing of reverts is a neglected area and we aim to offer support and help through our partner counselling and support services.

The initial aim of our mentors is to simply be there for the new Muslim as they start their new Muslim journey and beyond. As they progress other more complex questions may arise and we seek to support through access to information and reputable advisors.

Learning how to pray and making them feel comfortable as part of the Muslim community is a priority. The 1:1 support of the mentors has a huge positive impact on the new Muslims and is a **key part of what Islamwise does.**

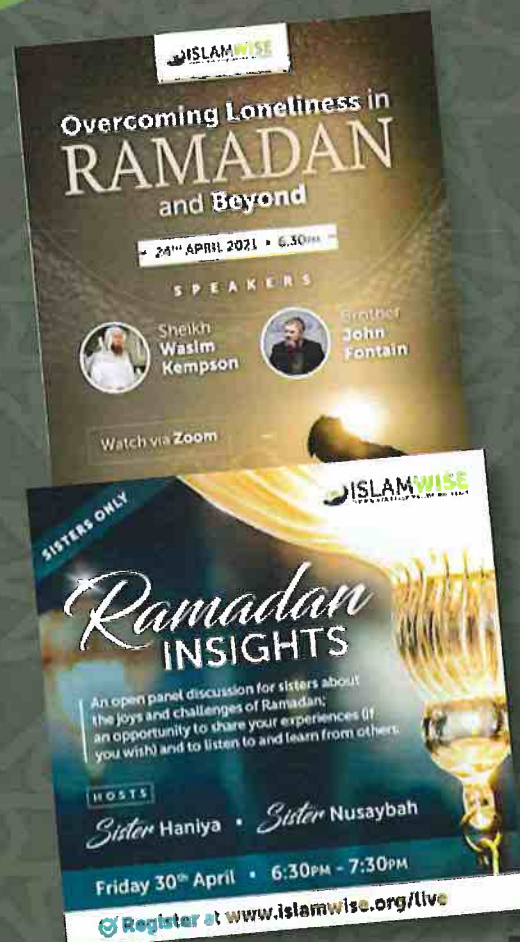
## EID GIFTS FOR NEW MUSLIMS

## EDUCATION

The education of every new Muslim is an essential part of their journey. We aim to provide the most appropriate and relevant courses for everyone. Every year we cover; new-Muslim focussed topics in our **live webinars**, **teach hundreds of hours Arabic** on our structured courses, record relevant **educational videos**, sponsor places on Islamic educational courses, including **Fiqh and Aqeedah**, as well as providing **hundreds of hours of Quran lessons**.

# Arabic Classes

One of our most popular and most requested courses is Arabic. We have now split our Arabic offering into two levels. **Arabic Essentials Level 1** is for absolute beginners, starting with the Arabic alphabet, and **Arabic Essentials Level 2** prepares the students to be able to start Quran lessons or move on to an Arabic programme. We therefore sponsor places on the Arabic courses run by GLM Educational College for those ready to move to the next level.

Over the last year, we have taught over **250 hours of Arabic to revert Muslims**. We aim to make the courses as accessible as possible and as such hosted them online, with great success. All of which was offered to our reverts for little or no cost, Alhumdulillah.

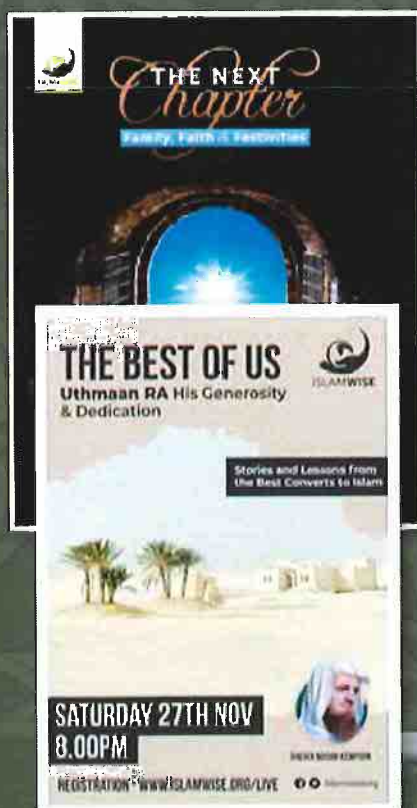

- The Sisters Monthly Tarbiyah Webinar – "Bow Down"

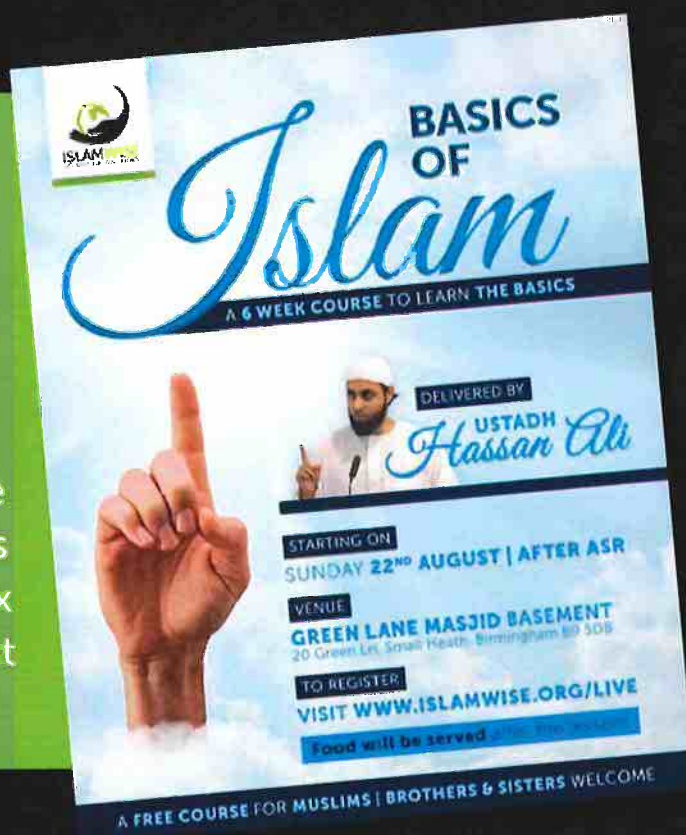




# On Site Courses

Alhumdulillah, with the gradual lifting of restrictions we were able to start offering more and more activities onsite. This marked the return of our weekly classes!

We have two main courses that we run for our new Muslim brothers and sister. Both were held over six weeks and cover some of the most essential topics.



Our Basics of Islam course teaches what every Muslim needs to know about Islam. The aim is to develop a love for Islam and turn the knowledge into action, as well as building a bond of brother/sisterhood with the other classmates. The topics covered included; Basics of Seeking Knowledge, the Pillars of Faith and Tawheed (Monotheism) & Shirk (Polytheism).





Our second course aims to soften the heart to be able to taste "The Sweetness of Faith" in our worship and connection with Allah. The topics covered included; Importance of a Pure Heart, Loving Allah (swt) and Connection with Allah through Dua.

After learning how to read in Arabic, our students progress on to reading the Quran. We offer sponsored places for **private online one-to-one Quran lessons**. This year we have formed a partnership with the newly launched, "The Online Quran Institute".

We have specifically asked for lessons to be made available to revert Muslims **free of charge**. In 2021 we were honoured to have **sponsored over 500 sessions** for our service users.

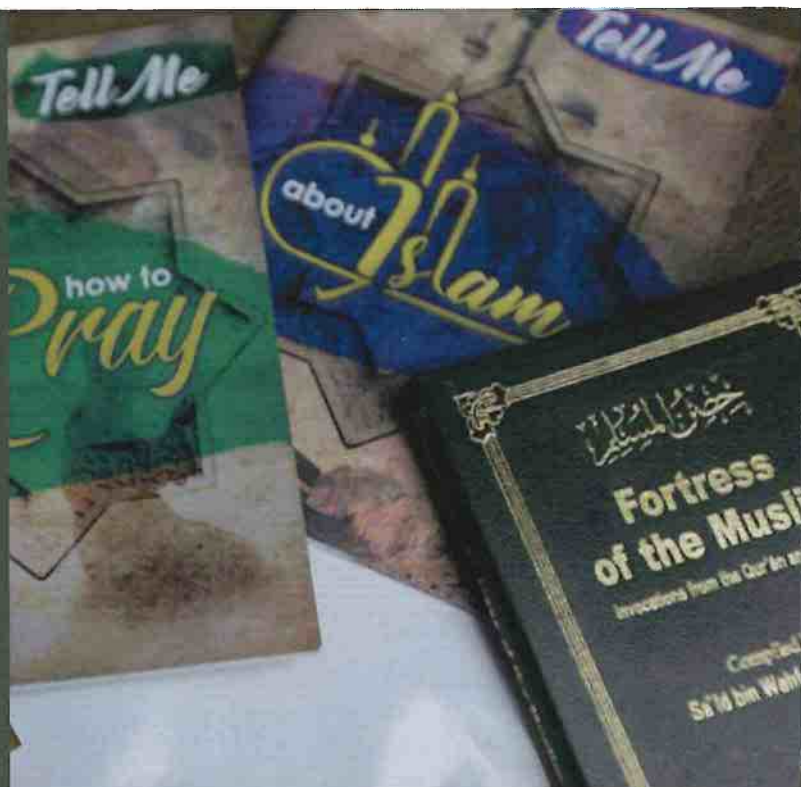

## MENTOR TRAINING

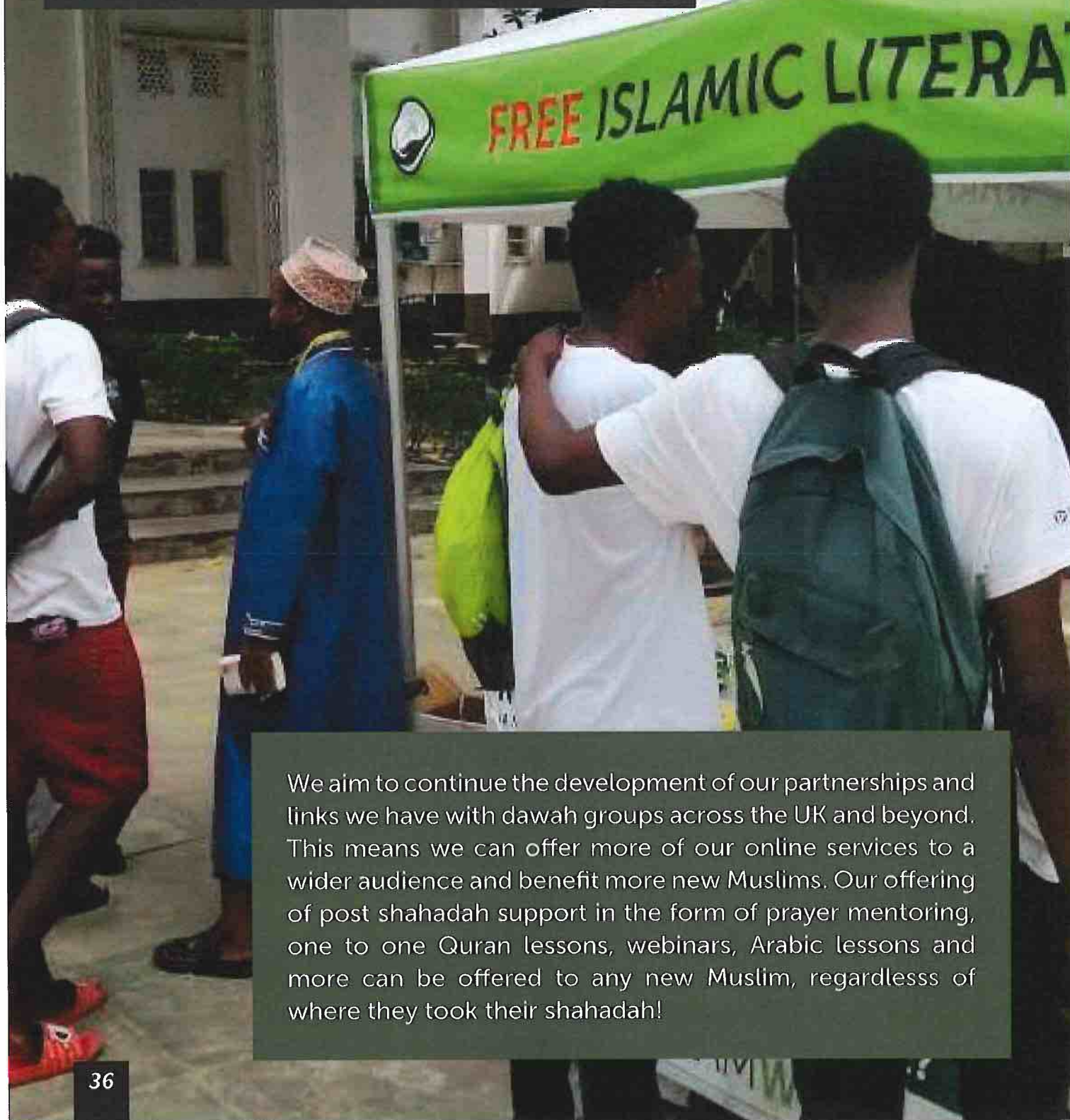
Our Mentor trainer, Coach Zubair (based in Canada), has created a video series on mentoring new Muslims that we have published via our YouTube channel.

We are always continuously seeking to develop our training and are working alongside Zubair and other organisations to develop the best ways support new Muslims. This has included training on "Convert Coaching" and a YouTube series called "New Muslim Prayers".



## WORKING WITH OTHER ORGANISATIONS

At Islamwise we are committed to work together towards the improvement of New Muslim support and services across the world. We have received books and support from a number of different charity organisations and shared our booklets and literature, with organisations across the world.



We aim to continue the development of our partnerships and links we have with dawah groups across the UK and beyond. This means we can offer more of our online services to a wider audience and benefit more new Muslims. Our offering of post shahadah support in the form of prayer mentoring, one to one Quran lessons, webinars, Arabic lessons and more can be offered to any new Muslim, regardless of where they took their shahadah!

# QURAN DISTRIBUTION

Every year Islamwise distributes thousands of copies of the Quran to dawah tables and our other partners, Alhumdulilah.



Over the course of the last year we have distributed thousands of Qurans to organisations across the world.

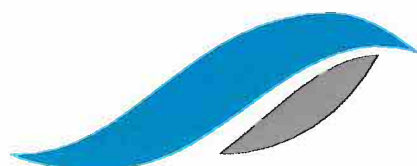

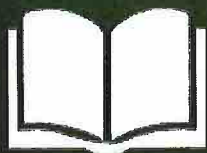

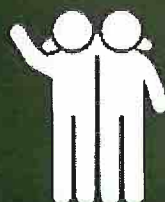

**Trustees' report**  
**For the year ended 31 December 2021**

---

The Trustees present their annual report together with the financial statements of the Company for the year 1 January 2021 to 31 December 2021. The Annual report serves the purposes of both a Trustees' report and a directors' report under company law. The Trustees confirm that the Annual report and financial statements of the charitable company comply with the current statutory requirements, the requirements of the charitable company's governing document and the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019).

Since the Company qualifies as small under section 382 of the Companies Act 2006, the Strategic report required of medium and large companies under the Companies Act 2006 (Strategic Report and Directors' Report) Regulations 2013 has been omitted.

The Company also trades under the name Islamwise.

**Objectives and activities**

**a. Policies and objectives**

Our objectives and aims

The objectives of the Charity as set out in its memorandum of association consist of the following:

- 1) To advance the Islamic faith without prejudice to the generality of the foregoing by any or all of the following:
  - (1) The propagation of the true message of Islam.
  - (2) Clarifying any misconceptions about the Islamic faith.
  - (3) The promotion of learning and appropriate support for any new Muslims.
- 2) Such other charitable purpose or purposes according to the law of England and Wales as the Trustees in their absolute discretion shall select from time to time.

In setting objectives and planning for activities, the Trustees have given due consideration to general guidance published by the Charity Commission relating to public benefit, including the guidance 'Public benefit: running a charity (PB2)'.

## **Achievements and performance**

### **a. Review of activities**

A detailed review of the activities of performed during the year can be found in the annual report on pages 1 to 44.

### **b. Main achievements of the Company**

At Islamwise, we focus on 4 key categories of work which are as follows:

- 1) Conveying Islam.
- 2) Supporting new Muslims.
- 3) Education.
- 4) Empowering others.

Each of these areas of work have a list of activities and services to help us fulfil our vision.

Although 2021 was a tough year with Covid-19 impacting many of our activities and services, we were still able to carry out essential work and continue with numerous services. Here is a quick summary of what we did.

#### Conveying Islam

In 2021 we facilitated over 50 Shahadahs, sent out hundreds of books and leaflets and engaged in conversations with non-Muslim online. Our dawah tables were in full operation through the year and we were able to become more active on social media by recording more video content.

We were also able to continue to carry out talks in external venues such as universities to raise awareness about new Muslims.

#### Supporting new Muslims

At Islamwise, we support many new Muslims on a weekly basis. From new Muslim gift packs to mentoring, we endeavour to provide all our beneficiaries with the highest level of support. This year also introduced new chat groups and have had an increased number of online interactions to offer the services we were unable to facilitate in person last year.

We also had regular social gatherings which were postponed during lockdown in 2020. In 2021 we were able to have a full gathering at Eid (with Covid precautions) when we came out of lockdown. For many new Muslims, Eid can feel like a lonely time so such events are essential to the support we provide.

#### Education

The education of every new Muslim is an essential part of their journey. We aim to provide the most appropriate and relevant courses for everyone. We cover new-Muslim focussed topics on our live monthly webinars, run regular beginner's Arabic courses, record relevant educational video series and sponsor places on Fiqh and Adeeqah courses.

This year we also partnered with Green Lane Masjid to provide free one on one Quran lessons to new Muslims. Sometimes such learning requires more intense sessions to accelerate progress. Such lessons have been very well received by the new Muslim community with many new Muslims reaching out to us for this essential service.

We have provided over 200 hours of group Arabic classes and over 150 hours of Quran lessons for the new Muslims that we support. We have also sponsored over 30 free student places on Fiqh and Adeeqah courses with Green Lane Masjid Educational College.



## **Achievements and performance (continued)**

### Empowering Others

There are many people and organisations that invite people to Islam and offer services for new Muslims. From London, here in the UK, to Mombasa in Kenya, Islamwise works alongside many partners to make the most of what we have to offer.

This year we continued to train Mosques and organisations on how to provide new Muslim support, distributed tens of thousands of dawah materials and Quran translations to teams around the world, delivered courses to educate brothers and sisters on how to correctly convey Islam and our instructors have trained mentors onsite and online to support new Muslims.

## **Financial review**

### **a. Going concern**

After making appropriate enquiries, the Trustees have a reasonable expectation that the Company has adequate resources to continue in operational existence for the foreseeable future. For this reason, they continue to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the accounting policies.

### **b. Reserves policy**

Reserves are represented by the fund balances as disclosed in the charity's balance sheet on page 10 of the financial statements.

The charity's balance sheet shows unrestricted reserves (reserves that do not carry any restrictions on how they can be used) of £170,776 at 31 December 2021 (2020: £105,127). In assessing our level of free reserves as at 31 December 2021, we also exclude unrestricted fixed assets totalling £Nil (2020: £758). This leaves free reserves of £170,776 as at 31 December 2021 (2020: £104,369).

## **Structure, governance and management**

### **a. Constitution**

Re-Enlighten is registered as a charitable company limited by guarantee and was set up by a Memorandum of Association.

### **b. Methods of appointment or election of Trustees**

The management of the Company is the responsibility of the Trustees who are elected and co-opted under the terms of the Memorandum of Association.

### **c. Organisational structure and decision-making policies**

The overall management and control of the charity is the responsibility of the Trustees who give their time freely and receive no remuneration or other benefits for carrying out their role.

The Trustees meet frequently throughout the year to make strategic and operational decisions.

**Structure, governance and management (continued)**

**d. Policies adopted for the induction and training of Trustees**

New Trustees undergo a briefing on their legal obligations under Charity law, the content of the memorandum and articles of association, the management and decision making processes, the business plan and recent financial performance of the charitable company. New Trustees also meet key employees and other Trustees. Trustees are encouraged to attend appropriate external training events where these will facilitate the undertaking of their role.

**e. Financial risk management**

The Trustees have assessed the major risks to which the Company is exposed, in particular those related to the operations and finances of the Company, and are satisfied that systems and procedures are in place to mitigate exposure to the major risks.

**Statement of Trustees' responsibilities**

The Trustees (who are also the directors of the Company for the purposes of company law) are responsible for preparing the Trustees' report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the Trustees to prepare financial statements for each financial year. Under company law, the Trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the Company and of its incoming resources and application of resources, including its income and expenditure, for that period. In preparing these financial statements, the Trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles of the Charities SORP (FRS 102);
- make judgments and accounting estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards (FRS 102) have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Company will continue in business.

The Trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the Company's transactions and disclose with reasonable accuracy at any time the financial position of the Company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the Company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

**1. General information**

Re-Enlighten is a charity registered in England and Wales with the Charity Commission and is incorporated as a private company limited by guarantee in England and Wales. The registered charity and company numbers, along with the registered office address, are given on page 1. The principal activity of the charity are set out in the Trustees' Report.

**2. Accounting policies**

**2.1 Basis of preparation of financial statements**

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) - Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

Re-Enlighten meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

**2.2 Going concern**

The Trustees have a reasonable expectation that the Group has adequate resources to continue in operational existence for a period of at least twelve months from the date of approval of these financial statements. Thus they have concluded that it is reasonable to continue to prepare the financial statements on a going concern basis.

**2.3 Income**

All income is recognised once the Company has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Other income is recognised in the period in which it is receivable and to the extent the goods have been provided or on completion of the service.

**2.4 Expenditure**

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the Company's objectives, as well as any associated support costs.

All expenditure is inclusive of irrecoverable VAT.



**2. Accounting policies (continued)**

**2.5 Taxation**

The Company is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the Company is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

**2.6 Tangible fixed assets and depreciation**

Tangible fixed assets costing £500 or more are capitalised and recognised when future economic benefits are probable and the cost or value of the asset can be measured reliably.

Tangible fixed assets are initially recognised at cost. After recognition, under the cost model, tangible fixed assets are measured at cost less accumulated depreciation and any accumulated impairment losses. All costs incurred to bring a tangible fixed asset into its intended working condition should be included in the measurement of cost.

Depreciation is charged so as to allocate the cost of tangible fixed assets less their residual value over their estimated useful lives, using the straight-line method.

**2.7 Debtors**

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

**2.8 Cash at bank and in hand**

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

**2.9 Liabilities and provisions**

Liabilities are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably.

Liabilities are recognised at the amount that the Company anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised in the Statement of financial activities as a finance cost.

**2. Accounting policies (continued)**

**2.10 Financial instruments**

The Company only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

**2.11 Pensions**

The Company operates a defined contribution pension scheme and the pension charge represents the amounts payable by the Company to the fund in respect of the year.

**2.12 Fund accounting**

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the Company and which have not been designated for other purposes.

**3. Critical accounting estimates and areas of judgment**

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Critical accounting estimates and assumptions:

The Company makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

Critical areas of judgment:

**Depreciation**

The Trustees have reviewed the asset lives and associated residual values of all fixed asset classes and have concluded that asset lives and residual values are appropriate given the activities of the charity.

**Income and expenditure allocation**

Income and expenditure incurred by the charity is apportioned where it relates to more than one category.
