**Activities:** The charity is inspired to relieve the poverty, advance the education and protect and preserve the health of orphaned girls living in Pakistan, who have lost their parents in natural disasters such as earthquakes and floods, in particularly but not exclusively, by the provision of an orphanage, inTehseel Kharyan, District Gujrat of Pakistan and in such other ways as the trustees may see fit.
