The objectives of the CIO are: 1) the prevention or relief of poverty 2) the advancement of education 3) the relief of those in need because of youth, ill health, disability, financial hardship or other disadvantage worldwide and in particular to the benefit of children living without secure or adequate accommodation in the streets, slums and refuse areas of Manila in the Philippines.

Achievements and performance

Summary of the main achievements of the charity during the year

In 2025, Anak-Tnk UK was able to collect GBP 10,181 through donations only. These donations plus the cash surplus (GBP 13,965) from last year, allowed Anak-Tnk UK to transfer GBP 16,483 to the Tnk Foundation in Manila to help buying rice and other basic goods and medicine for the street children of Manila.

Section E

Financial review

Brief statement of the charity's policy on reserves

Anak-Tnk needs to keep a minimum of cash for covering potential expenses for small fundraising events. Anak-Tnk has no other fixed costs than the monthly bank account fees of less than GBP100/year. Each year, Anak-Tnk UK tries to consistently send approximately between GBP10,000 and 15,000 to the Tnk Foundation as it is crucial for the foundation to be able to offer a stable and secure environment to its benefactors.

Details of any funds materially in deficit

Anak-Tnk UK has a cash position of GBP 7,578 as at 31/12/2025. Anak-Tnk UK has a sound financial position at the end of 2025, as it has cash only and no debt. Nevertheless, with a deficit of GBP 6,387 in 2025, Anak Tnk UK might have to reduce in 2026 the amount transferred to TNK Foundation in the Philippine.

The main risk for Anak-Tnk UK to stop operating is a lack of volunteers to run it and organize the fundraising events.


It is also key for Anak-Tnk UK to have a large base of small recurring donors.


