This year we have taken into foster 80 cats, neutered them and given them veterinary treatment before rehoming them.




Using social media we have continued to receive help from our supporters with donations which have helped us fund the neutering and veterinary fees for strays and cats who have been given up by their owners. We ran online raffles and sold calenders and Christmas card to gain donations. As an advocate charity of Cats Protection we continued to offer neutering vouchers to the general public for feral and owned cats whose owners cannot afford neutering. With the vouchers we assisted in neutering 80 cats and as such were able to actively promote neutering for cats over 4 months old. This year we have taken into foster 150 cats, neutered them and given them veterinary treatment before rehoming them.

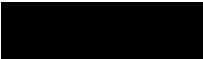



Due to Covid 19 restrictions and our efforts to protect the health of our volunteers we have not held face to face fundraising events and have been unable to continue with tiny cat café sessions. By continuing to build a network of adopters and people who follow the rescue on social media their donations have helped us fund the neutering and veterinary fees for strays and cats who have been given up by their owners. We have run online raffles, and sold Christmas Cards in an effort to boost funds. We had a lot more interest from people who were working from home and wished to foster for us so we set up 5 new home fosterers. The charity continued to offer advice and help via the website and facebook page and over the telephone. As an advocate charity of Cats Protection we continued to offer neutering vouchers to the general public for feral and owned cats whose owners cannot afford neutering. With the vouchers we assisted in neutering 80 cat and as such were able to actively promote neutering for cats over 4 months old. This year we have taken into foster 137 cats, neutered them and given them veterinary treatment before rehoming them.

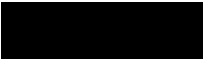

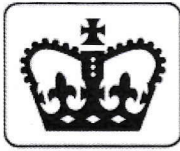
