Objects: THE CHARITY'S OBJECTS (THE OBJECTS) ARE:(1) TO ADVANCE THE ISLAMIC RELIGION, IN PARTICULAR BUT NOT EXCLUSIVELY BY THE PROVISION OF FACILITIES FOR WORSHIP AND FOR OTHER FUNCTIONS OF RELIGIOUS CHARACTER SUCH AS THE CELEBRATIONS OF RITES, CEREMONIES AND FESTIVALS;(2) TO RELIEVE FINANCIAL HARDSHIP OF THOSE WHO ARE IN CONDITIONS OF POVERTY, SICKNESS AND DISTRESS OR THOSE WHO ARE OTHERWISE IN CHARITABLE NEED;(3) TO PROMOTE FOR THE BENEFIT OF THE INHABITANTS OF HEMEL HEMPSTEAD AND THE SURROUNDING AREA THE PROVISION OF FACILITIES FOR RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABLEMENT, FINANCIAL HARDSHIP OR SOCIAL AND ECONOMIC CIRCUMSTANCES OR FOR THE PUBLIC AT LARGE IN THE INTERESTS OF SOCIAL WELFARE AND WITH THE OBJECT OF IMPROVING THE CONDITION OF LIFE OF THE SAID INHABITANTS.
