The nature of our organisation is to spread the Gospel of our Lord JESUS CHRIST as well as financial help for member if/where possible or needed. Sometimes that may come from any church’s member who does not want to be identified.

We feel the need to emphasise that, our main priority is to have our own or at least lease a building for our activities that why we are saving. Right now where we are, there are so many restrictions which are hindering us.
