To foster the public's knowledge and appreciation of music and thereby the advancement and support of the arts, culture and education for the public benefit; this is achieved in particular by the presentation of high quality public concerts with low ticket prices.

Naunton Music normally offers four classical music concerts each year, in the period May to September. Covid-19 pandemic restrictions resulted in various postponements/changes to our booked concerts; we were eventually able to run two concerts during the season. In promoting these concerts, the trustees have complied with their duty to have due regard to the public benefit guidance published by the Charity Commission. Audiences were provided with varied and extremely high quality performances, and ticket prices were kept low to fulfil our commitment to public accessibility.

Summary of the main achievements of the charity during the year

As the Covid-19 lockdown story continued during 2021, the management of concert arrangements continued to be piecemeal. We were forced to cancel or postpone the concerts booked for May, June and July. For each event, we asked the ticketholders whether they would like to have refunds or - where the concert had been postponed - to carry forward their ticket allocations to the 2022 season. We did pay some refunds but the majority either donated the ticket cost or retained their bookings.

The entire 2020 season had been postponed because of Covid-19. All major Supporters' and Friends' donations were therefore carried forward from that year and treated in the accounts as if they had been donated in this 2021 season instead, along with the associated gift aid. We therefore did not approach those people for further donations during the 2021 season.

By September 2021, it was apparent that it would be possible to run concerts again, though with reduced numbers and Covid precautions in place (e.g. mask-wearing). Thus two concerts took place:

On Friday 24 September 2021, the **Carducci String Quartet** played quartets by Haydn, Beethoven, Shostakovich and Dvorak.

On Saturday 9 October, the choral ensemble **The Tallis Scholars** performed the programme originally arranged for May 2020. This was entitled '*Metamorphosis*' and included works by composers from Roman Catholic, Anglican and Russian Orthodox traditions.

Both concerts were very well received after the long absence of live performance.

The charity's activities consist of an annual programme of concerts, which in practice requires musicians to be booked for at least a year in advance. It therefore endeavours to maintain sufficient financial reserves to ensure that, even if ticket sales are weaker than anticipated, it can nevertheless continue to run the planned concerts for the subsequent year.

Naunton Music's funds are generated from a combination of ticket sales and a Supporters' and Friends' scheme, whereby donations are made to the charity. On one occasion, these funds were supplemented by a legacy. All funds are applied towards producing the concerts, with the musicians' fees being by far the largest expense. The trustees consider that the key objectives of the charity have been met by the engagement of musicians of extremely high quality, offering attractive musical programmes with tickets at affordable prices.

The trustees are most grateful to all those who support the charity.
