To foster the public's knowledge and appreciation of music and thereby the advancement and support of the arts, culture and education for the public benefit; this is achieved in particular by the presentation of high quality public concerts with low ticket prices.

Naunton Music held four concerts during 2022; in promoting these concerts, the trustees have complied with their duty to have due regard to the public benefit guidance published by the Charity Commission. Audiences were provided with varied and extremely high quality performances, and ticket prices were kept low to fulfil our commitment to public accessibility.

Summary of the main achievements of the charity during the year

By late 2021, it was judged that it would be possible to revert to the 'normality' of running 4 concerts per year, accepting that some audience members might still be reluctant to attend events without any Covid-style restrictions. The following 4 concerts took place:

On Friday 20 May 2022, the choral ensemble **Tenebrae** performed a programme entitled '*Spanish glories of the Sixteenth Century*'. This included works by Victoria and Lobo.

On Friday 17 June, **Rachel Podger and Marcin Świątkiewicz** performed works for baroque violin and harpsichord by J.S. Bach, C.P.E. Bach, Franz Benda and Johann Graun. This was the concert originally scheduled for September 2020 but postponed because of the pandemic.

On Friday 8 July, pianist **Steven Osborne** played a programme of works by Debussy and Schubert.

The final concert of 2022 took place on Friday 23 September and featured the **Castalian String Quartet**. Quartets by Haydn, Britten and Beethoven were performed.

All of the concerts were very well attended.

The charity's activities consist of an annual programme of concerts, which in practice requires musicians to be booked for at least a year in advance. It therefore endeavours to maintain sufficient financial reserves to ensure that, even if ticket sales are weaker than anticipated, it can nevertheless continue to run the planned concerts for the subsequent year.

Naunton Music's funds are generated from a combination of ticket sales and a Supporters' and Friends' scheme, whereby donations are made to the charity. On one occasion, these funds were supplemented by a legacy. All funds are applied towards producing the concerts, with the musicians' fees being by far the largest expense. The trustees consider that the key objectives of the charity have been met by the engagement of musicians of extremely high quality, offering attractive musical programmes with tickets at affordable prices.
