Naunton Music held a series of four concerts during 2024; in promoting these concerts, the trustees have complied with their duty to have due regard to the public benefit guidance published by the Charity Commission. Audiences were provided with varied and extremely high quality performances, and ticket prices were kept low to fulfil our commitment to public accessibility.

The following 4 concerts took place:

On Friday 24 May 2024, the Baroque ensemble **Red Priest** performed works for recorder, violin, cello and harpsichord by J.S. Bach, Cima, Handel, Telemann, Couperin and Vivaldi.

On Friday 14 June, pianist **Benjamin Grosvenor** played a programme of works by Brahms, Liszt and Chopin.

On Friday 5 July, choral ensemble **The Carice Singers** performed a programme of works by J.S. Bach, Britten, Byrd and Pärt.

The final concert of 2024 took place on Friday 27 September and featured **Quatuor Agate** (string quartet). The programme included quartets by Boccherini, Ravel and Dvorak.

All of the concerts were very well attended and extremely well received.

The charity's activities consist of an annual programme of concerts, which in practice requires musicians to be booked for at least a year in advance. It therefore endeavours to maintain sufficient financial reserves to ensure that, even if ticket sales are weaker than anticipated, it can nevertheless continue to run the planned concerts for the subsequent year.

The trustees consider that the key objectives of the charity have been met by the engagement of musicians of extremely high quality, offering attractive musical programmes with tickets at affordable prices.


