To foster the public's knowledge and appreciation of music and thereby the advancement and support of the arts, culture and education for the public benefit; this is achieved in particular by the presentation of high quality public concerts with low ticket prices.

Naunton Music held a series of four concerts during 2025; in promoting these concerts, the trustees have complied with their duty to have due regard to the public benefit guidance published by the Charity Commission. Audiences were provided with varied and extremely high quality performances, and ticket prices were kept low to fulfil our commitment to public accessibility.

Summary of the main achievements of the charity during the year

The following 4 concerts took place:

On Friday 23 May 2025, the **Skampa Quartet** from Prague performed works by Mozart, Janacek and Brahms.

On Friday 20 June, choral ensemble **Stile Antico** performed a sold-out concert celebrating the quincentenary of Palestrina.

On Friday 4 July, pianist **Mishka Rushdie Momen** played a programme of works by Schubert and Janacek.

The final concert of 2025 took place on Friday 26 September and featured **Trio Gaspard** (piano, violin and cello). The programme included piano trios by Haydn, Martinu and Dvorak and also included a new work commissioned by the trio.

All of the concerts were very well attended and extremely well received.

The charity's activities consist of an annual programme of concerts, which in practice requires musicians to be booked for at least a year in advance. It therefore endeavours to maintain sufficient financial reserves to ensure that, even if ticket sales are weaker than anticipated, it can nevertheless continue to run the planned concerts for the subsequent year.

Naunton Music's funds are generated from a combination of ticket sales and a Supporters' and Friends' scheme, whereby donations are made to the charity. On one occasion, these funds were supplemented by a legacy. All funds are applied towards producing the concerts, with the musicians' fees being by far the largest expense. The trustees consider that the key objectives of the charity have been met by the engagement of musicians of extremely high quality, offering attractive musical programmes with tickets at affordable prices.

The trustees are most grateful to all those who support the charity.






