Due to the restrictions in place, it has been another difficult year for the charity.

However, we can report that on the 26th August 2021, Members of the community shared their concerns with Kate Griffiths MP at the centre about their families and friends who are left behind in Afghanistan. They asked the MP to raise her voice in the Houses of Parliament to evacuate their families from Afghanistan. Members of the community are from the Hazara ethnic tribe and are currently facing genocide and discrimination.
