Annual Trustees report September 2024 to August 2025

Theravada Buddhist Trust (TBT)

Theravada (school of the elder monks) is a branch of Buddhism that uses the teaching of the oldest recorded Buddhist texts. It is the dominant form of religion in Myanmar (formerly Burma) and its neighbours, Thailand, Cambodia, Laos and Sri Lanka.

Annual report by the board of Trustees for the financial year ended 31 August 2025

1. Objectives and activities

Our aims and objectives are clearly stated in our trust deeds which are summarised below:

(1) To advance the Theravada Buddhist practice in the Yorkshire area for the benefit of the public by encouraging and facilitating religious practice through provision of place of worship. This will hold religious ceremonies, mass chanting open to the public, prayers meetings, public celebration of religious festivals plus long and short stay meditation retreats.

(2) To promote awareness and understanding of Theravada Buddhism by providing regular religious teachings and meditation practice for the public.

(3) To provide religious devotional acts by facilitating the Buddhist reverend, visiting the sick for encouragement and support of pastoral work

2. Worship and prayer

There is regular chanting, group meditation and discussion of Buddha's teaching by attendees at the monastery as indicated by the daily programme below.

6:00 Chanting. 18:30 Chanting

The activities above give spiritual support and fulfilment to the Buddhist community in Sheffield and beyond. People from surrounding areas as far as Leeds, Manchester and even from London attended these meetings. The meditation and Dhamma discussion sessions are quite useful for the attendees to further their knowledge on the teachings of the Buddha and enhance their practice of insight meditation.

Children's classes to learn Burmese literature and culture also bring enormous benefits to the children who are keen to learn their language of their homeland which they have left for so many years. Children are actively encouraged to be involved in these activities promoted by the monastery to maintain the culture of the ethnic minorities of Burma.

3. Other religious and fund-raising activities

In addition to the above activities there are regular religious activities carried out under the direction of the resident Buddhist monk and teacher Venerable Ashin Gawsaka. These are important days in the Buddhist calendar as depicted below.

These events are well attended by devotees and members of the TBT. Most of these events are conducted in hired community halls or school sports halls to accommodate the number of people attending these events which include not only Myanmar devotees but also people from various backgrounds like British, Europeans and Asians.

i) Buddha Day or Vesak.

This ceremony was conducted on 3 May 2025

This is to honour the birth, enlightenment and passing away of the Buddha. In temples all over the world Buddhists engage in prayers and reflect on the virtues of wisdom, courage, and compassion of the Buddha.

TBT organised this event at the TBT monastery, Sheffield, which includes group chanting and praying, readings about Buddha's life and his achievements.

(ii). Waso robe ceremony

This ceremony was conducted on 12 July 2025

This ceremony commemorates the first sermon of the Buddha and marks the beginning of the Buddhist lent. Monks were offered new robes (Waso robes) and other requirements to tide them through the months ahead. Children were encouraged to do readings about the first sermon and group chanting of Buddha's first sermon were performed by the members of the Trust and attending guests. This was conducted at TBT monastery, Sheffield.

(iii) Abhidhamma Day

This is also called the Festival of Lights, marking the end of Buddhist Lent, held on the full moon day of Thadingyut (usually in October). This last for three days in Burma. Houses and streets are festively decorated and illuminated during this festive period.

It was celebrated by TBT members at TBT monastery Sheffield, by offering decorative lights to the Buddha, group chanting and refreshments for the guest. In accordance with the tradition younger members paid homage to the elders of the Trust and elders gave pocket money to the children.

The ceremony was conducted on 6-10-24

(iv) Kathina Ceremony 2-11-24

This is the largest alms giving ceremony of the Buddhist year. It occurs at the end of Vassa, or monsoon period, in October and November. During the rains retreat the Buddhist monks would have remained in one place for three months, and the Kathina celebration marks the time for them to move on. The festival also celebrates the offering of Kathina robe to the monks by lay people. This was celebrated by TBT members in a hired school sports hall/community hall due to large numbers of devotees attending. The ceremony began by offering lunch to the invited monks and guest.

The Kathina robes, gifts and cash were offered to the monks followed by talks and readings about Kathina ceremony, ending with a group prayer. All donations went to TBT. Devotees donated Kathina robes as usual. This year it was a collective sponsored event. All the members of the Theravada Buddhist Trust and Dhamma friends chipped in to celebrate this auspicious event.

4. Myanmar traditional community activities

(i). Annual Htamanae (crushed glutinous rice) ceremony.

This is historically a celebration of rice harvest marked by cooking of special sticky rice made with sesame seeds, peanuts, and ginger.

TBT members cooked Htamanae in large woks and offer this to the Buddha, monks and attending guest. There was also group chanting, praying and sharing of merits. The ceremony was conducted on 8-2-25.

(iii). Memorial days and Birthday celebrations

These were conducted by the resident monks. Between September 2024 and August 20245 there were 51 memorial services and 72 birthday blessings.

(iv). Regular second Saturday of the month meditation and collective food offering by TBT members. These were deferred since the pandemic.

(v). Ad Hoc visits to the monastery by families

There were 61 visits to the monastery to pay homage to the resident monks and make donations to TBT.

(vi). Bereavement support

The spiritual director regularly gives bereavement support to bereaved families in accordance with the Myanmar culture and Theravada Buddhist tradition. This is a much-needed service for the Myanmar community living in this area and beyond.

(vii). Ordination to monkhood

Every Myanmar man has to enter monk-hood temporarily as a novice and a monk at least once in their lifetime at a certain age to learn Buddhist scriptures and meditation. These ceremonies are conducted by the resident monk for those who wish to go through with this experience. There were 2 ceremonies this period.

5. Activities of the resident monk

Ashin Gawsaka

There were 17 home visits/ housewarming blessings.

He was also invited to other Myanmar monasteries in Birmingham, London, Manchester to attend Kathina, Waso and ordination ceremonies. He was also invited to the newly formed Thai monastery in Doncaster.

He hosted two Myanmar monks one from USA who visited the monastery.

He visited Hospitals in Sheffield as the Buddhist Chaplain.

6. Structure, Governance and Management

Their work includes moving chairs, cooking, cleaning, putting up decorations, washing up, throwing waste, and serving food to the guest on large occasions. These volunteers also regularly clear the garden and cut down the branches of overgrown trees. For the past two years Myanmar students from Sheffield University have regularly visited the monastery to clear the garden and help prepare for big events. We would like to acknowledge their hard work, dedication, and support to the organisation.

9. Humanitarian aid efforts

Due to the political crisis in Myanmar, there are a lot of needy people and internally displaced people(IDP). Following donations were made by TBT members and Dhamma friends this period.

£600 to the flood victims in Myanmar on 13-09-24 and £1000 to the earthquake victims in Myanmar in April 2024.

10. Other developments

An application has been submitted to invite another monk from Myanmar to assist the resident monk.

1.Younger members of the Trust, especially Myanmar students from Sheffield University are more involved in the work of the trust.



Due to the political crisis in Myanmar there are a lot of needy places there. Following donations were made by TBT members and Dhamma friends

- (I) A £500 donation was made to Mawgyun Sayadaw in Myanmar , who was sick.
- (II) A donation of £600 was made to the flood victims in Myanmar. All Dhamma friends in Sheffield contributed to this fund.

- (III) A £300 donation was made to Mahagandaryon Sayadaw, in Myanmar, for his 75 th birthday

Theravada Buddhist Trust (TBT)

Theravada (school of the elder monks) is a branch of Buddhism that uses the teaching of the oldest recorded Buddhist texts. It is the dominant form of religion in Myanmar (formerly Burma) and its neighbours, Thailand, Cambodia, Laos and Sri Lanka.

Annual report by the board of Trustees for the financial year ended 31 August 2023.

1. Objectives and activities

Our aims and objectives are clearly stated in our trust deeds which are summarised below:

(1) To advance the Theravada Buddhist practice in the Yorkshire area for the benefit of the public by encouraging and facilitating religious practice through provision of place of worship. This will hold religious ceremonies, mass chanting open to the public, prayers meetings, public celebration of religious festivals plus long and short stay meditation retreats.

(2) To promote awareness and understanding of Theravada Buddhism by providing regular religious teachings and meditation practice for the public.

(3) To provide religious devotional acts by facilitating the Buddhist reverend, visiting the sick for encouragement and support of pastoral work

2. Worship and prayer

There is regular chanting, group meditation and discussion of Buddha's teaching by attendees at the monastery as indicated by the daily programme below.

6:00 Chanting. 18:30 Chanting

Wednesday and Sunday 20:00 – 21:30 Group Meditation, Dhamma talks and reading of Buddhist scriptures like Anguttara Nikaya by Zoom meetings.

Second week of Saturday every month, 10:00 to 14:00 (offering food, chanting, group meditation and Dhamma discussion.)

The activities above give spiritual support and fulfilment to the Buddhist community in Sheffield and beyond. People from surrounding areas as far as Leeds, Manchester and even from London attended these meetings. The meditation and Dhamma discussion sessions are quite useful for the attendees to further their knowledge on the teachings of the Buddha and enhance their practice of insight meditation. These have been suspended at the moment.

Children's classes to learn Burmese literature and culture also bring enormous benefits to the children who are keen to learn their language of their homeland which they have left for so many years. Children are actively encouraged to be involved in these activities promoted by the monastery to maintain the culture of the ethnic minorities of Burma. These classes have been suspended since COVID-19.

3. Other religious and fund-raising activities

In addition to the above activities there are regular religious activities carried out under the direction of the resident Buddhist monk and teacher Venerable Ashin Gawsaka. These are important days in the Buddhist calendar as depicted below.

These events are well attended by devotees and members of the TBT. Most of these events are conducted in hired community halls or school sports halls to accommodate the number of people attending these events which include not only Myanmar devotees but also people from various backgrounds like British, Europeans and Asians.

i) Buddha Day or Vesak.

This ceremony was conducted on 6 May 2023

This is to honour the birth, enlightenment and passing away of the Buddha. In temples all over the world Buddhists engage in prayers and reflect on the virtues of wisdom, courage, and compassion of the Buddha.

TBT organised this event at the TBT monastery, Sheffield, which includes group chanting and praying, readings about Buddha's life and his achievements.

(ii). Waso robe ceremony

This ceremony was conducted on 5 August 2023

This ceremony commemorates the first sermon of the Buddha and marks the beginning of the Buddhist lent. Monks were offered new robes (Waso robes) and other requirements to tide them through the months ahead. Children were encouraged to do readings about the first sermon and group chanting of Buddha's first sermon were performed by the members of the Trust and attending guests. This was conducted at TBT monastery, Sheffield.

(iii) Abhidhamma Day

This is also called the Festival of Lights, marking the end of Buddhist Lent, held on the full moon day of Thadingyut (usually in October). This lasts for three days in Burma during which houses and streets are festively decorated and illuminated.

Usually it was celebrated by TBT members at TBT monastery Sheffield, by offering decorative lights to the Buddha, group chanting and refreshments for the guest. In accordance with the tradition younger members paid homage to the elders of the Trust and elders gave pocket money to the children.

The ceremony was conducted on 9-10-22

(iv) Kathina Ceremony 29-10-22

This is the largest alms giving ceremony of the Buddhist year. It occurs at the end of Vassa, or monsoon period, in October and November. During the rains retreat the Buddhist monks will have remained in one place for three months, and the Kathina celebration marks the time for them to move on. The festival also celebrates the offering of Kathina robe to the monks by lay people.

This was celebrated by TBT members in a hired school sports hall/community hall due to large numbers of devotees attending. The ceremony began by offering lunch to the invited monks and guest.

The Kathina robes, gifts and cash were offered to the monks followed by talks and readings about Kathina ceremony, ending with a group prayer. All donations went to TBT. Devotees donated Kathina robes as usual. This year it was a collective sponsored event. All the members of the Theravada Buddhist Trust and Dhamma friends chipped in to celebrate this auspicious event.

4. Myanmar traditional community activities

(i). Annual Htamenae (crushed glutinous rice) ceremony.

This is historically a celebration of rice harvest marked by cooking of special sticky rice made with

sesame seeds, peanuts, and ginger.

TBT members cooked Htamanae in large woks and offer this to the Buddha, monks and attending guest. There was also group chanting, praying and sharing of merits. The ceremony was conducted on 4-2-23

(iii). Memorial days and Birthday celebrations

These were conducted by the resident monks. Between September 2022 and August 2023 there were 39 memorial services and 34 birthday blessings .

(iv). Regular second Saturday of the month meditation and collective food offering by TBT members. These were deferred since the pandemic.

(v). Ad Hoc visits to the monastery by families

There were 41 visits to the monastery to pay homage to the resident monks and make donations to TBT.

(vi). Bereavement support

The spiritual director regularly gives bereavement support to bereaved families in accordance with the Myanmar culture and Theravada Buddhist tradition. This is a much-needed service for the Myanmar community living in this area and beyond.

(vii). Ordination to monk-hood

Every Myanmar men has to enter monk-hood temporarily as a novice and a monk at least once in their lifetime at a certain age to learn Buddhist scriptures and meditation. These ceremonies are conducted by the resident monk for those who wish to go through with this experience.

There was one ceremony this period.

5. Activities of the resident monks

Ashin Gawsaka

He visited USA from 18-03-23 to 31-05-23 and went to many Myanmar Theravada Buddhist monasteries in USA to observe Buddhist ceremonies there. He also exchanged views on how missionary work was done in USA and UK.

There were 11 home visits/ housewarming blessings .

Both the resident monks were invited to other Myanmar monasteries in Birmingham, London and Manchester to attend Kathina, Waso and ordination ceremonies.

Ashin Khemika Linkara

Since his arrival he has been busy carrying out religious activities including Dhamma talks, meditation sessions and standing in for Ashin Gawsaka when he is away. He had to return to Myanmar on 12-7-23 to manage his own monastery there. A farewell ceremony was held on 12-07-23, which was well attended by members of Theravada Buddhist Trust and many devotees.

He continued to hold Dhamma teaching sessions from Myanmar by Zoom for devotees here on Wednesdays.

The Kathina robes, gifts and cash were offered to the monks followed by talks and readings about Kathina ceremony, ending with a group prayer. All donations went to TBT. Devotees donated Kathina robes as usual. This year it was sponsored by 1993 graduates of Institute of Medicine (1), Yangon.

4. Myanmar traditional community activities

(i). Annual Htamenae (crushed glutinous rice) ceremony.

This is historically a celebration of rice harvest marked by cooking of special sticky rice made with sesame seeds, peanuts, and ginger.

TBT members cooked Htamenae in large woks and offer this to the Buddha, monks and attending guest. There was also group chanting, praying and sharing of merits. The ceremony was conducted on 19-02-22

(iii). Memorial days and Birthday celebrations

These were conducted by the resident monk. Due to the pandemic these blessings were done in accordance with the COVID-19 regulations. Between September 2021 and August 2022 there were 46 memorial services and 39 birthday blessings .

(iv). Regular second Saturday of the month meditation and collective food offering by TBT members. These were deferred due to the pandemic.

(v). Ad Hoc visits by families

There were 24 visits to the monastery.

(vi). Bereavement support

The spiritual director regularly gives bereavement support to bereaved families in accordance with the Myanmar culture and Theravada Buddhist tradition. This is a much-needed service for the Myanmar community living in this area and beyond.

(vii). Ordination to monk-hood

Every Myanmar men has to enter monk-hood temporarily as a novice and a monk at least once in their lifetime at a certain age to learn Buddhist scriptures and meditation. These ceremonies are conducted by the resident monk for those who wish to go through with this experience.

There were two ceremonies this period.

5. Activities of the resident monk Venerable Ashin Gawsaka

Due to the pandemic Ashin Gawsaka activities were reduced. There were 6 home visits/ housewarming blessings in accordance with the pandemic regulations.

6. Special Birthday celebration for Daw Aung San Suu Kyi 19-6-21

A special ceremony was conducted to mark Daw Suu's birthday as a UK country wide support by Myanmar Buddhist devotees for her.

7. Structure, Governance and Management

Governing document

TBT is a charitable trust registered with the Charity Commission in December 2014 (reg. Charity number 1160584.) and governed by a Trust Deed approved by the Charity Commission on December 2014. This is available on the Charity Commission web site.

10. Use of volunteers

There are about 10 dedicated volunteers who help in the religious events. Their work includes moving chairs, cooking, cleaning, putting up decorations, washing up, throwing waste, and serving food to the guest on large occasions. These volunteers also regularly clear the garden and cut down the branches of overgrown trees. We would like to acknowledge their hard work, dedication, and support to the organisation.

9. New Developments

Buddhist Chaplaincy

Our resident monk Ashin Gawsaka visits Northern General Hospital and Hallamshire hospitals to carry out the duties of a Buddhist Chaplaincy.

Ashin Khemika Linkara

He has arrived at Dhammadhammikarama monastery, Sheffield in May 2022 to take up the duties as a Tier V religious worker. He is highly qualified in Buddhist studies and an experienced meditation instructor. Since his arrival he has been assisting Ashin Gawsaka in all aspects of the religious work at the monastery. He has also started a regular weekly Dhamma talk and meditation session by Zoom.

Levelling of the ground

A patch of ground in the garden of the monastery has been filled and levelled. This will provide a much needed space to conduct gatherings at the monastery.

10. Future direction of the Trust

1. To encourage younger members of the trust to be more involved in the work of the trust. It is envisaged that these young members will become more active and take on more responsibilities.

Currently there are young members from South Yorkshire and beyond who are starting to take on some responsibilities.

2. After the establishment of a monastery in 2016, to conduct smaller religious activities at the monastery.

3. To give support to members of local Buddhist community (particularly to promising youngsters) who are in genuine need for their education/career progression via special awards/grants as well as rewarding them for excellence.

4. To invite famous meditation teachers and Buddhist monks for lectures and guidance.

5. To conduct weekend day courses on Buddhism for young people at the monastery.
