Review of the charity's financial position at the end of the period	Para 1.21	The charity has made a surplus of £10,224, which in part was due to a £4,000 donation from Randlay Roundabouts Pre-School Group which closed down during the year. The surplus is slightly lower than the previous year of £11,729, with parental contributions having decreased. This is a result of fewer unfunded hours having been accessed, possibly due to the cost of living increase.


