TO PROMOTE AND PROTECT THE PHYSICAL AND MENTAL HEALTH OF SUFFERERS AMONGST PEOPLE LIVING IN AFRICA AND UK THROUGH THE PROVISION OF FINANCIAL ASSISTANCE, VACCINE, SUPPORT, ADVOCACY, EDUCATION AND PRACTICAL ADVICE.E. TO RELIEVE POVERTY AMONG REFUGEES, ASYLUM SEEKERS, INTERNALLY DISPLACED PEOPLE (DUE TO CONFLICTS OR DISASTERS) AND THEIR DEPENDANTS IN AFRICA BY PROVIDING GRANTS, ITEMS AND SERVICES SUCH AS ADVOCACY, HEALTH, HOUSING, ADVICE AND EDUCATION;F.
