The Trustees present their annual report, along with financial statements of the charity for the year ended 31 December 2022.

Eastleigh Spiritualist Church was registered as a charity on 26 February 2015, Charity Registration 1160658, and became affiliated to the Spiritualists National Union in December 1999.

The church, by affiliation to the Spiritualist National Union, is governed as laid out in the SNU Rules for Churches prepared in accordance with the provisions of the Memorandum and Articles of Association and Byelaws of the Spiritualist National Union.

Charitable Objectives

The charitable objectives are to advance the religion and the religious philosophy of Spiritualism on the basis on the Seven Principles of the Spiritualist National Union.

Eastleigh spiritualist church provides a comprehensive and wide programme of activities and events to a cross section of the public through Spiritualist teaching of divine services, spiritual awareness meetings, spiritual healing, discussion groups, and workshops.

The church has regard to the Charity Commission guidance on public benefit.

Achievements and Performance

President's Address.

The President, Mike Cook, reported :

The church has mainly run smoothly through 2022 but there are some details that have to be mentioned:-

The church was redecorated over the Christmas and New Year closure. Thanks to everyone who helped put the church back in order.

It was discovered in January that Lynda Green's & Sue Barton's signatures had not been registered at Barclay's Bank as account signatories despite paperwork to that effect had been submitted. LG had been signing church cheques for four years so complaints were raised in the branch and with business bank HQ in Leicester. No satisfactory answer was ever received other than them having lots of cheques to process. LG and SB were finally confirmed as signatories in February.

Between close of service on Sunday 6th February and Open Circle on 7th February someone with a key let themselves in apparently searching for something. On leaving, this visitor ensured the church was locked but left all the lights on and all the heaters on. Enquiries were made at the playschool opposite for CCTV footage but our door isn't within their scope. No present key holder was responsible so suspicion must fall on a past key holder with a copy although no proof has been forthcoming. The lock was replaced.

The Christmas Hamper raffle raised £270 which was donated to the Piam Brown Children's Cancer Ward at Southampton General Hospital.

In April the church insurance was renewed at a cost of £571.06 including an increment of £5.77 to cover the stairlift.

Elaine Bevan, our national warden, made her annual inspection and informed us of a new requirement for a five-year maintenance plan and a responsibility for the committee to ensure funds are available to cover any maintenance required. It is also now a requirement to have the electrics inspected every five years. This was arranged immediately so the next inspection is due in 2027.

It was decided that usage of the stairlift must always be supervised by a committee member and be locked when not in use.

In June it was decided to discontinue Tuesday afternoon healing as we had only four patients in since January. We now offer healing after Sunday service providing we have enough healers in.

Committee meetings were moved to bi-monthly. We have a committee WhatsApp group to deal with minor matters

As a result of the EGM in 2021 when the membership approved a change of name new signs were obtained displaying "EASTLEIGH SPIRITUAL CENTRE" were purchased at a cost £143.36 although fitting was delayed because of Covid and extremely hot weather.

The stairlift broke down on our August Open Day which proved to be the busiest of the year. This was disappointing as it was still in its one year warranty. However the engineer came promptly and repaired it. We now have a five year maintenance contract. Terry Tong resigned as healing group leader allowing Sarah Frith to take up the reins.

Suzie Woodley resigned from Committee in August. Thanks to her and her husband for the new kitchen tap and the tiling in both toilets.

In September the new church signs were fitted. The old ones have been kept in case they are needed again. We remain registered as a church for religious purposes particularly the Sunday divine service but at other times we can be considered a Spiritualist Centre.

Following the passing of HM Queen Elizabeth a condolence book was opened for signatures and was subsequently filed for posterity.

At the Harvest service the collection amounted to £78. I suggest we round this up to £100 and post a cheque to Prostate Cancer UK.

On remembrance Sunday the church president laid a poppy wreath at Eastleigh's War Memorial.

At year end 2022 membership stood at 26 Full, 2 honorary.

Finally, our grateful thank go to Marea Watts, our late treasurer, much loved and sorely missed, who made our church the sole beneficiary in her will. This amounts to £112,048.38. The committee decide to keep this money separate from our normal business accounts and so opened an account with Metro Bank. This money has and will be used for church maintenance and improvements, viz. Stairlift, new front door, etc.

I am always open to criticism providing it is friendly, constructive and non-egotistic

Secretary's Report

There has been little secretarial work required up until the AGM. As always I learn more about how this works and it is a continual learning process

The constant commitment to representing Eastleigh Spiritual Centre remains and I now also run the Facebook page, which has come on in leaps and bounds.

I'd like to thank Mike Cook and the Committee for their invaluable insight and help over the past year.
